

I recommend we clarify two issues regarding the pavement repair on this project by including the following in an addendum:

1. A note regarding thermoplastic striping should be added to Sheet 7 of the plans: "The cost to replace all road markings and striping in overlay areas with thermoplastic shall be incidental to the overlay cost."
2. On the Bid Form, item 17 "Asphalt Road Restoration (1.0" S-III Overlay) should be changed to read "Asphalt Road Restoration (Mill & 1.0" S-III Overlay)".

I apologize for not noticing this in time for you to include this on the last addendum.
