QUESTIONS AND RESPONSES:

Q1. We would like to ask if the construction plans for the SWWRF Equalization System and Cover Addition and Bleach Tank Roof Cover Over can be provided for review?

R1. As stated in the solicitation- Article A.02 of Scope, the SWWRF projects have not yet advertised- and the plans for those projects will be shared with the top ranked Consultant during negotiations.

Q2. Would Kimley Horn be precluded from submitting on the RFQ since they are the EOR?

R2. No.

Q3. – In the scope of services, it is mentioned that potential consultant will perform Engineering services as well. We would like to know what type of engineering services is Manatee county referring to?

R3. Geotechnical engineering services for construction phase of the identified projects.

Q4. Does Manatee County have an estimate of how much volume of work for Material to be tested?

R4. No, the Proposer should be familiar with Manatee County standards and estimate the level of effort required to complete the geotechnical construction phase services for the identified projects.

Q5. What are the previous contract holders for these 2 project sites?

R5. The County has not previously awarded contracts for construction phase geotechnical engineering services for these two projects.

Q6. Has Manatee County expressed any dissatisfaction with the previous consultant?

Q7. Who are the incumbents of this project?

Q8. Does Manatee county allow joint venture with small firms?
