Questions and Answers:

1) There are some questions pertaining to Bid Item 2.35 Shredded Hardwood Mulch. Question and Answer # 26 and the revised Measurement & Payment Section only llst a generic "Hardwood Mulch". Is there a specific mulch that the Architect is requesting? Pine bark is typically used for "Hardwood Mulch" but it is not shredded. Shredded mulch is soft and not a hardwood. The Landscapers have also used Melaleuca Mulch as well. Please advise.

Response: Our intention is that no bark be used for the mulch. Bark tends to float and run off. Shredded wood mulch, i.e. melaleuca, eucalyptus, etc would be acceptable.
