ADDENDUM #2

Bidders are hereby notified that this Addendum shall be acknowledged on page 20 of the Bid Form and made a part of the above named bidding and contract documents. Bids submitted without acknowledgment of the Addendum will be considered incomplete.

The following items are issued to add to, modify, and clarify the bid and contract documents. These items shall have the same force and effect as the original bidding and contract documents, and cost involved shall be included in the bid prices. Bids to be submitted on the specified bid date, shall conform to the additions and revisions listed herein.

1. **CLARIFICATION** of Bid Article D.01.C, Remote Monitoring and Control, on page 14 of the bid documents:

For the Braden River and Lakewood Ranch locations, the systems shall have a remote exterior switch pad separate from the contactor cabinets, that will be installed by others on the outside of the electrical rooms for control of the lighting systems.

2. **ADD** the following to Bid Article D.01.D, Lighting System Construction, on page 16 of the bid documents:

The poles for the **Buffalo Creek Park** location shall have a hand hole, facing away from the field approximately twenty five (25) to thirty (30) feet above grade, for wiring access to install a security lamp that will be wired on a separate circuit from the Sports Lighting. The security lamp will be provided by Manatee County to be installed by others and shall be a Lithonia Model # TFL 400M RA2 TB LP1 (or equal).

3. **CLARIFICATION** of paragraph seven of Bid Article D.01.D, Lighting System Construction, on page 16 of the bid documents:

Due to geotechnical concerns at the Braden River location, a Geotechnical Soil report will be provided by Manatee County in a future addendum prior to the bid opening.


