BACKGROUND/DISCUSSION

Manatee County Parks and Natural Resources Department has an ongoing need for landscape maintenance services. Landscape maintenance services are needed for the following Manatee County's Preserves: Robinson Preserve, Emerson Point Preserve, and Jiggs Landing. Landscape maintenance service includes but is not limited to mowing and string trimming of all turf areas, edging along all concrete asphalt and paver edges where turf meets an impervious surface. Blowing off all grass, debris or dirt which has been casted on these surfaces.

The solicitation was advertised on November 17, 2020, on the Manatee County website. It was also provided to the Manatee County Chamber of Commerce, the Manasota Black Chamber of Commerce, Gulf Coast Builders Exchange and Gulf Coast Latin Chamber of Commerce for release to its members.
