NOTICE OF INTENT TO NEGOTIATE FOR AWARD

The Manatee County Procurement Division provides notice of its intent to award a single source contract with a value of \$290,616.00 with Data Flow Systems, Inc. for the provision of design and construction services of the North County Central SCADA Radio System Relocation.

BACKGROUND/DISCUSSION

Manatee County Procurement Division has completed a due diligence review and intends to procure design and construction services of the North County Central SCADA Radio System Relocation from Data Flow Systems, Inc. without conducting a competitive solicitation process for the following reason(s):

This Agreement provides for the design, permitting, and construction of a new 150-foot self-supporting Lattice Tower and small block building in order to relocate the existing Data Flow Systems (DFS) North County Central SCADA Radio system approximately 520 feet from its current location due to the new tower being a larger, more robust Lattice Tower and to avoid any buried infrastructure within the wastewater plant site. Additionally, the existing North County Water Reclamation Facility's local area DFS SCADA system antenna and associated equipment will be relocated to the new installation.

Since 1986, Manatee County Utilities has specified that only Data Flow Systems, Inc. units be used for lift station telemetry in order to maintain a single source of responsibility and to ensure compatibility of the lift station radio telemetry system hardware and software. Currently all 700 of the lift stations maintained by the Manatee County Utilities Department are equipped with the Data Flow Systems, Inc. telemetry system.

The Utilities Department is requesting a non-competitive procurement for the relocation of the North County Central SCADA Radio System In order to maintain a single source of responsibility since Data Flow Systems, Inc. is the manufacturer and sole provider of the equipment to be relocated.
