BACKGROUND/DISCUSSION

- This annual contract, with four (4) consecutive one-year automatic renewal periods provides for the collection/removal of scrap materials such as: pipe-cast iron, ductile iron, galvanized steel, street signs, fencing, aluminum, copper, brass, etc... from various County Locations. The collection includes the proper handling, consolidation, storage, transportation, and disposal activities involved with the removal of said materials. This is a revenue generated Contract.
- Formal competitive sealed bid procedures were followed resulting in a total of two (2) bidders submitting a sealed bid for consideration.

- The apparent high bidder, Transcor Recycling LLC, Tampa, FL was deemed non-responsive as Transcor Recycling did not meet the Qualification requirements of the Invitation for Bid, Article B.04, Qualifications which required the bidder to be registered under the laws of the State of Florida for the Collection and Removal of Scrap Metal for a period of at least three (3) consecutive years. The Florida Department of State Division of Corporations shows the effective date of Transcor Recycling, LLC as December 12, 2012 giving Transcor Recycling LLC, only one (1) year of being actively registered.
- On December 20, 2013, a memorandum from Public Works was received recommending award to Trademark Metals Recycling LLC, the responsive, responsible bidder.
