## EXHIBIT 2, PROPOSAL RESPONSE, TAB 8, ITEM 12

Delete Item 12 in its entirety, from Tab 8 of Exhibit 2, Proposal Response.

12. Provide details of Proposer's capacity to bond the project. Include a letter of intent from Proposer's bonding company which confirms Proposer's bonding capacity.

## **QUESTIONS AND RESPONSES:**

- Q1. In the instructions for what to include in Tab 8 Organizational Structure and Capacity, Item 12. (On page 57) In Manatee County RFQ No. 24-TA005049 Professional Design Services Desoto Bridge Watermain Replacement Project N. 6116570, the RFQ states: "12. Provide details of Proposer's capacity to bond the project. Include a letter of intent form Proposer's bonding company which confirms Proposer's bonding capacity." This requirement does not seem correct for a design services RFQ. This requirement would be applicable to a construction RFQ, not a design services RFQ such as this. Can the County please confirm that a response to this item is not required?
- R1. Bonding is not required for this project. Item 12 has been removed per this Addendum 1. Addendum No. 1 RFQ No. 24-TA005049JH

- Q2. In the instructions for what to include in Tab7 Approach, Item 3. (On page 55) In Manatee County RFQ No. 24-TA005049 Professional Design Services Desoto Bridge Watermain Replacement Project N. 6116570, the RFQ states: "3. Details of implementation plan and schedule. Provide an implementation schedule for each component of services (e.g., design, demolition, construction). NOTE: Proposer must commit to a timetable of no more than 365 calendar days for substantial completion of the project." Considering that this is a Design Services RFQ, can the County please clarify and confirm that it means that design will be done in 365 days?
- R2. Design to be completed in 365 days.
- Q3. Can the County please confirm that we are allowed to use an 11" x 17" page for the implementation plan and schedule requested in Tab 7 Approach, Item 3, so that we have sufficient room to clearly show our schedule information?
- R3. 11"x17" is acceptable.
- Q4. Can the County please confirm that we are allowed to use an 11" x 17" page for the organizational diagram requested in Tab 8 Organizational Structure and Capacity, Item 4, so that we have sufficient room to clearly present our organizational diagram/organizational chart information?
- R4. 11"x17" is acceptable.
