Request for Proposals (RFP) No. 24-R084063BB is amended as set forth herein. Responses to questions posed by prospective proposers are provided below. This Addendum is hereby incorporated in and made a part of RFP No. 24-R084063BB.

The deadline to submit all inquiries concerning interpretation, clarification or additional information pertaining to the RFP was March 17, 2024.

QUESTIONS AND RESPONSES:

- Q1. Are all scrubbers and carbon filters supplied by chemical supplier now, or are some permanent? Which units are supplied as part of bid (60 units shown in diagrams)?
- R1. Yes, all scrubbers and carbon filters are supplied by the chemical vender, units are sized per the H2S loadings and wet well size.
- Q2. Will the city consider separate treatment for one leg to demonstrate alternative chemistry?
- R2. No, the County will not use any alternative chemicals for any demonstrations.
- Q3. Pollution insurance is listed as a requirement. Would Manatee be amenable to removing this requirement for magnesium hydroxide since it is a non-hazardous product?
- R3. Requested modifications to the Insurance Requirements will be discussed with the successful proposer.
- Q4. Do you anticipate adding any additional feed sites in the duration of the product? The way the bid is currently written (requesting a price per gallon), does not allow for factoring in costs associated with bringing on a new site.

- R4. There is always a possibility that additional feed sites may be added throughout the course of the contract. That said, there is also the potential for feed sites to be removed as we continuously monitor performance and adjust treatment strategies as the system dynamics change.
- Q5. If you do anticipate bringing on new locations, would it be possible to include a separate line item for the cost for providing and installing new equipment per site?
- R5. No. The County has never had a separate line item for costs associated with new equipment, these costs have always been included in the price per gallon costs.
- Q6. Please confirm what personnel resumes we are required to submit (roles/title). We will include direct sales representatives, account managers and field service personnel related to managing this contract, but please confirm if you need any additional resumes from corporate such as customer service or logistics.
- R6. Proposer's proposal shall include resumes of any personnel that will be directly involved with providing the services under the resulting agreement.
