BACKGROUND/DISCUSSION

Manatee County is responsible for providing emergency shelter during declared disasters such as hurricanes. The Public Safety Department requested a solicitation to rent/retain a 1250 KW portable diesel generator for the 2025 and 2026 hurricane seasons for the special needs shelter located at Nolan Middle School. A Generator is to be delivered on an as-needed basis for emergency use during the hurricane seasons.

The solicitation was advertised on March 5, 2025 on the Manatee County website and DemandStar. It was also provided to the Manatee County Chamber of Commerce, the Manasota Black Chamber of Commerce, Gulf Coast Builders Exchange and Gulf Coast Latin Chamber of Commerce for release to its members. Responses were received from the following firms:
