The Request for Proposal (RFP) was broadcast via DemandStar to one hundred thirty (130) possible firms who generate and mail various bills and notices; thirty (30) firms downloaded the RFP and twenty four (24) firms' submitted proposals.
- In an effort to inform local Manatee firms the RFP was advertized locally in the Bradenton Herald, posted on the County's website and provided to the Manatee County Chamber of Commerce. However, no Manatee County firms responded to the RFP.

#### Mr. Hunzeker,

We are communicating the recommended selection of SouthWest Direct, Inc., Ft. Myers, FL for process electronic customer account data provided by the County via automated, electronic transmission and furnishing forms and envelopes for printing, inserting and mailing of utility customer bills, notices, inserts, etc. and furnishing required reports and statistics to the Utilities Department. Estimated cost for this work: \$645,000 per year (a term of three years with a two year option is being considered).

In an effort to inform local Manatee firms the RFP was advertized locally in the Bradenton Herald, posted on the County's website and provided to the Manatee County Chamber of Commerce. However, no Manatee County firms responded to the RFP.

Staff will proceed with the posting of the selection and beginning negotiations upon your confirmation.
