Due Diligence Review

- Due diligence review: Bids are evaluated to determine whether each Bidder is responsive and responsible.
 - To be responsive, a Bidder shall submit a Bid which conforms in all material respects to the requirements set forth in the IFBC. A Bid that confirms to the requirements of this solicitation, to include all documentation, is submitted in the format outlined in this Solicitation, is of timely submission, and has the appropriate signatures as required on each document.
 - A responsible bidder, the bidder shall have the capability in all respects to perform fully the bid requirements, and the tenacity, perseverance, experience, integrity, reliability, capacity, facilities, equipment, and credit which will assure good faith performance.
 - Bids that are deemed non-responsive and/or non-responsible will not be considered.



Minimum Qualifications

- Bidder must be registered with the State of Florida. Division of Corporations to do business in Florida.
- Bidder, or its representative(s), has made an inspection of the construction site for work specified in this IFBC on or after the date of advertisement of this IFBC and prior to the Due Date and Time.
- Bidder, or Bidder's representative(s) has attended one of the two Mandatory Information Conferences as outlined in the IFBC Document and Addendum 2.
- In accordance with the IFBC, Section A, sub-section A.36; Bidder's subcontracting any portion of the work shall include a list of subcontractors along with their bid.
- A Local Agency Program Agreement with the Florida Department of Transportation requires contractors to be prequalified with the Florida Department of Transportation in order to bid for the performance of this construction contract. Prequalification is defined by Florida Law (Chapter 337.14 F.S.) and Rules of the State of Florida, Department of Transportation, (Chapter 14-22, F.A.C.).



Minimum Qualifications (Continued)

- Bidder or Bidder's subcontractor has provided sidewalk, lighting, or underground utilities (water or sewer) work for at least three (3) projects since July 1, 2018. Project clients must be agreeable to responding to an inquiry by the County.
- Bidder is not on the Florida Suspended, Debarred, Convicted Vendor, Excluded Parties or Scrutinized list of Prohibited Companies lists.
- If you are filing as a joint venture, provide the companies approved filling with the DBPR.
- Must have no reported conflicts of interest in relation to this IFBC.



Prequalification

- FDOT requires contractors to be prequalified with FDOT in order to bid for the performance of this construction contract. Prequalification is defined by Florida Law (Chapter 337.14.F.S. and Rules of the State of Florida, Department of Transportation (Chapter 14-22, F.A.C.)
- Bidder or Bidder's subcontractor combined:

 - Electrical Work (8)
 - Flexible Paving (10)

Background

- Florida Department of Transportation (FDOT) and Manatee County are working together to complete a sidewalk and lighting safety project in this corridor. The existing utilities may be impacted when their safety improvements are installed, and the existing utilities will require protection or relocation.
- The existing Asbestos Cement (AC) water main is old and brittle concrete that is prone to cracking when installing the new lighting spread footings and sidewalk. The pipe will need protection and designed so the County can still maintain their water infrastructure. New sidewalk grades will require adjustment of existing valve boxes and covers as well.
- FDOT safety improvements to be installed are new concrete sidewalk, light pole fixtures and new mast-arms with traffic signalization.



Scope of Work

- FDOT centric work includes, but not limited to, installation of 4" and 6" thick sidewalk, curb and gutter installation, install 22 pedestal light poles and install 6 steel mast arm & traffic signalization on east and west sides of US-41 in Bradenton, FL.
- Manatee County centric work includes, but not limited to, installation of 12" steel split casing on 6" DIA, 8" DIA, and 10" DIA pipe, installation of 10" DIP watermain and valve adjustments on the east and west sides of US-41 in Bradenton, FL.
- Restoration Activities include asphalt and concrete driveway repair, sodding, sidewalk repair, guardrail replacement, and general landscaping.



Estimated Project Completion

• Expected completion is 540 days from Notice to Proceed.



Trade Secrets

- Bidders must identify any trade secret being claimed in accordance with Florida Statute 812 and the instructions in the IFBC.
- Designation of the entire Bid as 'Trade Secret', 'Proprietary' or 'Confidential' is not permitted and may result in a determination that the Bid is non-responsive and therefore will not be evaluated or considered.



Insurance Requirements

Coverage limits of not less than:

- Automobile: \$2m / combined single limit; or \$1m Bodily Injury and \$1m prop damage; \$10k No fault; \$500k non-owned and \$10k medical payments.
- General Liability: \$2m /single limit per occurrence; \$4m aggregate; \$2m products; \$1m personal / advertising injury; \$100k fire damage; \$10k medical expense and \$1m third party property.
- Employer's Liability: \$100k each accident; \$500k disease each employee; \$500k disease policy limit and Workers Compensation Insurance.
- Bid Bond in the amount of 5% of the total offer. Bond shall accompany the bid documents.
- Payment and Performance (Construction) Bond shall be submitted by Successful Bidder for 100% of the award amount



Mistakes That Could Cost You!

- Delivering the response after the deadline.
- Failing to provide the information requested for the "Minimum Qualifications".
- Not presenting questions regarding minimum requirements, scope/specifications, terms and conditions, or other provisions prior to the deadline for delivery of questions, which include questions about the insurance coverages and the sample agreement attached to the IFBC.
- Providing information that is not legible, too **small** or blurry.
- Failing to acknowledge addenda.
- Failing to sign the response.
- Failing to have insurance coverages at expected limits.
