The following items are issued to add to, modify, and clarify the bid and contract documents. These items shall have the same force and effect as the original bidding document, and cost involved shall be included in the bid prices. Bids to be submitted on the specified bid date, shall conform to the additions and revisions listed herein.

The deadline of May 30, 2014 to submit all inquiries concerning interpretation, clarification or additional information for this bid has lapsed. This deadline has been established to maintain fair treatment for all potential bidders, while maintaining the expedited nature of the Economic Stimulus that the contracting of this work may achieve.

Bidders Note: Engineer's clarification regarding Bid Item No. 24.0, Sludge Holding Tank Sludge Removal:

Revised Bid forms (Bid "A" and Bid "B") are made a part of this Addendum No. 3. The quantity has been revised: **WAS: 705 / NOW: 250.** (8 total Bid Form pages attached)

The Technical Specification Section 01150, Measurement and Payment under Bid Item No. 24.0 is revised and shall read as follows:

"Payment for removal and disposal of sludge holding tanks shall be included in this Bid Item as a unit price. The unit price shall include all necessary tools, labor, equipment and materials for removal and disposal off-site of accumulated sludge and / or residual material consisting of grit, sand, rags and any other debris. The volume of sludge will be determined by measuring the average depth of the material remaining, whether in liquid, semi-solid or solid form after the County staff has drained the tanks to the degree indicated in the Contract Documents and before any cleaning or removal is started by the Contractor."
