NOTICE OF INTENT TO AWARD

The Manatee County Procurement Division provides notice of its intent to award a contract to Forsberg Construction, Inc. for the provision of Palmetto Point Water Main Replacement.

BACKGROUND/EVALUATION

The Manatee County Procurement Division solicited IFBC No. 20-TA003307BB for the provision of Palmetto Point Water Main Replacement. The Scope of Work includes, but is not limited to, the following: plugging and placing utility pipe and appurtenances; furnishing and installing water main and appurtenances; seeding and sodding; pavement repair; maintenance of traffic; road, sidewalk, and driveway restoration; and miscellaneous as-needed concrete.
