Bidders are hereby notified that this Addendum shall be acknowledged on page 36- Revised Addendum #1 of the Bid Form and made a part of the above named bidding and contract documents. Bids submitted without acknowledgment of the Addendum will be considered incomplete.

The following items are issued to add to, modify, and clarify the quote and contract documents. These items shall have the same force and effect as the original quoting and contract documents, and cost involved shall be included in the quote prices. Quotes to be submitted on the specified quote date, shall conform to the additions and revisions listed herein.

- 1. CHANGE** the description for location Z1-20 in Zone #1, Work Area Locations and Descriptions on page 24 of the bid documents, to read as follows:
63rd Ave E from US 41 to 15th St E; Bradenton, FL (All Medians, North ROW at from 5th St W going east for 300 ft, and South ROW 300 ft south of 9th Street E., **and four retention ponds**)
- 2. CHANGE** the estimated mowing acres for location Z2-26 in Zone #2, Work Area Locations and Descriptions on page 27 of the bid documents, to read: **5.82 acres.**
- 3. CHANGE** the Due Date and Time to **Monday, November 21, 2011 at 3:00 PM.**

The following question was asked after the issuance of Addendum #1:

QUESTION #1: Is the acreage in the schedule of tasks included with the corrections in addendum #1? If not can you provide the added acreage for Z1-20, Z2-2, Z2-26, Z3-5, Z4-2, and Z4-3?

RESPONSE #1: For locations Z1-20, Z2-2, Z3-5, the estimated mowing acreage was not affected by the corrections; for Z2-26, see item #2 above. Location Z4-2 has an estimated mowing acreage of 35.00 acres, and location Z4-3 (the ten ponds) has an estimated mowing acreage of 21.17 acres.
