MANATEE COUNTY ADMINISTRATION BUILDING FUEL TANK REPLACEMENT

ADDENDUM NO. 1

The following are clarification and additions to the construction documents to be included with bid:

- Item No. 1.1 The County has a back-up generator manual transfer switch with remote generator set termination points existing in the generator room. The bidder shall be required to provide a 1000 kW portable generator terminated and at the ready for use for all down time where the existing emergency generator is off-line due to the construction included in the bid documents. The County will be responsible for the emergency transfer to the stand-by generator; therefore contractor shall alert the County at least seven days in advance that a portable generator will be available. Bidder shall provide a minimum 1000 gallons of fuel for use in the portable generator, and operation and testing of the new tank, etc.
- Item No. 1.2 The warranty required shall be (3) years for labor and workmanship, and (1) year for equipment.
- Item No. 1.3 All permitting, equipment, materials, and work shall be included in the deadline completion indicated on the construction documents.
- Item No. 1.4 All steel not indicated to be painted shall have galvanized finish.
- Item No. 1.5 Contractor staging area shall be contained to the South portion of the parking breezeway at the site. The breezeway parking on the North side of the breezeway shall remain to the public, and kept safe for travel.
- Item No. 1.6 The inclined floor above tank is indicated to be 9" total width, post tensioned slab.

 Contractor shall locate tensioning cable and slab reinforcement prior to core. Final tank location shall be adjusted to avoid any obstructions.
