### **QUESTIONS AND RESPONSES:**

**Q1. In Tab 7, questions 4/5 and 11 are identical, apart from part d. in question 11. Should we respond to this twice, or will it be revised?**

**R1. Lines 4 and 5 are deleted. See DELETE section in this Addendum No. 2.**

- Q2. Would it be possible to move the 2<sup>nd</sup> Mandatory Site visit to Friday the 5<sup>th</sup>? The annual Florida Water Resources Conference (FWRC) is Scheduled from April 2<sup>nd</sup> to April 4<sup>th</sup> and many people in the industry will be at the conference and unable to attend the site visit. I understand that if we attended the previous site visit we do not need to attend the second, however, since this second visit is a bit irregular we would like to be in attendance and hear any information that is shared with others. No other changes to dates and delivery times is requested...only moving the site visit from Thursday to Friday to allow maximum participation.**
- R2. The 2<sup>nd</sup> mandatory site visit date and time shall remain firm. If Proposer attended the March 25, 2024 site visit, it is not mandatory for Proposer to attend the 2<sup>nd</sup> mandatory site visit scheduled for April 4, 2024, at 9:00 AM ET. No new information will be provided.
- Q3. Page 33 of the RFQ requires a Bid Bond with our response.**
- **Please provide a copy of the bid bond form that should be included in our response.**
  - **Please advise the duration the Bid Bond should be valid.**
  - **Please confirm the Bid Bond is for the County's advertised budget of \$154M.**
- R3. On page 33, Bond Requirements, Bid Bond and Payment and Performance Bond was inadvertently selected. There are no Bond Requirements for RFQ 24-TA005215ED.
