## **QUESTIONS AND RESPONSES:**

- Q1. On page 1 of Exhibit 1 - Scope of Services, Section 1.01, the end of the first sentence reads, "... to assist in the development of two (2) Neighborhood Action Plans (NAP) for the identified target areas (Target Areas)." What are the names of the "identified target areas" referenced in this sentence?
- R1. The target areas will be provided after award to the successful Proposer. Proposers should respond based on how the work will be performed, regardless of the location(s).
- Q2. On page 1 of Exhibit 1 - Scope of Services, Section 1.01, the end of the first sentence reads, "... to assist in the development of two (2) Neighborhood Action Plans (NAP) for the identified target areas (Target Areas)." What are the general boundaries of the "identified target areas" referenced in this sentence?
- R2. The target area boundaries will be provided after award to the successful Proposer. Proposers should respond based on how the work will be performed regardless of the target area boundaries.

- Q3. On page 2 of Exhibit 1 Scope of Services, Section 1.04, under subparagraph A. Existing Conditions Analysis, the first sentence reads, "The Environmental Assessment addresses the need for a proposed project, alternatives to the project and the environmental impacts of both the proposed and alternative projects. Is a separate Environmental Assessment report expected beyond the balance of the Existing Conditions Analysis described under Exhibit 1 Section 1.04-A.?
- R3. No, a separate Environmental Assessment is not required.
- Q4. On page 2 of Exhibit 1 Scope of Services, Section 1.04, under subparagraph A. Existing Conditions Analysis, the first sentence reads, "The Environmental Assessment addresses the need for a proposed project, alternatives to the project and the environmental impacts of both the proposed and alternative projects. If the County requires a separate Environmental Assessment, has the County already selected the projects referenced in the first sentence under Exhibit 1 Section 1.04-A. regarding Environmental Assessment, or should those projects be identified through the requested Consultant services?
- R4. See response to Question 3. The County does not have selected projects already identified.
