NOTICE OF INTENT TO AWARD

The Manatee County Procurement Division provides notice of its intent to award a contract to Paramount Power, Inc. for the provision of portable diesel generators.

ENABLING/REGULATING AUTHORITY

Manatee County Procurement Ordinance, Sec 2-26.

BACKGROUND/DISCUSSION

The Manatee County Utilities Department is responsible for ensuring that sewage system lift stations are operating optimally in all conditions. Portable diesel generators are essential for providing electricity for the lift stations in cases of power outages. For that reason, a solicitation was advertised to select a supplier for the purchase of portable diesel generators.

The solicitation was advertised on June 30, 2020 on the Manatee County website. It was also provided to the Manatee County Chamber of Commerce and the Manasota Black Chamber of Commerce for release to their members. Responses were received from the following firms:

2. CDPW, Inc. / Edgewater, FL
3. Paramount Power, Inc. / Largo, FL
4. Technology International, Inc. / Lake Mary, FL
5. United Rentals (North America), Inc. / Tampa, FL

EVALUATION RESULTS SUMMARY:

Paramount Power, Inc. has been determined to be the responsive and responsible bidder with the lowest total bid. A bid tabulation of the results is attached to this Notice of Intent to Award.

CDPW, Inc. has been deemed non-responsive for the following reason: Bid provides goods from Atlas Copco, a manufacturer that is not approved in the IFB, Exhibit 1, Scope of Work/Specifications, Section 1.01.

United Rentals (North America), Inc. has been deemed non-responsive for the following reason: Bid includes exceptions that are not accepted by the County.

The Procurement Division and the Utilities Department recommend to award Paramount Power, Inc.
