The work will consist of Stormwater discharge maintenance including dredging sediment from six (6) stormwater outfall locations just west of 75th St. NW and between 72nd St. NW and 79th St. NW in Shaws Aztec Cove, Bradenton, Florida.

The solicitation was advertised on October 30, 2020 on the Manatee County website and Bid Sync.
