The following request for additional information has been received from bidders for the above referenced project.

Question #1: Will the county entertain the request to modify the permits for the project? If yes, a further request would be that the low bidder be allotted a 30 day period to meet and discuss with regulatory permitting agencies in the presence of County personnel to confirm dewatering methodology changes would be acceptable and permissible. If modifications were considered acceptable, the Contractor would modify said permits at his expense after bid award. Additionally if permit modifications are unable to be obtained that the county would allow for the contractor to withdraw his bid at no penalty to the contractor.

Answer: See Addendum No.1. No. Manatee County will not entertain modifications to the existing FDEP permit.

Question #2: Section B.03 QUALIFICATIONS OF BIDDERS Can the experience requirement be met using the experience if the contractor's team or must it be specific to the Prime Contractor. For instance, can the experience of a key employee who gained the experience with a past employer be used? Can the resume of a partnering company be used without forming a formal joint venture company?

Answer: The experience is explicit to prime contractor and not his employees or his subs.

Question #3: Section 4.2.1, 4.11.3 of the GENERAL CONDITIONS and Section 01700, Paragraph 1.03E Please provide a fee schedule for engineering charges per these sections.

Answer:

(A). Article 4.2.1 (Page 00700-7) - Contractors shall bid the project based on regular working hours; no performance of work on Saturday, Sunday, or legal holidays. Any request by the contractor to perform work on Saturday, Sunday, or legal holiday shall be determined on a case by case basis, and at the sole discretion of the County.

(B). Article 4.11.3 (Page 00700-9) – **DELETE** for this Project, Section 00700, General Conditions for the Invitation for Bid, Article 4.11.3, "Contractor shall reimburse County for the charges of Engineer and Engineer's Consultants for evaluating each proposed substitute submitted after the effective date of the Agreement and all costs resulting from any delays in the work while the substitute was undergoing review."

(C). Section 01700, Paragraph 1.03E – **DELETE** for this Project, Division 1, General Requirements, Section 01700, Contract Closeout; Article 1.03 Final Inspection, Paragraph (E), "For each additional inspection beyond a total of three (3) inspections for substantial and final completion due to the incompleteness of the work, the Contractor shall reimburse the Owner for the Engineer's fee." (Page 41).

Question #4: Section 4.12 of the GENERAL CONDITIONS Will an electronic file with the base line as shown on the plans be available to the Contractor's surveyor?

Answer: Yes. The Engineer of Record will supply CAD files containing the design data, including the base line to the successful bidder.

Please note, in accordance with Part 1.04, Section 01050 of General Requirements, all surveys provided by the contractor (pre-dredge survey, as-built surveys) shall be signed and sealed by a Florida registered professional surveyor and mapper.

Question #5: Section 01720, Paragraphs 1.01 & 1.02 Is a field office required for this project? If so has the County designated the site for the field office?

Answer: No field office is required for this project.

Question #6: DEP PERMIT Are all DEP Submittals included in the bid documents? If not, are these submittal available to us?

Answer: Bid documents include design plans and FDEP permits related to the design plans. There were several submittals to FDEP during the permitting of this project. Those submittals are not relevant to the current status of this project.

Question #7: Are there any tipping fees for deposit of sediments at the Manatee County landfill?

Answer: *The County Board of Commissioners, in their meeting of April 27, 2010, waived all tipping fees for this project.*

Bidders Note:

1. Attached "Exhibit" shows the limits/configuration of the Staging and Loading/Off-Loading area.
2. Contractor will be required to obtain a "Special Event Application", using the "Temporary Use Permit" section, through the City of Bradenton Beach for the proposed Staging and Loading/Off-Loading area. Fee for this application is estimated at \$100. County will assist the contractor in obtaining permits through the City of Bradenton Beach. Other permits such as FDOT haul permit may also be required for this project. Contractor shall be responsible for payment of all fees, taxes, assessments, bonds, etc. for obtaining these permits. Costs for fees, taxes, assessments, bonds, etc. shall be incorporated into the Bid, under Item: Mobilization.
