- Q2. *If the CMAR Proposer/Prime Contractor is FDOT pre-qualified, but not necessarily in all work classes identified in the request for qualifications, and does not intend to self-perform the work classes of (10) Flexible Paving, (16) Intelligent Transportation Systems and (39) Traffic Signals, do they need to identify subcontractors meeting the qualifications in these work classes as a part of the solicitation response or will these work classes just need to be met after final selection during the preparation of the GMP?***
- R2. Yes, the subcontractors meeting this minimum qualification need to be identified in the proposal response.
