## BACKGROUND/EVALUATION

The County requested proposals from qualified firms to provide Professional Engineering Services and other professional services for the Upper Manatee River Road Gates Creek and Mill Creek Bridge Replacement project. The project is in Manatee County, Florida on Upper Manatee River Road south and east of the Fort Hammer Bridge over the Manatee River. Both bridges have been rehabilitated in the past and require replacement. It has been determined that the bridges will accommodate future four-lane widening to meet future roadway requirements.

The solicitation was advertised on the Manatee County website and DemandStar. It was also provided to the Manatee County Chamber of Commerce and the Manasota Black Chamber of Commerce for release to its members. Responses were received from the following firms:
