This deadline had been established to maintain fair treatment of all potential bidders, while maintaining the expedited nature of the Economic Stimulus that the contracting of this work may achieve. Questions received after this date and time shall not be considered.

If you have submitted a bid prior to receiving this addendum, you may request <u>in writing</u> that your original, sealed bid be returned to your firm. All sealed bids received will be opened on the date stated.

Question # 1: Addendum 4 indicates that the county will provide trucking from an off-site vendor for hauling the material. Will this cover the trucking for the excavation of the suitable and the unsuitable material? If so, will the contractor be responsible for any further scope once the material has reached its destination as it specifically relates to items numbers D.1.8.2 and D.1.9.1.1 of the Bid Form?

Response #1: The off-site vendor will be responsible for hauling the suitable material only from the Staging/Temporary Stockpile Area to the offsite destination. The successful contractor will not be responsible for further scope of the suitable material once it has reached its destination.

The successful contractor will be responsible for the trucking and proper offsite disposal of unsuitable material as described in the Disposal of Unsuitable Materials section of Item D.1.8.1.
