The Manatee County Procurement Division provides notice of its intent to award a contract with Manhattan Construction Company for the provision of Bradenton Area Convention Center Expansion.

BACKGROUND/EVALUATION

Project consists of, but not limited to, the following: A 30,000 sq. ft. (approximately) mutli-purpose room will be added to the northeast side of the Convention Center (includes a 900-seat ballroom), expand lobby/pre-function area, air-conditioned corridor connecting full-service hotel to convention center, renovation of existing parking lot to include a landscape plan and interior/exterior improvement to existing convention center.

It was also provided to the Manatee County Chamber of Commerce, the Manasota Black Chamber of Commerce, Gulf Coast Builders Exchange, and Gulf Coast Latin Chamber of Commerce for release to its members and advertised in the Bradenton Herald and Tempo News newspapers.
