In discussion with Shea Shoun, P.E. in Jim Stockwell, P.E.'s absence and confirmed by Chris Mowbray, P.E., The following text answers questions received regarding this project and provides clarifications and revisions to this contract as follows:

Questions from Charlie Keister of DR Swanson Company October 8, 2014

1. Question: Can the lift station feeding the existing force main be shut down, and if so, for how long?

Answer: No, the contractor should be prepared to use a pump truck while performing the work.

2. Question: What is the maximum flow rate in the existing force main?

Answer: 275 GPM at 25 TDH.

3. Question: Can the Maritime Museum property, the lawn area just outside the ROW and adjacent parking lot entrance, be used for the directional drill machine working area? This would eliminate excessive damages to the existing landscaping.

Answer: This is private property. The contractor would have to negotiate the use of the property with the property owner.

4. Question: Can a portion of the Maritime Museum rear parking lot area be used for temporary storage of equipment and materials?

Answer: This is private property. The contractor would have to negotiate the use of the property with the property owner.
