This letter is to provide responses to comments submitted by bidders and for your use in preparing Addendum #2.

Comment 1: I know this question has already been asked about the Prime Contractor having a GC License; however we construct bridges for FDOT and other local municipalities and only carry a building license. We are an FDOT certified contractor in bridge and roadway work and would like the opportunity to bid this project for you. Is this something that you can look into having changed? I think you will also get a larger response.

Response 1: As stated in the Bid Documents and Addendum 1, contractors submitting a bid for this project shall have a General Contractor license.

Comment 2: We are requesting that the requirement of a General Contractors license be removed as there is not a building over 4 stories involved. We are a road/bridge and utility contractor and have all the necessary qualifications to construct this project, but we do not have this license.

Response 2: As stated in the Bid Documents and Addendum 1, contractors submitting a bid for this project shall have a General Contractor license.

Comment 3: I am in receipt of Addendum 1, and am still unclear of why there is a requirement for a General Contractor's license. Who is requiring this license and why? Is this coming from the EOR?
