CHANGE TO: SECTION A, ARTICLE A.01, BID DUE DATE

The Due Date and Time for submission of Bids in response to this Invitation for Bid Construction (IFBC) **is August 3, 2022 at 3:00 PM ET.** Bids must be delivered to the following location: Manatee County Administration Building, 1112 Manatee Avenue West, Suite 803, Bradenton, FL 34205 and time stamped by a Procurement representative prior to the Due Date and Time.

Effective Monday (August 1, 2022), all visitors coming into the Administration Building will need to check in with 311 staff on the first floor by the main entrance to obtain a visitors' badge to access all floors. Badges will be signed out and provided by 311 staff members. Visitors will be instructed to turn the badge in to the employee they are visiting or the receptionist on the various floors.

Bids received after the Due Date and Time will not be considered. <u>It will be the sole</u> <u>responsibility of the Bidder to deliver its Bid to the Manatee County Procurement</u> <u>Division for receipt on or before the Due Date and Time</u>. If a Bid is sent by U.S. Mail, courier or other delivery services, the Bidder will be responsible for its timely delivery to the Procurement Division. Bids delayed in delivery will not be considered, will not be opened at the public opening, and arrangements will be made for their return at the Bidder's request and expense.
