#### **BACKGROUND/EVALUATION**

The County requested proposals from qualified firms for the provision of Construction Management at Risk (CMAR) Services for the Manatee County Lincoln Park Pool project to include pre-construction, bidding, and construction phase services. During the pre-construction and design phase, the CMAR will provide preliminary site investigations, quality assurance and constructability reviews of the design, code compliance reviews, cost estimating to keep project in budget, value engineering recommendations, and the development of a guaranteed maximum price (GMP). The construction phase services for the project would begin upon acceptance of the GMP by the County.
