#### **QUESTIONS AND RESPONSES:**

- Q1. Can you confirm that 4104 Plumosa Terrace Bradenton, FL 34210 is the correct address for the non-mandatory site visit?
- R1. Yes, that is the correct address for the non-mandatory site visit.
- Q2. What is the width and depth of the manhole?
- R2. 48" wide and 96" deep.
- Q3. Do you want us to include the cost of any leak repairs in with the lump sum quote or would you prefer a separate leak injection repair quote by linear foot?
- R3. This is the replacement of the manhole with a new polymer, there should not be any leaks to repair.

- Q4. Would traffic cones be sufficient for traffic control, or do we need to include additional manpower and traffic control device measures in our quote?
- R4. All traffic control would need to follow the proper Florida Department of Transportation (FDOT) Maintenance of Traffic (MOT) Index sheet and any MOT plan would need to be submitted to the County for review before the start of any work.
- Q5. Is the County going to notify the residents prior to the proposed work, especially the homeowner at 4104 Plumosa Terrace?
- R5. The homeowner at 4104 Plumosa Terrace has been informed of the intent to make repairs to the manhole. It shall be the responsibility of the awarded contractor to communicate with the homeowner once work begins so the homeowner will know who to communicate with should any issues arise during construction.
- Q6. Is the contractor responsible for the removal and replacement of the decorative gravel in the R/W? if so, please advise where to apply this task in the bid tab.
- R6. Yes, the contractor is responsible for all restorative work to the property. Preconstruction pictures are recommended to document the before and after appearance. See revised Attachment G, Quote Form below.

## Q7. Is the contractor responsible for any geotechnical testing or record drawing?

R7. Yes, the Contractor is responsible for both.

## Q8. Is there any as-built information and elevations for the existing sewer?

R8. No, the County does not have as-builts for this sewer.
