Background Discussion

This project consists of upgrading the Manatee County Central Jail Security System located at 14470 Harlee Road, Palmetto, FL which includes furnishing and installing new programmable logic controllers, human machine interface software, control panels, integration to the existing video surveillance system, complete intercom and paging headend upgrade, door/gate control and alarm monitoring. Software development and programming for the replacement of the existing jail security system which has exceeded its

useful life. Work shall also include retesting all low-voltage security electronics and end points (including, but not limited to duress alarms, all electrical and mechanical control and interfaces). All equipment, materials and work shall be fully tested to ensure a complete operational system.

Formal competitive sealed bid procedures were followed resulting in a total of two (2) bidders submitting a sealed bid for consideration per the attached tabulation of bids.

The Property Management Department recommends award to the lowest, responsive and responsible bidder, Stanley Convergent Security Solutions, Inc., Noblesville, IN in the amount of \$1,312,300.00 based on a completion time of 330 calendar days.
