A.02 DUE DATE AND TIME

The Due Date and Time for submission of Proposals in response to this Request for Qualifications (RFQ) is December 18, 2020 by 3:00 P.M. ET. Proposals must be delivered to the following location: Manatee County Administration Building, 1112 Manatee Ave. W., Suite 803, Bradenton, FL 34205 prior to the Due Date and Time.

Proposal(s) received after the Due Date and Time will not be considered. It will be the sole responsibility of the Proposer to deliver its Proposal to the Manatee County Procurement Division for receipt on or before the Due Date and Time. If a Proposal is sent by U.S. Mail, courier or other delivery services, the Proposer will be responsible for its timely delivery to the Procurement Division. Proposals delayed in delivery will not be considered, will not be opened at the public opening, and arrangements will be made for their return at the Proposer's request and expense.

A.03 PUBLIC OPENING OF RESPONSES

A.04 SUBMISSION OF RESPONSES

The contents of the Proposal sealed package must include:

- One (1) bound original clearly identifying Proposer and marked "ORIGINAL".
- Three (3) bound copy(s) clearly identifying Proposer and marked "COPY" with all required information and identical to the original.
- One (1) electronic format copy(s) clearly identifying Proposer.

Electronic format copies should be submitted on separate Universal Serial Bus (USB) portable flash memory drives or compact disc (CD) in MicroSoft Office or Adobe Acrobat portable document format (PDF) in one continuous file. Do not password protect or otherwise encrypt electronic Proposal copies. Electronic copies must contain an identical Proposal to the original.

Upon submission, all Proposals become the property of Manatee County which has the right to use any or all ideas presented in any Proposal submitted in response to this Request for Qualifications whether, or not, the Proposal is accepted.

Proposals must clearly indicate the legal name, address and telephone number of the Proposer. Proposal Signature Form must be signed by an official or other individual authorized to make representations for the Proposer.

A.06 DISTRIBUTION OF SOLICITATION DOCUMENTS

A.07 ADDENDA

Any interpretations, corrections or changes to this RFQ will be made by addendum. Addenda will be posted on the Procurement Division's web page of the County website at http://www.mymanatee.org/> Business > Bids and Proposals. For those solicitations that are advertised on a third-party website, addenda will likewise be posted on the third-party website.

All addenda are a part of the RFQ and each Proposer will be bound by such addenda. It is the responsibility of each Proposer to obtain, read and comprehend all addenda issued. Failure of any Proposer to acknowledge an issued addendum in its Proposal will not relieve the Proposer from any obligation contained therein.

A.08 RESPONSE EXPENSES

All costs incurred by Proposer in responding to this RFQ and to participate in any interviews/presentations/demonstrations, including travel, will be the sole responsibility of the Proposer.

A.09 QUESTION AND CLARIFICATION PERIOD

Each Proposer shall examine all RFQ documents and will judge all matters relating to the adequacy and accuracy of such documents. Any questions or requests concerning interpretation, clarification or additional information pertaining to this RFQ shall be made in writing via email to the Manatee County Procurement Division to the Designated Procurement Contact or to purchasing@mymanatee.org. All questions received and responses given will be provided to potential Proposers via an addendum to this RFQ

Manatee County will not be responsible for oral interpretations given by other sources including County staff, representative, or others. The issuance of a written addendum by the Procurement Division is the only official method whereby interpretation, clarification or additional information will be given.

A.10 FALSE OR MISLEADING STATEMENTS

Proposals which contain false or misleading statements, or which provide references which do not support an attribute or condition claimed by the Proposer, may be rejected. If, in the opinion of the County, such information was intended to mislead the County in its evaluation of the Proposal, and the attribute, condition or capability is a requirement of this RFQ. Such Proposer will be disqualified from consideration for this RFQ and may be disqualified from submitting a response on future solicitation opportunities with the County.

A.11 WITHDRAWAL OR REVISION OF RESPONSES

Proposers may withdraw Proposals under the following circumstances:

a. If Proposer discovers a mistake(s) prior to the Due Date and Time. Proposer may withdraw its Proposal by submitting a written notice to the Procurement Division. The notice must be

received in the Procurement Division prior to the Due Date and Time for receiving Proposals. A copy of the request shall be retained, and the unopened Proposal returned to the Proposer; or

- b. After the Proposals are opened but before a contract is signed, Proposer alleges a material mistake of fact if:
 - 1. The mistake is clearly evident in the solicitation document; or
 - Proposer submits evidence which clearly and convincingly demonstrates that a mistake
 was made in the Proposal. Request to withdraw a Proposal must be in writing and
 approved by the Procurement Official.

A.12 JOINT VENTURES

Proposers intending to submit a Proposal as a joint venture with another entity are required to have filed proper documents with the Florida Department of Business and Professional Regulation and all other State or local licensing agencies as required by Florida Statute Section 489.119, prior to the Due Date and Time.

A.13 LOBBYING

After the issuance of any solicitation, no prospective Proposer, or their agents, representatives or persons acting at the request of such Proposer, shall contact, communicate with or discuss any matter relating in any way to the solicitation with any County officers, agents or employees, other than the Procurement Official or designee, unless otherwise directed by the Procurement Official or designee. This prohibition includes copying such persons on written communications (including email correspondence) but does not apply to presentations made to evaluation committees or at a County Commission meeting where the Commission is considering approval of a proposed contract/purchase order. This requirement ends upon final execution of the contract/purchase order or at the time the solicitation is cancelled. Violators of this prohibition will be subject to sanctions as provided in the Manatee County Code of Ordinances Section 2-26-31 and 2-26-32. Sanctions may include (a) written warning; (b) termination of contracts; and (c) debarment or suspension.

A.14 EXAMINATION OF RESPONSES

The examination and evaluation of the Proposals submitted in response to this solicitation generally requires a period of not less than ninety (90) calendar days from the Due Date and Time.

A.15 ERRORS OR OMISSIONS

Once a Proposal is opened, the County will not accept any request by Proposer to correct errors or omissions in the Proposal other than as identified in paragraph A.11.

A.16 DETERMINATION OF RESPONSIBLENESS AND RESPONSIVENESS

The County will conduct a due diligence review of all Proposals received to determine if the Proposer is responsible and responsive.

To be responsive a Proposer must submit a Proposal that conforms in all material respects to the requirements of this RFQ and contains all the information, fully completed attachments

and forms, and other documentation required. Proposals that are deemed non-responsive will not be considered or evaluated.

To be responsible, a Proposer must meet the minimum qualification requirements and have the capability to perform the Scope of Services contained in this RFQ. Proposals submitted by Proposers that are deemed non-responsible will not be considered or evaluated.

A.17 RESERVED RIGHTS

The County reserves the right to accept or reject any and all Proposals, to waive irregularities and technicalities, to request additional information and documentation, and to cancel this solicitation at any time prior to execution of the contract. In the event only one Proposal is received, the County reserves the right to negotiate with the Proposer. The County reserves the right to award the contract to a responsive and responsible Proposer which in its sole determination is the best value and in the best interests of the County.

The County reserves the right to conduct an investigation as it deems necessary to determine the ability of any Proposer to perform the work or service requested. Upon request by the County, Proposer shall provide all such information to the County. Additional information may include, but will not be limited to, current financial statements prepared in accordance with generally accepted accounting practices and certified by an independent CPA or official of Proposer; verification of availability of equipment and personnel; and past performance records.

A.18 APPLICABLE LAWS

Proposer must be authorized to transact business in the State of Florida. All applicable laws and regulations of the State of Florida and ordinances and regulations of Manatee County will apply to any resulting contract. This solicitation process will be conducted in accordance with Manatee County Code of Ordinances, Chapter 2-26.

A.19 TAXES

Manatee County is exempt from Federal Excise and State Sales Taxes. (F.E.T. Cert. No. 59-78-0089K; Florida Sales Tax Exempt Cert. No. 85-8012622206C-6). Therefore, the Proposer is prohibited from delineating a separate line item in its Proposal for any sales or service taxes.

The Successful Proposer will be responsible for the payment of taxes of any kind, including but not limited to sales, consumer, use, and other similar taxes payable on account of the work performed and/or materials furnished under the award in accordance with all applicable laws and regulations.

A.20 SCRUTINIZED COMPANIES

Pursuant to Florida Statute Section 287.135, as of July 1, 2012, a company that, at the time of submitting a response for a new contract or renewal of an existing contract, is on the Scrutinized Companies with Activities in Sudan List or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List, created pursuant to Florida Statute Section 215.473, is ineligible for, and may not submit a response for or enter into or renew a contract with an agency or local governmental entity for goods or services of \$1 million or more.

A.21 COLLUSION

Proposer certifies that its Proposal is made without prior understanding, agreement, or connection with any other corporation, firm or person submitting a Proposal for the same materials, services, supplies, or equipment and is in all respects fair and without collusion or fraud.

Any such violation may result in contract cancellation, return of materials or discontinuation of services and the possible removal of Proposer from participation in future County solicitations for a specified period.

The County reserves the right to disqualify a Proposer during any phase of the solicitation process and terminate for cause any resulting contract upon evidence of collusion with intent to defraud on the part of the Proposer.

A.22 CODE OF ETHICS

With respect to this Request for Qualifications, if any Proposer violates, directly or indirectly, the ethics provisions of the Manatee County Procurement Code and/or Florida criminal or civil laws related to public procurement, including but not limited to Florida Statutes Chapter 112, Part II, Code of Ethics for Public Officers and Employees, such Proposer will be disqualified from eligibility to perform the work described in this RFQ, and may also be disqualified from submitting any future bids or proposals to supply goods or services to Manatee County.

A.23 PUBLIC ENTITY CRIMES

In accordance with Section 287.133, Florida Statutes, a person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a proposal on a contract to provide any goods or services to a public entity, may not submit a proposal on a contract with a public entity for the construction or repair of a public building or public work, may not submit proposals on leases or real property to a public entity, may not be awarded or perform work as a contractor, Successful Proposer, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in Section 287.017 for Category Two for a period of 36 months from the date of being placed on the convicted vendor list.

In addition, Manatee County Code of Laws Chapter 2-26 Article V prohibits the award of County contracts to any person or entity who/which has, within the past 5 years, been convicted of, or admitted to in court or sworn to under oath, a public entity crime or of any environmental law that, in the reasonable opinion of the Purchasing Official, establishes reasonable grounds to believe the person or business entity will not conduct business in a reasonable manner.

To ensure compliance with the foregoing, Manatee County Code of Laws requires all persons or entities desiring to contract with Manatee County to execute and file with the Purchasing Official an affidavit, executed under the pain and penalties of perjury, confirming that person, entity, and any person(s) affiliated with the entity, does not have such a record and is therefore eligible to seek and be awarded business with Manatee County. Proposer is to complete Form 3 and submit with your Proposal.

A.24 AMERICANS WITH DISABILITIES

Manatee County does not discriminate upon the basis of any individual's disability status. This non-discrimination policy involves every aspect of County's functions including one's access to participation, employment, or treatment in its programs or activities. Anyone requiring reasonable accommodation for an information conference or Proposal opening should contact the person named on the cover page of this document at least twenty-four (24) hours in advance of either activity.

A.25 EQUAL EMPLOYMENT OPPORTUNITY

In accordance with Title VI of the Civil Rights Act of 1964, Title 15, Part 8 of the Code of Federal Regulations and the Civil Rights Act of 1992, Manatee County hereby notifies all Proposers that it will affirmatively ensure minority business enterprises are afforded full opportunity to participate in response to this Request for Qualifications and will not be discriminated against on the grounds of race, color, national origin, religion, sex, age, handicap, or marital status in consideration of award.

A.26 MINORITY AND/OR DISADVANTAGED BUSINESS ENTERPRISE

A.27 DISCLOSURE

Upon receipt, all inquiries and responses to inquiries related to this Request for Proposal become "Public Records", and shall be subject to public disclosure consistent with Florida Statute, Chapter 119.

Proposals become subject to disclosure thirty (30) days after the opening or if a notice of intent to award decision is made earlier than this time as provided by Florida Statutes § 119.071(1)(b). No announcement or review of the Proposals shall be conducted at the public opening.

If County rejects all Proposals and concurrently notices its intent to reissue the solicitation, the rejected Proposals are exempt from public disclosure until such time the County provides notice of an intended decision concerning the reissued solicitation or until County withdraws the reissued solicitation. A Proposal is not exempt for longer than twelve (12) months after the initial notice of rejection of all Proposals.

Pursuant to Florida Statute 119.0701, to the extent Successful Proposer is performing services on behalf of County, Successful Proposer must:

a. Keep and maintain public records required by public agency to perform the service. That information and data it manages as part of the services may be public record in accordance with Chapter 119, Florida Statutes and Manatee County public record policies. Proposer agrees, prior to providing goods/services, it will implement policies and procedures, which are subject to approval by County, to maintain, produce, secure, and retain public records in accordance with applicable laws, regulations, and County policies including but not limited to Section 119.0701, Florida Statutes.

- b. Upon request from the public agency's custodian of public records, provide the public agency with a copy of the requested records or allow the records to be inspected or copied within a reasonable time at a cost that does not exceed the cost provided in Florida Statutes, Chapter 119, or as otherwise provided by law.
- c. Ensure that public records that are exempt or confidential and exempt from public records disclosure requirements are not disclosed except as authorized by law for the duration of the contract term and following completion of the contract if the Successful Proposer does not transfer the records to the public agency.
- d. Upon completion of the contract, transfer, at no cost, to the public agency all public records in possession of contractor or keep and maintain public records required by the public agency to perform the service. If the Successful Proposer transfers all public records to County upon completion of the contract, the Successful Proposer shall destroy any duplicate public records that are exempt or confidential and exempt from public records disclosure requirements. If the Successful Proposer keeps and maintains public records upon completion of the contract, the Successful Proposer shall meet all applicable requirements for retaining public records. All records stored electronically must be provided to County, upon request from County's custodian of public records, in a format that is compatible with the information technology systems of County.

A.28 TRADE SECRETS

Manatee County is subject to Chapter 119, Florida Statutes. Therefore, all documents, materials, and data submitted as part of a Proposal in response to a Request for Proposal are governed by the disclosure, exemption and confidentiality provisions relating to public records in Florida Statutes.

Notwithstanding any other provision in this solicitation, designation of the entire proposal as 'trade secret', 'proprietary', or 'confidential' is not permitted and may result in a determination that the Proposal is non-responsive and therefore the proposal will not be evaluated or considered.

Except for materials that are 'trade secrets' as defined by Chapter 812, Florida Statutes, ownership of all documents, materials and data submitted as part of a Proposal in response to the Request for Proposal shall belong exclusively to County.

To the extent that Proposer desires to maintain the confidentiality of materials that constitute trade secrets pursuant to Florida law, trade secret material submitted must be segregated from the portions of the Proposal that are not declared as trade secret. In addition, Proposer shall cite, for each trade secret claimed, the Florida Statute number which supports the designation. Further, Proposer shall offer a brief written explanation as to why the cited Statute is applicable to the information claimed as trade secret. Additionally, Proposer shall provide a hard copy of its Proposal that redacts all information designated as trade secret.

In conjunction with trade secret designation, Proposer acknowledges and agrees that:

- 1. Trade secret requests made after the opening will not be considered. However, County reserves the right to clarify the Proposers request for trade secret at any time; and
- County and its officials, employees, agents, and representatives are hereby granted full
 rights to access, view, consider, and discuss the information designated as trade secret
 throughout the evaluation process and until final execution of any awarded purchase order
 or contract; and
- 3. That after notice from County that a public records request has been made pursuant to Proposer's proposal, the Proposer at its sole expense, shall be responsible for defending its determination that submitted material is a trade secret and is not subject to disclosure. Action by Proposer in response to notice from the County shall be taken immediately, but no later than 10 calendar days from the date of notification or Proposer will be deemed to have waived the trade secret designation of the materials.

Offeror shall indemnify and hold County, and its officials, employees, agents and representatives harmless from any actions, damages (including attorney's fees and costs), or claims arising from or related to the designation of trade secrets by the Proposer, including actions or claims arising from County's non-disclosure of the trade secret materials.

A.29 CONFIDENTIALITY OF SECURITY RELATED RECORDS

- a. Pursuant to Florida Statutes § 119.071(3), the following records (hereinafter referred to collectively as "the Confidential Security Records") are confidential and exempt from the disclosure requirements of Florida Statutes § 119.07(1):
 - i. A Security System Plan or portion thereof for any property owned by or leased to County or any privately owned or leased property held by County.
 - ii. Building plans, blueprints, schematic drawings, and diagrams, including draft, preliminary, and final formats, which depict the internal layout and structural elements of a building, arena, stadium, water treatment facility, or other structure owned or operated by County.
 - iii. Building plans, blueprints, schematic drawings, and diagrams, including draft, preliminary, and final formats, which depict the internal layout or structural elements of an attractions and recreation facility, entertainment or resort complex, industrial complex, retail and service development, office development, or hotel or motel development in the possession of, submitted to County.

b. Successful Proposer agrees that, as provided by Florida Statute, it shall not, as a result of a public records request, or for other reason disclose the contents of, or release or provide copies of the Confidential Security Records to any other party absent the express written authorization of County's Property Management Director or to comply with a court order requiring such release or disclosure. To the extent Successful Proposer receives a request for such records, it shall immediately contact the County's designated Contract administrator who shall coordinate County's response to the request.

A.30 E-VERIFY

Prior to the employment of any person under this contract, the Successful Proposer shall utilize the U.S. Department of Homeland Security's E-Verify system to verify the employment eligibility of (a) all persons employed during the contract term by the Successful Proposer to perform employment duties within Florida and (b) all persons, including subcontractors, assigned by the Successful Proposer to perform work pursuant to the contract with Manatee County. Only those individuals determined eligible to work in the United States shall be employed under this contract.

By submission of a Proposal in response to this RFQ, the successful Proposer commits that all employees and subcontractors will undergo e-verification before placement on this contract.

The successful Proposer shall maintain sole responsibility for the actions of its employees and subcontractors. For the life of the contract, all employees and new employees brought in after contract award shall be verified under the same requirement stated above.

A.31 LICENSES AND PERMITS

The successful Proposer shall be solely responsible for obtaining all necessary license and permit fees, including, but not limited to, all license fees, permit fees, impact fees, or inspection fees, and responsible for the costs of such fees. There is no stay of the procurement process during a protest. The Procurement Official shall have the authority to settle and resolve a protest concerning the intended award of a contract.

A.34 BINDING OFFER

Proposals will remain valid for a period of 120 days following the Due Date and Time and will be considered a binding offer to perform the required services and/or provide the required goods. The submission of a Proposal will be taken as prima facie evidence that the Proposer has familiarized itself with the contents of this Solicitation

A.35 ACCESSIBILITY

As part of the evaluation process, the evaluation committee will determine a list of those responsive and responsible Proposals that are deemed by the committee as having a reasonable probability of being selected for award (Short List). At a minimum, the evaluation committee shall conduct discussions with the Short List Proposers and may request additional information or clarification from Proposers for the purpose of further evaluation of (a) conformance to the solicitation requirements, (b) the abilities of the Proposer, and (c) understanding of the Proposal submitted. Additional information and clarification must be submitted by Proposer within the requested time-period.

Additionally, interviews, presentations or demonstrations may be conducted with Proposers as part of the evaluation process. In the final evaluations, each evaluator will consider the information obtained from the proposals as well as the discussions and clarifications presented during the presentations. As part of the final evaluations, the initial technical evaluation scores and ranking for each short-listed firm, in each of the evaluation criterion, will be discussed by the evaluation committee and are subject to change.

B.04 RECOMMENDATION FOR NEGOTIATION

The evaluation committee will determine from the responses to this RFQ and subsequent investigations, the Proposer(s) who best meets the County's requirements. Upon completion of the technical evaluations, the evaluation committee will make a recommendation as to the Proposer(s) which the County should enter into negotiations, if any. The County will notice the Intent to Negotiate, in the same manner the original Request for Qualifications document was noticed prior to commencing negotiations.

- **5.** Successful Proposer agrees that should at any time Successful Proposer fail to meet or maintain the required insurance coverage(s) as set forth herein, the COUNTY may terminate this contract.

The surety selected by the Successful Proposer to provide the Payment and Performance Bond shall be approved by COUNTY prior to issuance of such Bond, which approval shall not be unreasonably withheld or delayed provided that surety is rated A- or better by Best's Key Guide, latest edition.

Failure to provide the required bonds on the prescribed form may result in Successful Proposer being deemed nonresponsive. Bonds must be in the form prescribed in Florida Statutes § 255.05, and must not contain notice, demand or other terms and conditions, including informal pre-claim meetings, not provided for in Florida Statutes § 255.05.

Bonds shall be in an amount equal to 100% of the contract price issued by a duly authorized and nationally recognized surety company, authorized to do business in the State of Florida, satisfactory to COUNTY. ATTACHMENT A

SCOPE OF SERVICES - DESIGN CRITERIA PACKAGE

A.01 GENERAL INFORMATION AND BACKGROUND

The County is seeking proposals from qualified firms to extend the 20-inch Master Lift Station No. 5 force main (MLS #5 FM) approximately 10,113 linear feet along Cortez Road to Master Lift Station No. 1-M (MLS 1-M).

It is the County's expectation to contract with a qualified firm to provide the County with the design, engineering, and construction management services for the proposed Design-Build Project which will be constructed at the following location:

Cortez Road (From approximately 123rd Street West to 87th St Court West) Bradenton, Florida

This project is for site work, survey, engineering design, and construction under a single prime contract for a cost of the work plus design-builder's fee with a Guaranteed Maximum Price (GMP).

The name of the project is: MLS #5 Force Main Extension to MLS 1-M

A.02 PROJECT RATIONALE AND BACKGROUND

This project is intended to relieve capacity issues in the 24-inch gravity main on Cortez Road (upstream of MLS 1-M). Simulations of current and future conditions have shown that during wet weather this pipe is consistently surcharged (at maximum capacity) and has a high risk of causing overflows, preventing MLS 1-M from collecting the wastewater flow from MLS #5 and other tributary areas.

MLS #5 FM is a 20" diameter pipeline that conveys flows from Anna Marie Island MLS #5 to MLS 1-M. This existing 20" diameter FM discharges into an existing 24" gravity sewer line along Cortez Road (SR684) in the vicinity of 119th St W, where it flows by gravity eastward approximately 2 miles to MLS1-M, near 87th St Ct W. The 24" inch gravity line consistently surcharges during wet weather. The 24" PVC gravity line was slip-lined into an old 36" main. Thus MLS #5 FM is projected to bypass the gravity. The gravity line will still receive small diameter gravity and force main flows which must be conveyed to MLS 1-M.

A.03 SCOPE OF WORK

The Design-Build team shall provide the following for the required force main replacement and related work, but not limited to:

- 1. The extension of MLS #5 FM to MLS 1-M, and modifications to or disposition of the 24" gravity sewer line.
- 2. Analyze the existing small diameter (6 gravity and 3 force main) flow connections to the existing 24" gravity, to be routed to MLS 1-M, and offer options for the County's consideration for completion (see as-builts and GIS map in Attachment C)
- 3. Coordinate and permit all work in Cortez Road FDOT ROW with the FDOT.
- 4. Utility coordination shall be conducted utilizing the FDOT 30%/60%/90%/100% design milestone RGB process, to include all utilities and the FDOT involvement.
- 5. Obtain all necessary permits required for proposed work and certify complete.

- 6. Provide a Property Acquisition Team to provide insight and opinion for any contemplated acquisition of easement or property during design; and assist in final acquisition.
- 7. The project schedule will include considerations for maintenance of flows, including seasonal variations, to minimize impact to the other County facilities, including the treatment plant.

Other considerations during the project include, but not limited to:

- 8. Construction sequencing.
- 9. Coordination with County operations staff. County staff will be responsible for opening and closing of valves and also determining if plant impacts proposed to facilitate the project are adequate.
- 10. Minimization of impact to the multi modal public, plan to address inquiries, and coordinate with communities whose service may be temporarily impacted by the work
- 11. Maintenance of Flows is preferred versus by-pass pumping.

Phased Deliverables (based on Standards from A.I.A. and D.B.I.A.)

Design-build team shall deliver for County review and approval: 30% Schematic Design, 60% Design Development with Outline Specifications, 90% Construction Documents with full set of Specifications and a 100% permit set. Each deliverable shall include estimated pricing until the final GMP.

A.04 GENERAL REQUIREMENTS

Professional services for design-build should include, but may not be limited to, utility engineering design, survey and geotechnical testing as required, necessary permits and fees, construction engineering inspection (CEI) services and record drawing certification.

A.05 CODES AND STANDARDS

The Manatee County Wastewater Collection & Transmission System is regulated through the FDEP. Also, the County maintains the Southwest Wastewater Collection System Master Plan (see Attachment D). A.07 ESTIMATED PROJECT COMPLETION DATE

The estimated project completion schedule is 22 months from the project design kick-off meeting.

A.08 ESTIMATED PROJECT COST

The County has budgeted the project design and construction cost at approximately \$5 million, which includes design, construction (including Sitework) and soft costs.



- (2) By providing Submittals the Design-Builder represents to the Owner that it has (i) reviewed and approved them, (ii) determined and verified materials, field measurements and field construction criteria related thereto, or will do so, and (iii) checked and coordinated the information contained within such Submittals with the requirements of the Work and of the Design-Build Documents.

- (3) The Design-Builder shall perform no portion of the Work for which the Design-Build Documents require Submittals until the Owner has approved the respective Submittal.
- The Work shall be in accordance with approved Submittals except that the Design-Builder shall not be relieved of its responsibility to perform the Work consistent with the requirements of the Design-Build Documents. The Work may deviate from the Design-Build Documents only if the Design-Builder has notified the Owner in writing of deviation from the Design-Build Documents at the time of the Submit and a Modification is executed authorizing the identified deviation. The Design-Funder shall not be relieved of responsibility for errors or omission in abmittals of the Owner's approval of the Submittals.
- (5) All professional design services or tifications to be pa ded by the Design-Builder, including all drawn calculation specifications, certifications, shop drawing bmittals shall contain the ther al preparing them. signature and seal of the ensed sign p d or certify a by the licensed design Submittals related to the ork desig professionals, if prepare rs, shall bear the licensed design by o The Owner and its consultants shall be professional's wri appro entitled to rely u e ade cy, accuracy and completeness of the services, certificat performed by such design als ap professionals.
- uilder warrants to the Owner that materials and N. Warranty equipment furnished under the Conet win good quality and new unless the Design-Build The Design-Builder further warrants that the Work will Documents require rmit otherwis conform to the require Ruild Documents and will be free from defects, except the Design Work or otherwise expressly permitted by the Design-Build for those inherent in th quality Documents. Work, m or equipment not conforming to these requirements shall be Design-Builder's warranty excludes remedy for damage or defect consider ctive. ov abuse, alterati s to the Work not executed by the Design-Builder, improper or cause insuf proper operation, or normal wear and tear and normal usage. If Owner he Design-Builder shall furnish satisfactory evidence as to the kind and requi quality or materials an equipment.

Royalties, Patents and Copyrights.

- (1) The Design-Builder shall pay all royalties and license fees.
- (2) The Design-Builder shall defend suits or claims for infringement of copyrights and patent rights and shall hold the Owner and its separate contactors and consultants harmless from loss on account thereof, but shall not be responsible for such defense or loss when a particular design, process

or product of a particular manufacturer or manufacturers is required by the Owner, or where the copyright violations are required in the Owner's Criteria. However, if the Design-Builder has reason to believe that the design, process or product required in the Owner's Criteria is an infringement of a copyright or a patent, the Design-Builder shall be responsible for such loss unless such information is promptly furnished to the Owner. If the Owner receives notice from a patent or copyright owner of an alleged violation of a patent or copyright, attribute to the Design-Builder, the Owner shall give prompt written notice to the Design-Builder.

P. <u>Indemnification</u>.

- To the fullest extent permitted by law, the Design-Busyr shall in (1) and hold harmless the Owner, its officers, agents and en them from and against claims, damage losses and expenses cluding but not limited to attorney's fees, arising ou or resulting from performance of the Work, provided that mage, s or expense is laim. attributable to bodily inju sicknes diseas an, or to injury to or destruction of tangible operty, by only to extent caused by the of 1 Design-Builder, a subcontractor or negligent acts or omissi loyed by them or anyone for whose acts anyone directly of lirectly they may be liable ardles whether such claim, damage, loss or expense is caused in demnified hereunder. Such obligation a party egate, abridge, or reduce other rights or shall not be constru l to which ould otherwise exist as to a party or person ndemnit described 1.P.
- (2) The Design-But ar's duty to indemnify and hold harmless the Owner in P. (1) a shall extend to fines, penalties and costs incurred by the Owner relater to enforcement action taken by local, state, regional or federal reals by entities. The Owner may deduct any of such fines, penalties and costs as described in this subsection from any unpaid amounts then or their fter due the Design-Builder. Any of such fines, penalties and costs of seleducted from any unpaid amounts due the Design-Builder shall be yable to the Owner at the demand of the Owner, together with interest om the date of the demand at the maximum allowable rate.
 - In claims against any person or entity indemnified under this Section 3.1.P by an employee of the Design-Builder, a subcontractor, anyone directly or indirectly employed by them or anyone for whose acts they may be liable, the indemnification obligation under Section 3.1.P(1) shall not be limited by a limitation on amount or type of damages, compensation or benefits payable by or for the Design-Builder or a subcontractor under workers' compensation acts, disability benefit acts or other employee benefit acts.

- With respect to design, engineering and architectural services, the Design-Builder shall indemnify and hold harmless the Owner and its officers, agents and employees, from liabilities, damages, losses, and costs, including, but not limited to reasonable attorneys' fees, to the extent caused by the negligence, recklessness, or intentionally wrongful conduct of the Design-Builder, its design professionals and other persons employed or utilized by the Design-Builder in the performance of this Agreement, including without limitation, defects in design, or errors omissions of the Design-Builder that result in material cost increases.
- (5) The Design-Builder shall defend the Owner in an ction, la uit mediation or arbitration arising from the alleged neglis recklessne nd other intentionally wrongful conduct of the Design-Builde ne Work. employed or utilized by the Design-Builder in the perform So long as Design-Builder, through its vn counsel, perform as obligation to defend the Owner pursuant to this Se on, Design-Builder shall not be required to pay the Owner's q ith the Q er's participation ciate in the defense.
- Q. <u>Contingent Assignment & green ats</u>. Each agreement for a portion of the Work is assigned by the Design-Buil at to the work, provided that:
 - assignment is effective by after remination of the Agreement by the Owner for cause, purs and a Sections 16.1 D or 16.2 B, and only for those agreement at the Owner accepts by written notification to the Design-Builder at the white Engineer, Consultants, and Contractors whose agreements a succepts of assignment; and
 - (2) ssign at is subject to the prior rights of the surety, if any, obligated under ind.

When the per acceptance assignment of an agreement, the Owner assumes the Design-Build is rights and obligations under the assigned agreement. Upon such assignment, if the Work has been suspend to more than thirty (30) days, the compensation under the assigned agreement shall acceptable and attend for increases in cost resulting from the suspension. Upon such assignment to the Owner under this Section 3.1.Q, the Owner may further assign the agreement to a successor design builded on other entity. If the Owner assigns the agreement to a successor design-builded on the owner shall nevertheless remain legally responsible for all of the successor design-builder's or other entity's obligations under this agreement.

R. <u>Design-Builder's Insurance</u>. If and to the extent required by the RFP, the Design-Builder shall furnish insurance coverage for (but not necessarily limited to) workers' compensation, commercial general liability, professional liability, auto liability, excess liability, and builder's risk. The Design-Builder shall furnish to the Owner all appropriate policies and Certificate(s) of Insurance as set forth in Exhibit C.

S. Payment and Performance Bond. Prior to the construction commencement date, the Design-Builder shall obtain, for the benefit of and directed to the Owner, a Payment and Performance Bond satisfying the requirements of Section 255.05, Florida Statutes, covering the faithful performance by the Design-Builder of its obligations under the Design-Build Documents, including but not limited to the construction of the Project on the Project site and the payment of all obligations arising thereunder, including all payments to the Architect/Engineer, Contractors, Consultants, laborers, and materialmen. The surety selected by the Design-Byer er to provide the Payment and Performance Bond shall be approved by the Owner prior to the issuance of such Bond, which approval shall not be unreasonably withheld or delayed ided that e surety is rated A or better by Best's Key Guide, latest edition. For Changes in Work at result in an increase in the Contract Sum, Owner reserves the right to require the Desis der to secu deliver additive riders to the Payment and Performance bond.

ARTICLE IV WORK PRIOR TO EXECUTIO OF THE DESIGN-BUILD

4.1 General.

- A. <u>Information Submertor</u>. Any function submitted by the Design-Builder, and any interim decisions made by the Over thall be refacilitating the design process and shall not modify the Owner's Criteria unless the law and Despn-Builder execute a Modification.
- tions The Design-Builder shall advise the Owner В. Advice ommen ser tions of materials, and building systems and on proposed site use and imp eme equipment. The Design-Builder sh also p. e the Owner with recommendations, consistent actability, availability of materials and labor, time with the Owner's eria, on col requirements for pro installation and construction, and factors related to construction cost including, but no of alternative designs or materials, preliminary budgets, imited life-cycle data, and pos st reductions.

auation f the Owner's Criteria.

A. <u>Meetings</u>. The Design-Builder shall schedule and conduct meetings with the Owner and y other necessary individuals or entities to discuss and review the Owner's Criteria as set forth in Section 1.1. The Design-Builder shall thereafter again meet with the Owner to discuss a preliminary evaluation of the Owner's Criteria. The preliminary evaluation shall address possible alternative approaches to design and construction of the Project and include the Design-Builder's recommendations, if any, with regard to accelerated or fast-track scheduling, procurement, or phased construction. The preliminary evaluation shall consider cost information, constructability, and procurement and construction scheduling issues.

- B. Report. After the Design-Builder meets with the Owner and presents the preliminary evaluation, the Design-Builder shall provide a written report to the Owner, summarizing the Design-Builder's evaluation of the Owner's Criteria. The report shall also include:
 - (1) allocations of program functions, detailing each function and their square foot areas;
 - a preliminary estimate of the cost of the Work, recommendations to adjust the Owner's Criteria to coorm to the Owner's budget;
 - a preliminary schedule, which shall include processed dereal milestones; dates for receiving additional information from, or have to be completed by, the Owner, anticipated date for the Design-Builder proposal, and dates of periodic design review sessions with the Owner; and
 - (4) the following:

(List additional information be leveled in Design-Builder's written report.)

C. <u>Review</u>. The Owner shall view Design-Builder's written report and, if acceptable, provide the Design-Builder ith written onsent to proceed to the development of the preliminary design as described in Select 1.3. The onsent to proceed shall not be construed to modify the Owner's Criteria unless the Cynn and Design-Builder execute a Modification.

4.3 Preliminary Desi

- A. <u>Submittal</u>. Lean the per's issuance of a written consent to proceed under Section 4.2.C Design-Bunk's shall prepare and submit a preliminary design to the Owner. The preliminary design to the Owner a report identifying any deviations from the Owner's Criteria, and shall inches the form
 - (1) commation of the allocations of program functions;
 - (2) site an:
 - uild g plans, sections and elevations;
 - (4) uctural systems;
 - (5) lections of major building systems, including but not limited to mechanical, electrical and plumbing systems; and
 - outline of specifications or sufficient drawing notes describing construction materials.

The preliminary design may include some combination of physical study models, perspective sketches, or digital modeling.

B. <u>Review</u>. The Owner shall review the preliminary design and, if acceptable, provide the Design-Builder with written consent to proceed to development of the Design-

Builder's Proposal. The preliminary design shall not modify the Owner's Criteria unless the Owner and Design-Builder execute a Modification.

4.4 Design-Builder's Proposal.

- A. <u>Submittal</u>. Upon the Owner's issuance of a written consent to proceed under Section 4.3.B, the Design-Builder shall prepare and submit the Design-Builder's Proposal to the Owner. The Design-Builder's Proposal shall include the following:
 - a list of the preliminary design documents and othe informatics, including the Design-Builder's clarifications, assumptions and deviations from the Owner's Criteria, upon which the Design-Builder's constal is based.
 - the proposed Contract Sum, including the compensation method and, if based upon the cost of the Work plus a fee, a written state and estimated cost organized by trade categories, lowances, contingences, Design-Builder's fee, and other items that compare the Contract Sum;
 - (3) the proposed date the Design-Yana hall a lieve Sub-initial Completion;
 - an enumeration of any qualifications and exchange applicable;
 - (5) a list of the Design-Buil s key per hnel, Con stors and suppliers; and
 - (6) the date on which the Des Buil s Proposal expires.
- B. <u>Local Conditions</u>. It mission of the Design-Builder's Proposal shall constitute a representation by the Design-Luike, that it is visited the site and become familiar with local conditions under which the Work to be completed.
- C. <u>Design-B.</u> A. dme . If the Owner and Design-Builder agree on a Design-Builder's Proposal, the Cover and sign-Builder shall execute the Design-Build Amendment setting the terms of agreement.

ARTICLE V ORK FOLLOWING EXECUTION OF HE DESIGN-BUILD AMENDMENT

5.1 Construct A Documents.

- <u>Preparation; Consistency.</u> Upon the execution of the Design-Build Amendment, the Design-Builder shall prepare Construction Documents. The Construction Documents shall establish the quality levels of materials and systems required. The Construction Documents shall be consistent with the Design-Build Documents.
- B. <u>Owner Review</u>. The Design-Builder shall provide the Construction Documents to the Owner for the Owner's information. If the Owner discovers any deviations between the Construction Documents and the Design-Build Documents, the Owner shall promptly

notify the Design-Builder of such deviations in writing. The Construction Documents shall not modify the Design-Build Documents unless the Owner and Design-Builder execute a Modification. The failure of the Owner to discover any such deviations shall not relieve the Design-Builder of the obligation to perform the Work in accordance with the Design-Build Documents.

5.2 Construction.

- A. <u>Commencement</u>. Except as permitted in Section 5.27, construction shall not commence prior to execution of the Design-Build Amendment.
- B. <u>Pre-Amendment Commencement</u>. If the Owner also Documents are in writing, construction may proceed prior to the execution of the Design wild Amendment. However, such authorization shall not waive the Owner's right to reject the Proposal reflected in the Design-Build Amendment.
- shall sur Buile. ise and direct the C. Supervision and Control. The Work, using the Design-Builder's best skill and ention. The De alder shall be solely responsible for, and have control over, constr on means hethods, k iniques, sequences and procedures, and for coordinating all portions of h Work der the Agreement, unless the Design-Build Documents give other specific inst ang these matters. ions d
- D. <u>Inspection</u>. The D sign Ruilder call be responsible for inspection of portions of Work already performed to det min that such portions are in proper condition to receive subsequent Work.

5.3 Labor a Materials.

- A. Design-by the Provide. Unless otherwise provided in the Design-Build Documents, the Design Build provide and pay for labor, materials, equipment, tools, construction proper in machinery, water, heat, utilities, transportation, and other facilities and states, necessary for roper execution and completion of the Work, whether temporary or permatent, and the control of the work.
- B. <u>Abstitutions</u>. When a material or system is specified in the Design-Build Documents, the Design-Build results are substitutions only in accordance with Article VI.
- C. <u>Management of Employees</u>. The Design-Builder shall enforce strict discipline and good order among the Design-Builder's employees and other persons carrying out the Work. The Design-Builder shall not permit employment of unfit persons or persons not properly skilled in tasks assigned to them.

5.4 Taxes. The Design-Builder shall pay applicable sales, consumer, use and similar taxes, for the Work provided by the Design-Builder, that are legally enacted when the Design-Build Amendment is executed, whether or not yet effective or merely scheduled to go into effect.

5.5 Permits, Fees, Notices and Compliance with Laws.

- A. <u>Permits</u>. Unless otherwise provided in the Design-Build Documents, the Design-Builder shall secure and pay for the building permit as well as any er permits, fees, licenses, and inspections by government agencies, necessary for proper execution of the Work and Substantial Completion of the Project.
- Unanticipated Site Conditions. If, during the Work, e Design B. encounters human remains, or recognizes the existence of burial markers, archa wetlands, not indicated in the Design-Build Documents, it. Design-Builder sha ammediately suspend any operations that would affect them and shall notify Owner. Upon receipt of such o ob. govern notice, the Owner shall promptly take any action no ntal authorization required to resume the operations. The Design-Parker sha end such operations ontinu 1 continue until otherwise instructed by the Owner but ith all other operations that do not affect those remains or features. Requests for adtment the Contract Sum and Contract Time arising from the existence of such remain featu y be made as provided in Article VI.

5.6 Allowances.

- A. Allowa to The Design-But or shall include in the Contract Sum all allowances stated in the Design-Wild Large s. Items covered by allowances shall be supplied for such amounts, and by such person or entities to Whom the Design-Builder shall not be required temploy person or entities to whom the Design-Builder has reasonable objection. Unless oth wish wided in a Design-Build Documents,
 - a we see shar cover the cost to the Design-Builder of materials and equinent delivered at the site and all required taxes, less applicable trade discents:
 - be laign-Builder's costs for unloading and handling at the site, labor, stallation costs, overhead, profit, and other expenses contemplated for ated allowance amounts, shall be included in the Contract Sum but not in the allowances; and
 - whenever costs are more than or less than allowances, the Contract Sum shall be adjusted accordingly by Change Order. The amount of the Change Order shall reflect (i) the difference between actual costs and the allowances under Section 5.6.A.(1) and (ii) changes in Design-Builder's costs under Section 5.6.A.(2).
- B. <u>Owner Selections</u>. The Owner shall make selections of materials and equipment with reasonable promptness, for allowances requiring Owner selection.

5.7 Key Personnel, Contractors and Suppliers.

- A. <u>Identification</u>. Except for those persons or entities already identified or required in the Design-Build Amendment, the Design-Builder, as soon as practicable after execution of the Design-Build Amendment, shall furnish in writing to the Owner the names of persons or entities (including those who are to furnish materials or equipment fabricated to a special design) proposed for each principal portion of the Work. The Owner hay reply within fourteen (14) days to the Design-Builder in writing stating (1) whether the where has reasonable objection to any such proposed person or entity or (2) that the Owner receives additional time for review. Failure of the Owner to reply within the 14-day period she constitute notice of no reasonable objection.
- Owner Objections. The Design-Builder shall not emp В. nnel. or contract with Contractors or suppliers to whom the Own has made reasona and timely entity proposed by the Designobjection. If the Owner has reasonable objection to a person Builder, the Design-Builder shall propose another to e Ow has no r sonable objection. Y Ak, the Contract Sum If the rejected person or entity was reasonably car ne of pe orming d by the and Contract Time shall be increased or decre ference, h. Ay, occasioned by such change, and an appropriate Change Order shall ssued fore commencement of the substitute person or entity's Work. - Design Build shanges any of the personnel, Contractors C. Change Ame Iment, the Design-Builder shall notify the Owner or suppliers identified in the Des Bu. and provide the name and qualifica. s of the personnel, Contractor or supplier. The Owner the Design-Builder in writing, stating (1) whether the may reply within for on (14) days Owner has reasonable to the p. osed personnel, Contractor or supplier or (2) that the Owner requires addition w. Failure of the Owner to reply within the 14-day period al time shall constitute notice of 0/ sonable objection.
- Owner good of er and marked currently to indicate field changes and selections made during construction, are one copy of approved Submittals. The Design-Builder shall deliver these items to the Owner accordance with Section 9.10.B as a record of the Work as constructed.
- **5.9 Use of Site.** The Design-Builder shall confine operations at the site to areas permitted by applicable laws, statutes, ordinances, codes, rules and regulations, lawful orders of public authorities, and the Design-Build Documents, and shall not unreasonably encumber the site with materials or equipment.
- **5.10** Cutting and Patching. The Design-Builder shall not cut, patch, or otherwise alter fully or partially completed construction by the Owner or a separate contractor except with written

consent of the Owner and of such separate contractor. Such consent shall not be unreasonably withheld. The Design-Builder shall not unreasonably withhold from the Owner or a separate contractor the Design-Builder's consent to cutting or otherwise altering the Work.

5.11 Cleanliness.

- A. <u>Cleanliness</u>. The Design-Builder shall keep the premises and surrounding area free from accumulation of waste materials or rubbish caused by operations under the Agreement. At completion of the Work, the Design-Builder shall remove were materials, rubbish, tools, construction equipment, machinery and surplus materials from any bout the Design-Builder.
- B. <u>Reimbursement to Owner</u>. If the Design-Builds fair to clean as provided in the Design-Build Documents, the Owner may do so and Owner hall be exceeded to offset its costs incurred against payments to the Design-Builder.
- **5.12** Access to Work. The Design-Builder shall placed the Owner and its separate contractors and consultants access to the Work in product and peress wheever located. The Design-Builder shall notify the Owner regarding toject sattly criterian programs, which the Owner, and its contractors and consultants, shall comply with while at a site.

5.13 Construction by Owner of Sepal Contractors.

- A. Owner's Right to Peron. Construction and to Award Separate Contracts.

The Owner shall notify the Designsurance promptly after execution of any separate contract. If the Designer claims that delay or additional cost is involved because of such by the Owner, the Design-Builder shall make a Claim as provided in rtic XVII.
- hen separate contracts are awarded for different portions of the Project or other construction or operations on the site, the term, "Design-Builder" in the Design-Build Documents in each case shall mean the individual or entity that executes each separate agreement with the Owner.
- (3) The Owner shall provide for coordination of the activities of the Owner's own forces, and of each separate contractor, with the Work of the Design-Builder, who shall cooperate with them. The Design-Builder shall participate with other separate contractors and the Owner in reviewing their construction schedules. The Design-Builder shall make any revisions to the

construction schedule deemed necessary after a joint review and mutual agreement. The construction schedules shall then constitute the schedules to be used by the Design-Builder, separate contractors and the Owner until subsequently revised.

Unless otherwise provided in the Design-Build Documents, when the Owner performs construction or operations related to the Project with the Owner's own forces or separate contractors, the Owner all be deemed to be subject to the same obligations, and to have the green rights, that apply to the Design-Builder under the Agreement.

5.14 Mutual Responsibility.

- A. <u>Coordination of Site Uses</u>. The Design-Builder shall after the wner and separate contractors reasonable opportunity for introduction and storage of their atterials and equipment and performance of their activities, and shall connect and coordinate the Design-Builder's construction and operations with theirs as a pure by the Design-Paul Documents.

- E. <u>Cutting and Patching by Owner</u>. The Owner and each separate contractor shall have the same responsibilities for cutting and patching the Work as the Design-Builder has with respect to the construction of the Owner or separate contractors in Section 5.10.
- **5.15 Owner's Right to Clean Up.** If a dispute arises among the Design-Builder, separate contractors and the Owner as to the responsibility under their respective contracts for maintaining

the premises and surrounding area free from waste materials and rubbish, the Owner may clean up and will allocate the cost among those responsible.

ARTICLE VI CHANGES IN THE WORK

- Concer d Conditions. If the Design-Builder encounters conditions at the site that are (1) subsurface otherwise concealed physical conditions that differ materially from those indicated in the Largn-Build Documents or (2) unknown physical conditions of an unusual nature, that differ materially from those ordinarily found to exist and generally recognized as inherent in construction activities of the character provided for in the Design-Builder shall promptly provide notice to the Owner before conditions are disturbed and in no event later than ten (10) days after first observance of the conditions. The Owner will promptly investigate such conditions and, if the Owner determines that they differ materially and cause an increase or decrease in the Design-Builder's cost of, or time required for, performance of any part of the Work, will recommend an equitable adjustment in the Contract Sum or Contract Time, or

both. If the Owner determines that the conditions at the site are not materially different from those indicated in the Design-Build Documents and that no change in the terms of the Contract is justified, the Owner shall promptly notify the Design-Builder in writing, stating the reasons. If Design-Builder disputes the Owner's determination or recommendation, it may proceed as provided in Article XVII.

6.5 Change Orders; Adjustments to Contract Sum.

The increase or decrease in the Contract Sum resulting from a charge authorized pursuant to the Design-Build Documents shall be determined:

- (1) By mutual acceptance of a lump sum amount provide item d and supported by sufficient substantiating data, to permit the luminary by the Owner; or
- (2) By unit prices stated in the A control or stanguently greed upon; or
- (3) By any other method metally agree the to Own, and Design-Builder.

- subsequently agreed from, and if the quantities originally contemplated are so changed in a proposed Change for that application of the agreed unit prices to the quantities of Work proposed with a substantial inequity to the Owner or Design-Builder, the applicable unit prices and Contract Sum shall be equitably adjusted.
- **6.7 Owner-Initiated Changes.** Without invalidating the Agreement and without notice to any Surety, Owner may, at any time, order additions, deletions or revisions in the Work. These will be authorized by a written amendment, a Field Directive, a Change Order, or a Work Directive Change, as the case may be. Upon receipt of any such document, Design-Builder shall promptly proceed with the Work involved which will be performed under the applicable conditions

of the Design-Build Documents (except as otherwise specifically provided). A Work Directive Change may not change the Contract Sum or the Contract Time; but is evidence that the parties expect that the change directed or documented by a Work Directive Change will be incorporated in a subsequently issued Change Order following negotiations by the parties as to its effect, if any, on the Contract Sum or Contract Time.

- **6.8** Unauthorized Work. Design-Builder shall not be entitled to an increase in the Contract Sum or an extension of the Contract Time with respect to any Work promed that is not required by the Design-Build Documents.
- 6.9 **Defective Work.** Owner and Design-Builder shall excite appropriate Change Orders (or written amendments) covering changes in the Work which prefer because of Defective Work, or which may be required because of acceptance f Defective Work, without adjustment to the Contract Sum.
- Estimates for Changes. At any time Owner management a quotation from Designcalend days after receipt, Builder for a proposed change in the Work. Within one e or decrease in the Design-Builder shall submit a written and detail propos for an Contract Sum or Contract Time for the property d change Owner sha have twenty-one (21) calendar days after receipt of the detailed propond in writing. - **6.11** Form Proced Change The form of all submittals, notices, Change Orders and other documents armitted under the Design-Build Documents shall be determined by the Owner. Standard Owner forms shall be utilized.
- Changes to Contract Time. The Contract Time may only be changed pursuant to a Change Order write amendment to the Design-Build Documents. Any claim for an extension cortening of the Contract Time shall be based on written notice delivered by the party making the claim to the other party. Notice of the extent of the claim with supporting data shall be delivered within fifteen (15) days from detection or beginning of such occurrence and shall be accorded by the claimant's written statement that the adjustment claimed is the entire adjustment to which the claimant has reason to believe it is entitled because of the occurrence of said event. The Contract Time will be extended in an amount equal to time lost due to delays beyond the control of Design-Builder. Such delays shall include, but not be limited to, acts or neglect by Owner or others performing additional Work; or to fires, floods, epidemics, abnormal weather conditions or acts of God. Failure to deliver a written notice of claim within the requisite 15-day period shall constitute a waiver of the right to pursue said claim.

ARTICLE VII OWNER'S RIGHTS AND RESPONSIBILITIES

7.1 General.

- A. <u>Authority of Owner's Representative</u>. The Owner shall designate in writing a representative (the Owner's "authorized representative") who shall have express authority to bind the Owner with respect to all Project matters requiring the Owner's approx or authorization.
- B. <u>Owner Decisions</u>. The Owner shall render decision in a timel manner and in accordance with Design-Builder's schedule agreed to by the Owner.

7.2 Information and Services Required of the Owner.

- A. <u>Promptness</u>. The Owner shall furnish information or service required of the Owner by the Design-Build Documents with reasonable properties.
- Owner B. Inspections and Reports. hall pre the extent under the Owner's control and if not required by the Desi Build Do ments to be provided by the Design-Builder, the results and reports of prior tests, insp ions o vestigations conducted for the Project involving structural or mechanical system hemica and water pollution, hazardous materials, or environmental and subsurface condition tion regarding the presence of pollutants d infor at the Project site. Upon receipt of a written t from Design-Builder, the Owner shall also legal imitations and utility locations for the provide surveys describing physical charact stic site of the Project, and a legal site er the Owner's control. tion of t
- C. <u>Land Uses</u>. Owner all promptly obtain easements, zoning variances, and legal authorization of the Project.
- D. Copy don; Permitting. The Owner shall cooperate with the Design-Builder and other permits, licenses and inspections.
- requires provide by the Owner under this Agreement, shall be furnished at the Owner's expense, and except a otherwise specifically provided in this Agreement or elsewhere in the Design-Build Documents or to the extent the Owner advises the Design-Builder to the contrary in writing, the Design-Builder shall be entitled to rely upon the accuracy and completeness thereof. In no event shall the Design-Builder be relieved of its responsibility to exercise proper precautions relating to the safe performance of the Work.
- F. <u>Notice of Defects</u>. If the Owner observes or otherwise becomes aware of a fault or defect in the Work or non-conformity with the Design-Build Documents, the Owner shall give prompt written notice thereof to the Design-Builder.

- G. <u>Communications</u>. Except as otherwise provided in the Design-Build Documents or when direct communications have been specially authorized, the Owner shall communicate through the Design-Builder with persons or entities employed or retained by the Design-Builder.
- H. Subsurface Conditions. Unless required by the Design-Build Documents to be provided by the Design-Builders, the Owner shall, upon request from the Design-Builder, furnish the services of geotechnical engineers or other consultants for investigation of subsurface, perly carry out the air and water conditions when such services are reasonably necessary to design services furnished by the Design-Builder. In such event, the Design services furnished by the Design-Builder. A-Builder all specify the services required. Such services may include, but are not limited test b ags, test pits, determinations of soil bearing values, percolation tests, evaluations of haz naterials, s erosion and resistivity tests, and necessary operations for anticipating subs condition omission services of geotechnical engineer(s) or other consultants shall include preparation ndof all appropriate reports and professional recommendations

7.3 Submittals.

The Owner's review of Submittals shall not relieve the I n-Builder of obligations under Sections 3.1.M, 3.1.N, and 5.2.C. The Owner's review shall Lof safety precautions or, unless otherwise specifically rute appro any co on means, methods, techniques, sequences or procedures. stated by the Owner, cific item shall not indicate approval of an assembly of which the The Owner's approval item is a hent.
- the Design-Build ocuments the Owner discovers. Upon review of the Submittals required by the Design-Build ocuments the Owner discovers.
- 7.4 Sec. 1.14s; Limitations. Visits to the site by the Owner shall not be construed to create an obligation on the part of the Owner to make onsite inspections to check the quality or quantity of the Work. The Owner shall neither have control over or charge of, nor be responsible for, the construction means, methods, techniques, sequences or procedures, or for the safety precautions and programs in connection with the Work, because these are solely the Design-Builder's rights and responsibilities under the Design-Build Documents.

- **7.5 Design-Builder Performance; Limitations.** The Owner shall not be responsible for the Design-Builder's failure to perform the Work in accordance with the requirements of the Design-Build Documents. The Owner shall not have control over or charge of, and will not be responsible for acts or omissions of the Design-Builder, Architect/Engineer, Consultants, Contractors, or their agents or employees, or any other persons or entitles performing portions of the Work for the Design-Builder.
- 7.6 Rejection of Work. The Owner has the authority to reject Work the Zoes not conform to the Design-Build Documents. The Owner shall have authority to require aspection or testing of the Work, whether or not such Work is fabricated, installed or compared. However, neither this authority of the Owner nor a decision made in good faith either to vercise out to exercise such authority shall give rise to a duty or responsibility of the Owner to Pagn-Build the Architect/Engineer, Consultants, Contractors, material and equipment supports, their vants or employees, or other persons or entities performing portions of the Work.
- **7.7** Completion Dates. The Owner shall determine the date of dates of Substantial Completion in accordance with Section 9.8 and the same final empletion of accordance with Section 9.10.
- 7.8 Owner's Right to Stop Work. If Desig Builder fails to correct Work which is not in accordance with the requirement the De Build Documents as required by Section 11.2 or persistently fails to carry out Wo ccord e with the Design-Build Documents, the Owner may issue a written order to the D uilder top the Work, or any portion thereof, until the cause for such order has been elik however, the right of the Owner to stop the nate the Work shall not give rise to a ner to exercise this right for the benefit of the part the Design-Builder or any other
- sht to Carry ut the Work. If the Design-Builder defaults or neglects 7.9 Owner's Jance with e Design-Build Documents and fails within a ten-day to carry out the Wor from the Owner to commence and continue correction of period after receipt of vritten agence and promptness, the Owner may, without prejudice to other such default or neglect itb wner ma ave, correct such deficiencies. In such case, an appropriate Change cting from payments then or thereafter due the Design-Builder the hall be issued de reas such deficiencies. If payments then or thereafter due the Design-Buil it to cover such amounts, the Design-Builder shall pay the difference to t suffic the Owner. Notwiths ding any other provisions in the Design-Build Documents to the contrary, the Owner shall be itled to bring a direct action in the Circuit Court to recover such costs.
- **7.10 Governmental Body.** The Design-Builder recognizes that the Owner is a governmental body with certain procedural requirements to be satisfied. The Design-Builder has and will make reasonable allowance in its performance of services for such additional time as may be required for approvals and decisions by the Owner and any other necessary government agency.
- **7.11 Pre-Completion Acceptance.** The Owner shall have the right to take possession of and use any completed portions of the Work, although the time for completing the entire Work

or such portions may not have expired, but such taking possession and use shall not be deemed an acceptance of any Work not completed in accordance with the Design-Build Documents.

7.12 Ownership and Use of Drawings, Specifications and Other Instruments of Service.

- (1) The Design-Builder and the Design-Builder's Consultants shall be deemed the authors and owners of their respective Instruments of Service, including the Project Plans and Specifications, and will retained common law, statutory and other reserved rights, including copy ghts. Submittal or distribution to meet official regulatory requirement, or for other purposes in connection with this Project is not to be contrued a publication in derogation of the Design-Builder's and the Design with a Consultant's reserved rights.
- (2) The Design-Builder, Contractors and eterial or equipmen appliers are gs and specifications provided authorized to use and reproduce the drathe Wo to them solely and exclusive All copies made utio under this authorization sh sear the oti , if any, shown on the pyrigh Project Plans and Sa fications. other struments of Service. et forth in Section 7.12(1), the Owner Notwithstanding the reserve right ase the Design-Builder's and the Designshall have the righ all time of Service in execution of the Work. ARTICLE VIII TIME

.1 Progress and ompletion.

- executing the Design-Villa Amendment, the Design-Builder confirms that the Contract Time is a reasonable period for performing the Work.
- B. <u>Insurance</u>. The Design-Builder shall not, except by agreement of the Owner in writing, commence the Work prior to the effective date of insurance required by this Agreement. The Contract Time shall not be adjusted because of the Design-Builder's failure to obtain insurance required under this Agreement.
- C. <u>Substantial Completion</u>. The Design-Builder shall proceed expeditiously with adequate forces and shall achieve Substantial Completion within the Contract Time.

8.2 Delays and Extensions of Time.

- A. Owner Delays. If the Design-Builder is delayed at the time in the commencement or progress of the Work by an act or neglect of the Owner or of a consultant or separate contractor employed by the Owner, or by changes ordered in the Work by the Owner, or by labor disputes, fire, unusual delay in deliveries, unavoidable casualties or other causes beyond the Design-Builder's control, or by delay authorized by the Owner pending restation pursuant to Article XVII hereof, or by other causes that the Owner determines may affy delay, then the Contract Time shall be extended by Change Order for such reasonable one as the Owner may determine.
- B. <u>Claims for Delay</u>. Claims relating to time shall be mad a accordate with applicable provisions of Article XVII.
- C. Liquidated Damages for Delay. Time is the essence in the Design-Build fails to Documents and all obligations thereunder. If the nieve Substantial Build by the Design-Build Completion of the Work within the Contract Tim nd as or rwise Documents, the Owner shall be entitled to retain m the Dean-Builder, as liquidated or recover: ar day, commencing upon the first day damages and not as a penalty, the sum of \$ cale following expiration of the Contract Ta and c ang until the actual date of Substantial to be a reasonable estimate of damages Completion. Such liquidated damages ar by agi the Owner will incur because of delayed the Work. ARTICLE IX PAYME T A PLICATIONS AND PROJECT COMPLETION

- .1 Contract Sun. The Contract Sum shall be stated in the Design-Build Amendment.
- guaranteed maximum lice, the Design-Builder, prior to the first Application for Payment after execution of the Design-Builder, shall submit to the Owner a schedule of values allocating the Contract Sum to the various portions of the Work and prepared in such form and supported by such data to substantiate its accuracy as the Owner may require. This schedule, unless objected to by the Owner, shall be used as a basis for reviewing the Design-Builder's Applications for Payment.

9.3 Applications for Payment.

- A. <u>Submittal; Requirements</u>. At least ten (10) days before the date established for each progress payment, the Design-Builder shall submit to the Owner an itemized Application for Payment for completed portions of the Work. The application shall be notarized, if required, and supported by data substantiating the Design-Builder's right to payment as the Owner may require, such as copies of requisitions from the Architect/Engineer, Consultants, Contractors, and material suppliers, and shall reflect retainage if provided for in the Design-Build Documents.
 - (1) As provided in Section 6.6, Applications for Payment provinced requests for payment because of changes in the Work that have been promptly authorized by Work Directive Changes, or by internal determinations of the Owner but not yet included in Change Orders.
 - Applications for Payment shall not include requests, or portion of the Work for which the Design-Builder does not into the pay the Architect/Engineer Consultant, Configure, and material support, or other persons or entities providing services or which the Design-Builder, unless such Work has been performed to the pay.
- Payments for Services Pro ess otherwise provided in the Design-В. Build Documents, payments shall be e for es provided as well as materials and bsequent incorporation in the Work. If equipment delivered and suitably stored site for approved in advance by the Owner, payme simila be made for materials and equipment suitably stored off the site at a location agree d in iting. - Design-Builder warrants that title to all Work, other than C. arrant d by an Application for Payment will pass to the Owner no later Instruments of Service. f payme The Design-Builder further warrants that, upon submittal of an on for Payment. Work for which a Certificate for Payment has been previously issued Appli and the Owner shall, to the best of the Design-Builder's knowledge, be free and clear of liens, claims, security interests or encumbrances in infort a belief favor of the Design-B der, Architect/Engineer, Consultants, Contractors, material suppliers, or other persons or enti entitled to make a claim by reason of having provided labor, materials and equipment real to the Work.
- **9.4 Certificates for Payment.** The Owner shall, within seven days after receipt of the Design-Builder's Application for Payment, issue to the Design-Builder a Certificate for Payment indicating the amount the Owner determines is properly due, and notify the Design-Builder in writing of the Owner's reasons for withholding certification in whole or in part as provided in Section 9.5.A.

9.5 Decisions to Withhold Certification.

- A. Grounds. The Owner may withhold a Certificate for Payment in whole or in part to the extent reasonably necessary to protect the Owner due to the Owner's determination that the Work has not progressed to the point indicated in the Design-Builder's Application for Payment, or the quality of the Work is not in accordance with the Design-Build Documents. If the Owner is unable to certify payment in the amount of the Application, the Owner will notify the Design-Builder as provided in Section 9.4. If the Design-Builder and Owne the amount that the revised amount, the Owner will promptly issue a Certificate for Payment f Owner deems to be due and owing. The Owner may also withhold a C ficate for because of subsequently discovered evidence, may nullify the whole & part of ertificate for Payment previously issued to such extent as may be necessary to protect der from le which the Design-Builder is responsible because of:
 - (1) defective Work, including design and astruction, not remark,

The Design-Builder shall pay each Architect/Engineer Consultant, Contractor, and other person or entity providing services or work for the Design-Builder no later than the time period required by applicable law, but in no event more than seven days after receipt of payment from the Owner the amount to which the Architect/Engineer Consultant, Contractor, and other person or entity providing services or work for the Design-Builder is entitled, reflecting percentages actually retained from payments to the Design-Builder on account of the portion of the Work performed by the Architect/Engineer, Consultant, Contractor, and other person or entity. The Design-Builder shape, by appropriate er person or entity agreement with each Architect/Engineer, Consultant, Contractor, and a providing services or work for the Design-Builder, require each Archit Éngineer Contractor, and other person or entity providing services or work for the Qesign-Ider to make payments to subcontractors in a similar manner.

If the the Design-Builder fails to fu sh evide seven (7) days, the Owner shall have the re wil right to contact the Architect/Eng ts and Contractors to ascertain whether they have been properly paid. The Owner sha vave no. gation to pay or to see to the payment of money to a Consultant or C ctor, except ay otherwise be required by law.
- E. Suppliers. Design-Builder payments to material and equipment suppliers shall be seated in a manner similar to that provided in Sections 9.6.B, 9.6.C and 9.6.
- partial to the Use of Work. A Certificate for Payment, a progress payment, or partial to the Use of ccupancy of the Project by the Owner shall not constitute acceptance of Work not in accordance with the Design-Build Documents.
- **9.7 Payment.** If the Owner does not issue a Certificate for Payment, through no fault of the Design-Builder, within the time required by the Design-Build Documents, then the Design-Builder may, upon seven additional days' written notice to the Owner, stop the Work until payment of the amount owing has been received. The Contract Time shall be extended appropriately and the Contract Sum shall be increased by the amount of the Design-Builder's reasonable costs of shut-down, delay and start-up.

9.8 Substantial Completion.

- A. <u>Substantial Completion Defined</u>. Substantial Completion shall be as defined in Section 1.4. The date of Substantial Completion is the date certified by the Owner in accordance with this Section 9.8.
- B. <u>List of Corrections</u>. When the Design-Builder considers that the Work, or a portion thereof which the Owner agrees to accept separately, is substantially complete, the Design-Builder shall prepare and submit to the Owner a comprehensive of items to be completed or corrected prior to final payment. Failure to include an item on the list does not alter the responsibility of the Design-Builder to complete all Work in accordance with the Documents.
- Builder's C. Inspections; Corrections. Upon receipt of the Design Owner shall make an inspection to determine whether the Work or designated hereof is substantially complete. The Certificate of Substantial Completion shall be submited by the Design-In ilder to the Owner for written acceptance of responsibilities assigned to it the Certificate Up the Owner's acceptance, and consent of surety, if any, the Owner shall be adjusted for York that is incomplete or not in accordance with the requirements of the Design-Build Documents.

9.9 Partial Occupancy or Use.

A. <u>Right of Owner</u>. The Owner may occupy or use any completed or partially completed portion of the Work at any stage when such portion is designated by separate agreement with the Design-Builder, provided such occupancy or use is authorized by public authorities having jurisdiction over the Project. Such partial occupancy or use may commence whether or not the portion is substantially complete, provided the Owner and Design-Builder have accepted in

writing the responsibilities assigned to each of them for payments, retainage, if any, security, maintenance, heat, utilities, damage to the Work and insurance, and have agreed in writing concerning the period for correction of the Work and commencement of warranties required by the Design-Build Documents. When the Design-Builder considers a portion substantially complete, the Design-Builder shall prepare and submit a list to the Owner as provided under Section 9.8.B. Consent of the Design-Builder to partial occupancy or use shall not be unreasonably withheld. The state of the progress of the Work shall be determined by written agreement between the Owner and Design-Builder.

- B. <u>Inspection</u>. Immediately prior to such partial occurring or use the Owner and Design-Builder shall jointly inspect the area to be occupied or port of the York to be used in order to determine and record the condition of the Work.
- C. Occupancy Shall Not Constitute Acceptance. Unless there is agreed upon, partial occupancy or use of a portion or portions of the York shall not constitute acceptance of Work not complying with the requirements of the Design-Back Documents.

9.10 Final Completion and Final Paym

- A. <u>Timely Inspection</u>. Upon peipt of the Design-Builder's written notice that the Work is ready for final inspection are exceptable and upon receipt of a final Application for Payment, the Owner will promptly mak to be inspection. When the Owner finds the Work acceptable under the Design-Build Document, and the preement fully performed, the Owner will, subject to Section 9.10.B, promptly issue a full Certificate for Payment.
- B. <u>Condition</u> Pay ent. Neither final payment nor any remaining retained percentage shall become depend on the payment of the Owner:
 - (1) In a wit that perolls, bills for materials and equipment, and other debted to expected with the Work, for which the Owner or the Owner's proper might responsible or encumbered (less amounts withheld by Over) have been paid or otherwise satisfied;
 - (2) a conficate evidencing that insurance required by the Design-Build Poct ents to remain in force after final payment is currently in effect;
 - vritten statement that the Design-Builder knows of no substantial reason at the insurance will not be renewable to cover the period required by the Design-Build Documents;
 - consent of surety, if any, to final payment;
 - (5) as-built drawings and an as-constructed record copy of the Design-Build Documents, marked to indicate field changes and selections made during construction:
 - (6) all warranty documentation, manufacturer's warranties, product data, maintenance and operations manuals (including parts and technical manuals), and all schematics and handbooks; and

- (7) if required by the Owner, other data establishing payment or satisfaction of obligations, such as receipts, or releases and waivers of liens, security interests, or encumbrances, arising out of the Agreement, to the extent and in such form as may be designated by the Owner.
- C. Delay; Partial Payment. If, after Substantial Completion of the Work, final completion thereof is materially delayed through no fault of the Design-Builder or by issuance of Change Orders affecting final completion, the Owner shall, upon application by the Design-Builder, and without terminating the Agreement, make payment of the balar due for that portion of the Work fully completed and accepted. If the remaining balance for X rk not ful completed or corrected is less than retainage stipulated in the Design-Build Doc ents, ar f bonds have been furnished, the written consent of surety to payment of the balance de at portion the Ow prior Work fully completed and accepted shall be submitted by the Design-Build to issuance of payment. Such payment shall be made under the terms and conion overning final payment, except that it shall not constitute a waiver of
- D. <u>Waiver of Owner Claims</u>. The many of small payment shall constitute a waiver of Claims by the Owner except those arising from:

ARTICLE X PR ÆCTION OF PERSONS AND PROPERTY

10.1 Sections and Programs. The Design-Builder shall be responsible for initial adaining a dispervising all safety precautions and programs in connection with the performance of the Assement.

- C. <u>Safeguards</u>. The Design-Builder shall implement, as and mainted, as required by existing conditions and performance of the Agreement, reasonable safegrads for safety and protection, including posting danger signs and other warnings pair hazards, promulgating safety regulations, and notifying owners and the safeguards and protections.
- D. <u>Hazardous Materials</u>. When use of struge of a loss as or other hazardous materials or equipment, or unusual methods, as decessary freeeestary free execution of the Work, the Design-Builder shall exercise utmost care, and carry a such a vities under supervision of properly qualified personnel.

- H. <u>Injury or Damage to Person or Property</u>. If the Owner or Design-Builder suffers injury or damage to person or property because of an act or omission of the other, or of others for whose acts such party is legally responsible, written notice of the injury or damage, whether or not insured, shall be given to the other party within a reasonable time not exceeding

twenty one (21) days after discovery. The notice shall provide sufficient detail to enable the other party to investigate the matter.

10.3 Hazardous Materials.

- A. <u>Design-Builder Responsibility</u>. The Design-Builder is responsible for compliance with any requirements included in the Design-Build Documents regarding hazardous materials. If the Design-Builder encounters a hazardous material or substance addressed in the Design-Build Documents, and if reasonable precautions will be inadequated prevent foreseeable bodily injury or death to persons resulting from a material or substance adding by not limited to asbestos or polychlorinated biphenyl (PCB), encountered on the site of the Design-Builder, the Design-Builder shall, upon recognizing the condition, immediately stop which the affected area and report the condition to the Owner in writing.

To the fullest extent permitted by law, the Owner emnify and hold rmless the Design-Builder, the Architect/Engineer Consultants, and shall Cont of any of them, from and against claims, damages, losses and ot Imited to attorneys' fees, arising out of or resulting from performance aing bu exper of the Work in the af ted area, if in fact the material or substance presents the risk of bodily injury or death as de ribed in Section 10.3.A and has not been rendered harmless, provided that such claim, da. ..., loss or expense is attributable to bodily injury, sickness, disease or death, or to injury to, or destruction of, tangible property (other than the Work itself), except to the extent that such damage, loss or expense is due to the fault or negligence of the party seeking indemnity. If, without negligence on the part of the Design-Builder, the Design-Builder is held liable by a government agency for the cost of remediation of a hazardous material or substance solely by reason of performing Work as required by the Design-Build Documents, the Owner shall also indemnify the Design-Builder for all cost and expense thereby incurred.

- D. <u>Limitations on Indemnity</u>. The Owner shall not be responsible under this Section 10.3 for materials or substances the Design-Builder brings to the site unless such materials or substances are required by the owner's Criteria. The Owner shall be responsible for materials or substances required by the Owner's Criteria, except to the extent of the Design-Builder's fault or negligence in the use and handing of such materials or substances.
- E. <u>Indemnity by Design-Builder</u>. The Design-Builder shall indemnify the Owner for the cost and expense the Owner incurs (1) for remediation of a more ial or substance the Design-Builder brings to the site and negligently handles, or (2) where the Design-Builder fails to perform its obligations under Section 10.3.A, except to the extent that the cost and expense are due to the Owner's fault or negligence.
- **10.4 Emergencies.** In an emergency affecting safety of persons or purperty, the resign-Builder shall act, at the Design-Builder's discretion, to prevent threatened dama in its yor loss.

ARTICLE UNCOVERING AND CO LECTION OF LARY

11.1 Uncovering of Work. - Discrete Work. The Design-Builder shall promptly correct Work rejects by the Owner or beling to conform to the requirements of the Design-Build Documents, whether discover the Oriental Completion and whether or not fabricated, installed or consists of prrecting such rejected Work, including additional testing and inspections, the cost of uncovering and replacement, and compensation for any design consultant employed by the Owner whose expresses and compensation were made necessary thereby, shall be at the Design-Builder's expression.
 - B. After Substantial Completion.
 - (1) In addition to the Design-Builder's obligations under Section 3.1.N, if, within three years after the date of Substantial Completion of the Work or designated portion thereof or after the date for commencement of warranties established under Section 9.9.A, or by terms of an applicable special

warranty required by the Design-Build Documents, any of the Work is found not to be in accordance with the requirements of the Design-Build Documents, the Design-Builder shall correct it promptly after receipt of written notice from the Owner to do so unless the Owner has previously given the Design-Builder a written acceptance of such condition. The Owner shall give such notice promptly after discovery of the condition. During the three-year period for correction of the Work, if the Owner fails to notify the Design-Builder and give the Design-Builder an opportunity to make the correction, the Owner waives the rights to equire correction by the Design-Builder and to make a claim for bro n of war Design-Builder fails to correct nonconforming rk with a reasonable time during that period after receipt of notice from wner, the \mathcal{L} may correct it in accordance with Section 7.9.

Nothing contained in this lish a period of limitation with respect to other obligations Section 11.2 shall be d strued the Design-Builder has de re Design-Build Documents. Establishment of the three-year period scribed in Section 11.2.B relates only to the specific obligation of the Work a Builder to correct Work, and has no relationship to the time within which the obligation Desig to co ild Documents may be sought to be enforced, nor to the time within be commenced to establish the Design-Builder's liability with respect to which ngs ma the Design-Builder's igation other than specifically to correct the Work.
- 11.3 A prance of Nonconforming Work. If the Owner prefers to accept Work that is not in accordance with the requirements of the Design-Build Documents, the Owner may do so instead of requiring its removal and correction, in which case the Contract Sum will be reduced as appropriate and equitable. Such adjustment shall be effected whether or not final payment has been made.

ARTICLE XII ACCOUNTING RECORDS; OWNERSHIP OF DOCUMENTS

- **12.1 Accounting Records.** Records of expenses pertaining to all services performed shall be kept in accordance with generally accepted accounting principles and procedures.
- 12.2 **Inspection and Audit.** The Design-Builder's records shall open to inspection and subject to examination, audit, and/or reproduction during norm working / Owner's agents or authorized representatives to the extent necess to ad ately permit evaluation and verification of any invoices, payments or claims submitte Design-Polder nclude, band be or any of its payees during the performance of the Work. These records sha file limited to, accounting records, written policies and procedures, Subcontract ncluding estimates, estimath worksheets, proposals of successful and unsuccessful bidders), origin vering negoticted settlements), correspondence, Change Order files (including documentation related and any other supporting evidence necessary to su the Design-Build chak Documents. They shall also include, but not be mited to hose i ecessary to evaluate and verify direct and indirect costs (including verhead al cations) a view may apply to costs associated with the Design-Build Documents purpose of such audits, inspections, For the examinations and evaluations, the Own norized representatives shall have access gents for the duration of Work, and until three to said records from the effective date of greem (3) years after the date of final payment the Design-Builder pursuant to the Owne Design-Build Documents.
- 12.3 Access. The Own 's agents or uthorized representatives shall have access to the Design-Builder's facilities and an ocessar, words to conduct audits in compliance with this Article. The Own agents or a horized representatives shall give the Design-Builder reasonable advance attention tended in acctions, examinations, and/or audits.
- Agreements, by Cournerts. Upon completion of the Work or termination of this Agreements, records, occuments, tracings, plans, specifications, maps, evaluations, reports, transcripts and other technical data, other than working papers, prepared or developed by the Design-Builde of the Design-Builde at its own expense may retain copies for its files and internal use.

ARTICLE XIII PUBLIC CONTRACT LAWS

13.1 Equal Opportunity Employment.

- B. <u>Participation</u>. No person shall, on the grounds of race, creed, sex, color, national origin, disability or age, be excluded from participation in, be denied the proceeds of, or be subject to discrimination in the performance of this Agreement.
- 13.2 Immigration Reform and Control Act of 1986. Design Builder a nowledges that it is responsible for complying with the provisions of the Immigration Reform and Control Act of 1986, located at 8 U.S.C. Section 1324, et seq., and regulations reformed to the comply with the above statutory provisions shall be considered a material teach and stall be grounds for immediate termination of this Agreement.

The intere espect Design-Builder has pr ided the Affidavit of No Conflict, incorporated into the Agreement as Exhibit "B", as a m rial inducement for Owner entering into this Agreement. If, in the sole Junty Administrator or designee, a conflict of interest is deemed to exist or arise during the term of this Agreement, the County Administrator or designee may terminate this Agreement, effective upon the date so stated in a written notice of termination, without penalty to the Owner.
- 13.4 Truth in Negotiations. By execution of the Design-Build Documents, the Design-Builder certifies to truth-in-negotiations and that wage rates and other factual unit costs supporting the compensation are accurate, complete and current at the time of contracting.

Further, the original Contract Sum and any additions thereto shall be adjusted to exclude any significant sums where the Owner determines the Contract Sum was increased due to inaccurate, incomplete or non-current wage rates and other factual unit costs. Such adjustments must be made within one (1) year after final payment to the Design-Builder.

13.5 Public Entity Crimes. The Design-Builder is directed to the Florida Public Entity Crimes Act, Section 287.133, Florida Statutes, specifically section (2)(a), and the Owner's requirement that the Design-Builder comply with it in all respects prior to an arring the term of this Agreement.

ARTICLE XIV FORCE MAJEURE, FIRE OR OTHER CASUALT

14.1 Force Majeure.

Each party seeking the from nonperformance based on Force Majeure shall use its best efforts to rectify any condition causing a delay and will cooperate with the other party, except that neither party shall be obligated to incur any unreasonable additional costs and expenses to overcome any loss of time that has resulted.
- 14.2 Casualty; Actions by Owner and Design-Builder. During the construction period, if the Project or any part thereof shall have been damaged or destroyed, in whole or in part, the Design-Builder shall promptly make proof of loss; and Owner and Design-Builder shall

proceed promptly to collect, or cause to be collected, all valid claims which may have arisen against insurers or others based upon such damage or destruction. The Design-Builder shall diligently assess the damages or destruction and shall prepare an estimate of the cost, expenses, and other charges, including normal and ordinary compensation to the Design-Builder, necessary for reconstruction of the Project substantially in accordance with the Design-Build Documents. Within fifteen (15) days following satisfaction of the express conditions described in subsections (1), (2) and (3) below, the Design-Builder covenants and agrees diligently to commence reconstruction and to complete the reconstruction or repair of any loss or damage by fire or other casualty to the Project to substantially the same size, floor area, cubic ontent, and general appearance as prior to such loss or damage:

Loss or damage which the Design-Builder determines will not affect the Contract Sum or Substantial Completion Date will be reported to Owner immediately, and associated corrective actions will be undertaken without delay.

- C. The agreements between the Design-Builder and Architect, Contractors and other Consultants identified in the Agreement shall be in writing. These agreements shall be promptly provided to the Owner upon the Owner's written request.
- 5.5 Accounting Records. The Design-Builder shall keep full and detailed records and accounts related to the Cost of the Work and exercise such controls as may be cessary for proper financial management under the Agreement and to substantiate all costs in cred. The accounting and control systems shall be satisfactory to the Owner. The Owner and to Owner's aditors shall, during regular business hours and upon reasonable notice be afforded accessed, and shall be permitted to audit and copy, the Design-Builder's records and account adding complete documentation supporting accounting entities, books, correspondence, instantions, aswings, receipts, subcontracts, Contractor's proposals, purchase orders, vouchers, members and other data relating to the Agreement. The Design-Builder shall provide these records for a period of three years after final payment, or for such longer periods as may be required below.
