Dear Mrs. Valcich:

We are pleased to provide Manatee County with the following responses to the pre-bid questions for Addendum 3. This addendum will also include plan sheet no. 2 (Summary of Pay Items) which was not a part of the original package. One of the responses required a change to the quantities, so revised bid tab forms are also included.

Questions received from Bidders – June 17, 2011

- Question** Would stump grinding be an acceptable means of grubbing? Mechanical removal of these large trees will likely rip roots and damage private property.
- Response** *Stump grinding is an acceptable means of grubbing. The stumps will need to be ground to a minimum depth of one foot or to the base of the stump, whichever is least.*
- Question** I noticed there are 3 silk oak trees on 17th St. E between 36th and 34th that are in conflict with the future sidewalk. None of the 3 trees are shown on the plans. Are these trees to be included in the clearing price?
- Response** *The cost of removing these three trees shall be included in the Pay Item 110-1-1, Clearing and Grubbing.*
- Question** I see no line item for surveying or as-builts. Is the County providing these services?
- Response** *Attachment A Special Provisions, Section 5 requires that the contractor supply record drawings and as-built information certified by a surveyor. Section 10 explains that no separate payment for Special Provisions will be made and the cost shall be included in the individual unit prices for the particular pay item.*



Question As I walked the project I noticed a few valve boxes, water meters, etc. in the ROW however I see no bid item for adjusting. Also, they are not shown on the plans (which surprises me as I noticed bird baths and mail boxes were shown) so I cannot verify the count of each. Where does one apply these costs to the bid?

Response *Note 1 on Sheet 3 states that any water meters located within the limits of construction of the sidewalk will need to be relocated as directed by the Manatee County Utilities. Cost to be included in pay item 110-1-1, Clearing and Grubbing.*

Question There are various areas on the plans that show a proposed swale and note directing you to sheet 23 for details. There is no sheet 23 in the plans I downloaded on Demand Star. Please clarify.

Response *Sheet 23 is out of place in the plan set downloaded from Demand Star. It is the very last page, Page 151, of the package available for download.*

Question There are many types of grates that can be used for a "C" inlet – USF# 6210, 6212, 6606P, 6606G, 6611P, 6611G. All of these grates will fit and can comply with DOT standards, but vary greatly in pricing. Which of these grates will be required for this project?

Response *Use USF #6210 for this project.*

Question Many of the structures for the project lack the required height in order to fit the piping into the structure – i.e. #4, 5B & 18 to . Will there be an allowance made for monetary adjustment in the pay item if structures are revised during the shop drawing submittal process?

Response *No allowances will be made for monetary adjustment in the pay item if structures are revised during the shop drawing submittal process. The following are adjustments to the plans for the previously mentioned structures:*

#4 Raise inlet top ½ inch to 30.92 to allow a half inch of mud between the pipe and the inlet top.

5B Lower manhole bottom one inch to 28.97 to allow a half inch of mud between the pipe and the inlet top.

18 Structure 18 has been relocated for constructability; see attached revised Plan sheet 10.

Question What material (i.e., Concrete, CMP, HDPE, ext.) can be used for the pipe culvert? Plans show concrete, but bid form calls out pipe culvert optional material.

Response *All pipes are to be concrete for this project.*

Question There's an open cut storm crossing under 32nd Ave. What's the limit of the overlay and how will these items (Subbase, Base, and Asphalt) be paid for?



Response From Manatee County Highway, Traffic, and Stormwater Standards, Index 403.2, the overlay shall extend 25 feet from the face of the cut in each direction. Per FDOT specs 430-12.3; the cost of site restoration for pipe installation is to be included in the unit cost for the pipe.

Question How will open cuts across existing concrete driveways be paid for? Plans don't indicate replacement of driveways. Is this quantity included in the 6" sidewalk quantity or will an additional item be added for driveway replacement?

Response Per FDOT specs 430-12.3; the cost of site restoration for pipe installation is to be included in the unit cost for the pipe.

Question Under Special Provisions: Utility Coordination (pg.7) it states that once the NTP is issued the Contractor shall contact the affected Utilities so that temp/permanent relocation plans can be implemented. The possible relocation of utilities could substantially affect the production schedule and thus the number of days required to build the job. Would it not be prudent to have the utility coordination meeting in advance of the NTP?

Response Plans have been submitted to the utility companies at 30% and 90% plan submittals. A preconstruction meeting shall be held with the utilities prior to the NTP being issued.

Question Where is the detail for the Inlet Protection Systems?

Response Detail for inlet protection systems can be found in FDOT 2010 Design Standards Index 102.


Question In the SW corner of 17th and 33rd it appears there should be some existing structure removal and tie-in of existing storm pipe, is this correct?

Response On the SW corner of 17th ST E and 33rd AVE E existing headwall #50 is to be removed and S-4 will tie into the existing pipe under 17th ST E

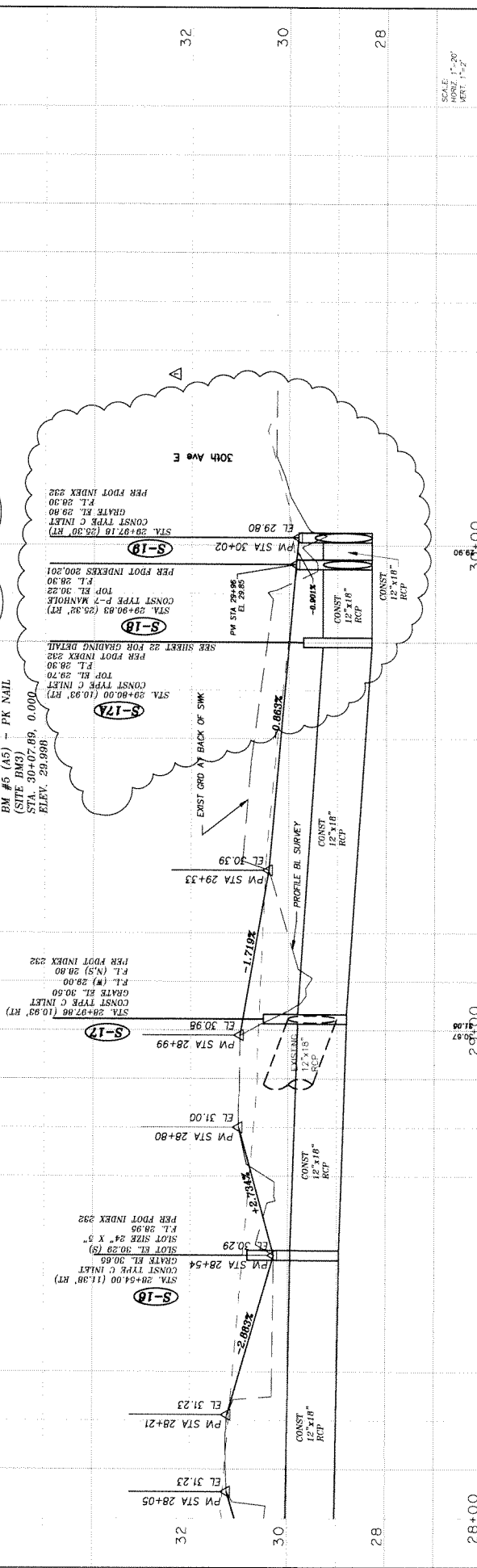
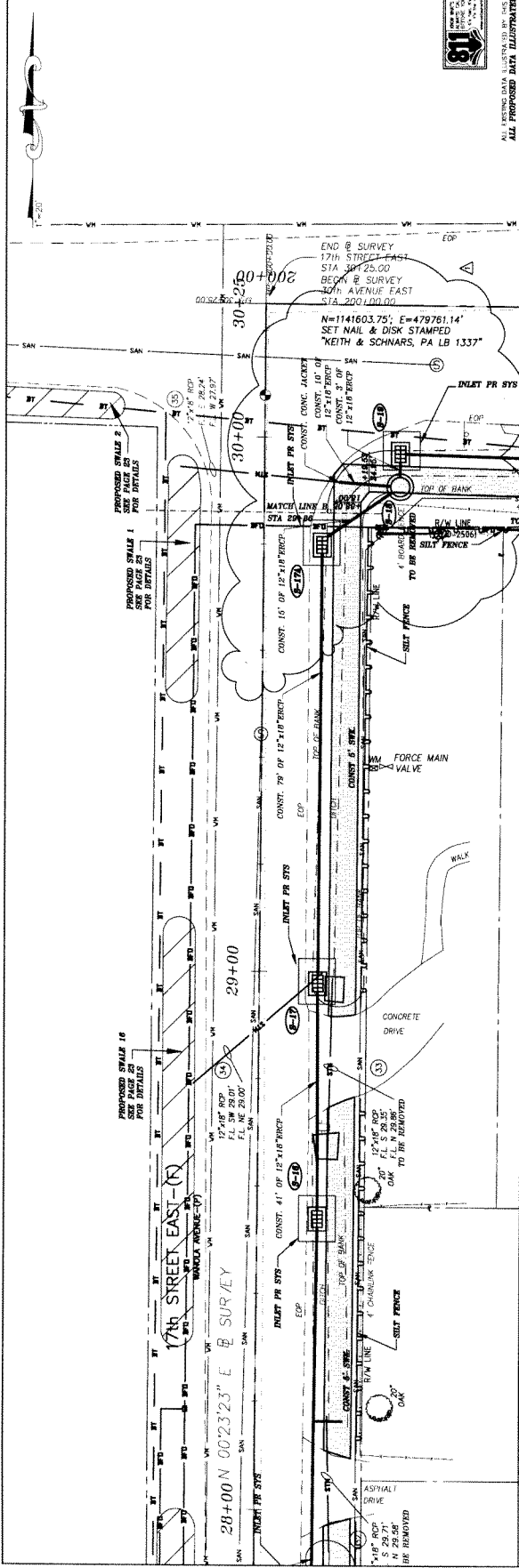
