### BACKGROUND/EVALUATION

The County requested proposals from qualified firms for the provision of Construction Management at Risk Services for the Manatee County Sheriff's Office Fleet Services Facility project to include pre-construction, bidding, and construction services with a guaranteed maximum price (GMP).
