NOTICE OF INTENT TO AWARD

The Manatee County Procurement Division provides notice of its intent to award a contract with Timothy Rose Contracting, Inc., for the provision of Manhole and Sewer Main Repair.

BACKGROUND/DISCUSSION

The work consists of, but not limited to furnishing all equipment, labor, materials, supplies, licensing, transportation, and other components necessary to repair a manhole and sewer main.

The solicitation was advertised on July 14, 2023, on the Manatee County website and DemandStar. It was also provided to the Manatee County Chamber of Commerce, the Manasota Black Chamber of Commerce, Gulf Coast Builders Exchange and Gulf Coast Latin Chamber of Commerce for release to its members. Responses were received from the following firms:
