#### SECTION A, INSTRUCTIONS TO PROPOSERS

In order to receive consideration, Proposers must meet the minimum qualification requirements, submit the required forms and information, and comply with the instructions as follows. Proposals will be accepted from a single business entity, joint venture, partnership or corporation. The County intends to award an agreement(s) for the provision of construction management at risk services as identified in this RFQ.

#### A.01 INFORMATION CONFERENCE

A non-mandatory Information Conference will be held on December 20, 2023 at 1:00 PM at the Manatee County Administration Building, 1112 Manatee Ave West, 7th Floor, Suite 705, Bradenton, FL 34205. Attendance is not mandatory, but is strongly encouraged.

#### A.02 DUE DATE AND TIME

The Due Date and Time for submission of Proposals in response to this Request for Qualifications (RFQ) is January 18, 2024 by 3:00 P.M. ET. Proposals must be delivered to the following location: Manatee County Administration Building, 1112 Manatee Ave. W., 7th Floor, Bradenton, FL 34205 prior to the Due Date and Time.

Proposal(s) received after the Due Date and Time will not be considered. It will be the sole responsibility of the Proposer to deliver its Proposal to the Manatee County Procurement Division for receipt on or before the Due Date and Time. If a Proposal is sent by U.S. Mail, courier or other delivery services, the Proposer will be responsible for its timely delivery to the Procurement Division. Proposals delayed in delivery will not be considered, will not be opened at the public opening, and arrangements will be made for their return at the Proposer's request and expense.

#### A.03 PUBLIC OPENING OF RESPONSES

Sealed Proposals will be publicly opened at Manatee County Administration Procurement Division, 1112 Manatee Avenue West, 7th Floor, Bradenton, Florida 34205, in the presence of County officials immediately upon expiration of the Due Date and Time. Proposers or their representatives may attend the Proposal opening.

Manatee County will make public at the opening the names of the business entities which submitted a Proposal and city and state in which they reside. No review or analysis of the Proposals will be conducted at the Proposal opening.

#### A.04 SUBMISSION OF RESPONSES

The contents of the Proposal sealed package must include:

- One (1) bound original clearly identifying Proposer and marked "ORIGINAL".
- Three (3) bound copy(s) clearly identifying Proposer and marked "COPY" with all required information and identical to the original.
- One (1) electronic format copy(s) clearly identifying Proposer.

Electronic format copies should be submitted on separate Universal Serial Bus (USB) portable flash memory drives or compact disc (CD) in MicroSoft Office<sup>®</sup> or Adobe

Acrobat<sup>®</sup> portable document format (PDF) in one continuous file. Do not password protect or otherwise encrypt electronic Proposal copies. Electronic copies must contain an identical Proposal to the original.

Upon submission, all Proposals become the property of Manatee County which has the right to use any or all ideas presented in any Proposal submitted in response to this Request for Qualifications whether, or not, the Proposal is accepted.

#### A.05 ORGANIZATION OF RESPONSES

Proposals must be organized and arranged with tabs in the same order as listed in the subsections within Exhibit 2, Proposal Response, identifying the response to each specific item.

Proposals must clearly indicate the legal name, address and telephone number of the Proposer. Proposal Signature Form must be signed by an official or other individual authorized to make representations for the Proposer.

#### A.06 DISTRIBUTION OF SOLICITATION DOCUMENTS

All documents issued pursuant to this RFQ are distributed electronically and available for download at no charge at <a href="www.mymanatee.org">www.mymanatee.org</a> > Business > Bids and Proposals. Documents may be viewed and downloaded for printing using Adobe Reader® or Microsoft software, as applicable.

At its sole discretion, the County may utilize a third-party provider to distribute Proposals. For more information regarding this service visit the Procurement webpage of the County website. Utilization of this third-party service is not a requirement for doing business with Manatee County.

Additionally, the RFQ and all related documents are available for public inspection at the Manatee County Procurement Division, 1112 Manatee Avenue West, 7th Floor, Bradenton, FL 34205. Call (941) 749-3014 to schedule an appointment. Documents are available between the hours of 8:00 A.M. and 5:00 P.M., Monday through Friday, with the exception of County holidays.

As a courtesy, Manatee County notifies the Manatee County Chamber of Commerce and the Manasota Black Chamber of Commerce of all active solicitations, who then distributes the information to its members.

#### A.07 ADDENDA

Any interpretations, corrections or changes to this RFQ will be made by addendum. Addenda will be posted on the Procurement Division's web page of the County website at <a href="http://www.mymanatee.org/">http://www.mymanatee.org/</a> Business > Bids and Proposals. For those solicitations that are advertised on a third-party website, addenda will likewise be posted on the third-party website.

All addenda are a part of the RFQ and each Proposer will be bound by such addenda. It is the responsibility of each Proposer to obtain, read and comprehend all addenda issued. Failure of any Proposer to acknowledge an issued addendum in its Proposal will not relieve the Proposer from any obligation contained therein.

#### A.08 RESPONSE EXPENSES

All costs incurred by Proposer in responding to this RFQ and to participate in any interviews/presentations/demonstrations, including travel, will be the sole responsibility of the Proposer.

#### A.09 QUESTION AND CLARIFICATION PERIOD

Each Proposer shall examine all RFQ documents and will judge all matters relating to the adequacy and accuracy of such documents. Any questions or requests concerning interpretation, clarification or additional information pertaining to this RFQ shall be made in writing via email to the Manatee County Procurement Division to the Designated Procurement Contact or to <a href="mailto:purchasing@mymanatee.org">purchasing@mymanatee.org</a>. All questions received and responses given will be provided to potential Proposers via an addendum to this RFQ

Manatee County will not be responsible for oral interpretations given by other sources including County staff, representative, or others. The issuance of a written addendum by the Procurement Division is the only official method whereby interpretation, clarification or additional information will be given.

#### A.10 FALSE OR MISLEADING STATEMENTS

Proposals which contain false or misleading statements, or which provide references which do not support an attribute or condition claimed by the Proposer, may be rejected. If, in the opinion of the County, such information was intended to mislead the County in its evaluation of the Proposal, and the attribute, condition or capability is a requirement of this RFQ. Such Proposer will be disqualified from consideration for this RFQ and may be disqualified from submitting a response on future solicitation opportunities with the County.

#### A.11 WITHDRAWAL OR REVISION OF RESPONSES

Proposers may withdraw Proposals under the following circumstances:

- a. If Proposer discovers a mistake(s) prior to the Due Date and Time. Proposer may withdraw its Proposal by submitting a written notice to the Procurement Division. The notice must be received in the Procurement Division prior to the Due Date and Time for receiving Proposals. A copy of the request shall be retained, and the unopened Proposal returned to the Proposer; or
- b. After the Proposals are opened but before a contract is signed, Proposer alleges a material mistake of fact if:
  - 1. The mistake is clearly evident in the solicitation document; or
  - 2. Proposer submits evidence which clearly and convincingly demonstrates that a mistake was made in the Proposal. Request to withdraw a Proposal must be in writing and approved by the Purchasing Official.

#### A.12 JOINT VENTURES

Proposers intending to submit a Proposal as a joint venture with another entity are required to have filed proper documents with the Florida Department of Business and Professional Regulation and all other State or local licensing agencies as required by Florida Statute Section 489.119, prior to the Due Date and Time.

#### A.13 LOBBYING

After the issuance of any solicitation, no prospective Proposer, or their agents, representatives or persons acting at the request of such Proposer, shall contact, communicate with or discuss any matter relating in any way to the solicitation with any County officers, agents or employees, other than the Purchasing Official or designee, unless otherwise directed by the Purchasing Official or designee. This prohibition includes copying such persons on written communications (including email correspondence) but does not apply to presentations made to evaluation committees or at a County Commission meeting where the Commission is considering approval of a proposed contract/purchase order. This requirement ends upon final execution of the contract/purchase order or at the time the solicitation is cancelled. Violators of this prohibition will be subject to sanctions as provided in the Manatee County Code of Ordinances Section 2-26-31 and 2-26-32. Sanctions may include (a) written warning; (b) termination of contracts; and (c) debarment or suspension.

#### A.14 EXAMINATION OF RESPONSES

The examination and evaluation of the Proposals submitted in response to this solicitation generally requires a period of not less than ninety (90) calendar days from the Due Date and Time.

#### A.15 ERRORS OR OMISSIONS

Once a Proposal is opened, the County will not accept any request by Proposer to correct errors or omissions in the Proposal other than as identified in paragraph A.11.

#### A.16 DETERMINATION OF RESPONSIBLENESS AND RESPONSIVENESS

The County will conduct a due diligence review of all Proposals received to determine if the Proposer is responsible and responsive.

To be responsive a Proposer must submit a Proposal that conforms in all material respects to the requirements of this RFQ and contains all the information, fully completed attachments and forms, and other documentation required. Proposals that are deemed non-responsive will not be considered or evaluated.

To be responsible, a Proposer must meet the minimum qualification requirements and have the capability to perform the Scope of Services contained in this RFQ. Proposals submitted by Proposers that are deemed non-responsible will not be considered or evaluated.

#### A.17 RESERVED RIGHTS

The County reserves the right to accept or reject any and all Proposals, to waive irregularities and technicalities, to request additional information and documentation, and to cancel this solicitation at any time prior to execution of the contract. In the event only one Proposal is received, the County reserves the right to negotiate with the Proposer. The County reserves the right to award the contract to a responsive and responsible Proposer which in its sole determination is the best value and in the best interests of the County.

The County reserves the right to conduct an investigation as it deems necessary to determine the ability of any Proposer to perform the work or service requested. Upon request by the County, Proposer shall provide all such information to the County. Additional information may include, but will not be limited to, current financial statements prepared in accordance with generally accepted accounting practices and certified by an independent CPA or official of Proposer; verification of availability of equipment and personnel; and past performance records.

#### A.18 APPLICABLE LAWS

Proposer must be authorized to transact business in the State of Florida. All applicable laws and regulations of the State of Florida and ordinances and regulations of Manatee County will apply to any resulting contract. This solicitation process will be conducted in accordance with Manatee County Code of Ordinances, Chapter 2-26.

#### A.19 TAXES

Manatee County is exempt from Federal Excise and State Sales Taxes. (F.E.T. Cert. No. 59-78-0089K; Florida Sales Tax Exempt Cert. No. 85-8012622206C-6). Therefore, the Proposer is prohibited from delineating a separate line item in its Proposal for any sales or service taxes.

The Successful Proposer will be responsible for the payment of taxes of any kind, including but not limited to sales, consumer, use, and other similar taxes payable on account of the work performed and/or materials furnished under the award in accordance with all applicable laws and regulations.

#### A.20 SCRUTINIZED COMPANIES

Pursuant to Florida Statute Section 287.135, as of July 1, 2012, a company that, at the time of submitting a response for a new contract or renewal of an existing contract, is on the Scrutinized Companies with Activities in Sudan List or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List, created pursuant to Florida Statute Section 215.473, is ineligible for, and may not submit a response for or enter into or renew a contract with an agency or local governmental entity for goods or services of \$1 million or more.

#### A.21 COLLUSION

Proposer certifies that its Proposal is made without prior understanding, agreement, or connection with any other corporation, firm or person submitting a Proposal for the same materials, services, supplies, or equipment and is in all respects fair and without collusion or fraud.

Any such violation may result in contract cancellation, return of materials or discontinuation of services and the possible removal of Proposer from participation in future County solicitations for a specified period.

The County reserves the right to disqualify a Proposer during any phase of the solicitation process and terminate for cause any resulting contract upon evidence of collusion with intent to defraud on the part of the Proposer.

#### A.22 CODE OF ETHICS

With respect to this Request for Qualifications, if any Proposer violates, directly or indirectly, the ethics provisions of the Manatee County Procurement Code and/or Florida criminal or civil laws related to public procurement, including but not limited to Florida Statutes Chapter 112, Part II, Code of Ethics for Public Officers and Employees, such Proposer will be disqualified from eligibility to perform the work described in this RFQ, and may also be disqualified from submitting any future bids or proposals to supply goods or services to Manatee County.

#### A.23 PUBLIC ENTITY CRIMES

In accordance with Section 287.133, Florida Statutes, a person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a proposal on a contract to provide any goods or services to a public entity, may not submit a proposal on a contract with a public entity for the construction or repair of a public building or public work, may not submit proposals on leases or real property to a public entity, may not be awarded or perform work as a contractor, Successful Proposer, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in Section 287.017 for Category Two for a period of 36 months from the date of being placed on the convicted vendor list.

In addition, Manatee County Code of Laws Chapter 2-26 Article V prohibits the award of County contracts to any person or entity who/which has, within the past 5 years, been

convicted of, or admitted to in court or sworn to under oath, a public entity crime or of any environmental law that, in the reasonable opinion of the Purchasing Official, establishes reasonable grounds to believe the person or business entity will not conduct business in a reasonable manner.

To ensure compliance with the foregoing, Manatee County Code of Laws requires all persons or entities desiring to contract with Manatee County to execute and file with the Purchasing Official an affidavit, executed under the pain and penalties of perjury, confirming that person, entity, and any person(s) affiliated with the entity, does not have such a record and is therefore eligible to seek and be awarded business with Manatee County. Proposer is to complete Form 3 and submit with your Proposal.

#### A.24 AMERICANS WITH DISABILITIES

Manatee County does not discriminate upon the basis of any individual's disability status. This non-discrimination policy involves every aspect of County's functions including one's access to participation, employment, or treatment in its programs or activities. Anyone requiring reasonable accommodation for an information conference or Proposal opening should contact the person named on the cover page of this document at least twenty-four (24) hours in advance of either activity.

#### A.25 EQUAL EMPLOYMENT OPPORTUNITY

In accordance with Title VI of the Civil Rights Act of 1964, Title 15, Part 8 of the Code of Federal Regulations and the Civil Rights Act of 1992, Manatee County hereby notifies all Proposers that it will affirmatively ensure minority business enterprises are afforded full opportunity to participate in response to this Request for Qualifications and will not be discriminated against on the grounds of race, color, national origin, religion, sex, age, handicap, or marital status in consideration of award.

#### A.26 MINORITY AND/OR DISADVANTAGED BUSINESS ENTERPRISE

The State of Florida Office of Successful Proposer Diversity provides the certification process and maintains the database of certified MBE/DBE firms. #### A.27 DISCLOSURE

Upon receipt, all inquiries and responses to inquiries related to this Request for Proposal become "Public Records", and shall be subject to public disclosure consistent with Florida Statute, Chapter 119.

Proposals become subject to disclosure thirty (30) days after the opening or if a notice of intent to award decision is made earlier than this time as provided by Florida Statutes § 119.071(1)(b). No announcement or review of the Proposals shall be conducted at the public opening.

If County rejects all Proposals and concurrently notices its intent to reissue the solicitation, the rejected Proposals are exempt from public disclosure until such time the County provides notice of an intended decision concerning the reissued solicitation or

until County withdraws the reissued solicitation. A Proposal is not exempt for longer than twelve (12) months after the initial notice of rejection of all Proposals.

Pursuant to Florida Statute 119.0701, to the extent Successful Proposer is performing services on behalf of County, Successful Proposer must:

- a. Keep and maintain public records required by public agency to perform the service. That information and data it manages as part of the services may be public record in accordance with Chapter 119, Florida Statutes and Manatee County public record policies. Proposer agrees, prior to providing goods/services, it will implement policies and procedures, which are subject to approval by County, to maintain, produce, secure, and retain public records in accordance with applicable laws, regulations, and County policies including but not limited to Section 119.0701, Florida Statutes.
- b. Upon request from the public agency's custodian of public records, provide the public agency with a copy of the requested records or allow the records to be inspected or copied within a reasonable time at a cost that does not exceed the cost provided in Florida Statutes, Chapter 119, or as otherwise provided by law.
- c. Ensure that public records that are exempt or confidential and exempt from public records disclosure requirements are not disclosed except as authorized by law for the duration of the contract term and following completion of the contract if the Successful Proposer does not transfer the records to the public agency.
- d. Upon completion of the contract, transfer, at no cost, to the public agency all public records in possession of contractor or keep and maintain public records required by the public agency to perform the service. If the Successful Proposer transfers all public records to County upon completion of the contract, the Successful Proposer shall destroy any duplicate public records that are exempt or confidential and exempt from public records disclosure requirements. If the Successful Proposer keeps and maintains public records upon completion of the contract, the Successful Proposer shall meet all applicable requirements for retaining public records. All records stored electronically must be provided to County, upon request from County's custodian of public records, in a format that is compatible with the information technology systems of County.

#### A.28 TRADE SECRETS

Manatee County is subject to Chapter 119, Florida Statutes. Therefore, all documents, materials, and data submitted as part of a Proposal in response to a Request for Proposal are governed by the disclosure, exemption and confidentiality provisions relating to public records in Florida Statutes.

Notwithstanding any other provision in this solicitation, designation of the entire proposal as 'trade secret', 'proprietary', or 'confidential' is not permitted and may result in a determination that the Proposal is non-responsive and therefore the proposal will not be evaluated or considered.

Except for materials that are 'trade secrets' as defined by Chapter 812, Florida Statutes, ownership of all documents, materials and data submitted as part of a Proposal in response to the Request for Proposal shall belong exclusively to County.

To the extent that Proposer desires to maintain the confidentiality of materials that constitute trade secrets pursuant to Florida law, trade secret material submitted must be segregated from the portions of the Proposal that are not declared as trade secret. In addition, Proposer shall cite, for each trade secret claimed, the Florida Statute number which supports the designation. Further, Proposer shall offer a brief written explanation as to why the cited Statute is applicable to the information claimed as trade secret. Additionally, Proposer shall provide a hard copy of its Proposal that redacts all information designated as trade secret.

In conjunction with trade secret designation, Proposer acknowledges and agrees that:

- a. Trade secret requests made after the opening will not be considered. However, County reserves the right to clarify the Proposers request for trade secret at any time; and
- b. County and its officials, employees, agents, and representatives are hereby granted full rights to access, view, consider, and discuss the information designated as trade secret throughout the evaluation process and until final execution of any awarded purchase order or contract; and
- c. That after notice from County that a public records request has been made pursuant to Proposer's proposal, the Proposer at its sole expense, shall be responsible for defending its determination that submitted material is a trade secret and is not subject to disclosure. Action by Proposer in response to notice from the County shall be taken immediately, but no later than 10 calendar days from the date of notification or Proposer will be deemed to have waived the trade secret designation of the materials.

Proposer shall indemnify and hold County, and its officials, employees, agents and representatives harmless from any actions, damages (including attorney's fees and costs), or claims arising from or related to the designation of trade secrets by the Proposer,

including actions or claims arising from County's non-disclosure of the trade secret materials.

#### A.29 CONFIDENTIALITY OF SECURITY RELATED RECORDS

- a. Pursuant to Florida Statutes § 119.071(3), the following records (hereinafter referred to collectively as "the Confidential Security Records") are confidential and exempt from the disclosure requirements of Florida Statutes § 119.07(1):
  - 1. A Security System Plan or portion thereof for any property owned by or leased to County or any privately owned or leased property held by County.
  - 2. Building plans, blueprints, schematic drawings, and diagrams, including draft, preliminary, and final formats, which depict the internal layout and structural elements of a building, arena, stadium, water treatment facility, or other structure owned or operated by County.
  - 3. Building plans, blueprints, schematic drawings, and diagrams, including draft, preliminary, and final formats, which depict the internal layout or structural elements of an attractions and recreation facility, entertainment or resort complex, industrial complex, retail and service development, office development, or hotel or motel development in the possession of, submitted to County.
- b. Successful Proposer agrees that, as provided by Florida Statute, it shall not, as a result of a public records request, or for other reason disclose the contents of, or release or provide copies of the Confidential Security Records to any other party absent the express written authorization of County's Property Management Director or to comply with a court order requiring such release or disclosure. To the extent Successful Proposer receives a request for such records, it shall immediately contact the County's designated Contract administrator who shall coordinate County's response to the request.

#### A.30 E-VERIFY

As part of the evaluation process, the evaluation committee will determine a list of those responsive and responsible Proposals that are deemed by the committee as having a reasonable probability of being selected for award (Short List). At a minimum, the evaluation committee shall conduct discussions with the Short List Proposers and may request additional information or clarification from Proposers for the purpose of further evaluation of (a) conformance to the solicitation requirements, (b) the abilities of the

Proposer, and (c) understanding of the Proposal submitted. Additional information and clarification must be submitted by Proposer within the requested time-period.

Additionally, interviews, presentations or demonstrations may be conducted with Proposers as part of the evaluation process. "Manatee County, a Political Subdivision of the State of Florida," is to be named as an Additional Insured in respect to: Liability arising out of activities performed by or on behalf of the Successful Proposer, his agents, representatives, and employees; products and completed operations of the Successful Proposer; or automobiles owned, leased, hired or borrowed by the Successful Proposer. The coverage shall contain no special limitation(s) on the scope of protection afforded to the COUNTY, its officials, employees or volunteers.

In addition, when requested in writing from the COUNTY, Successful Proposer will provide the COUNTY with a certified copy

- 3. The project's solicitation number and title shall be listed on each certificate.
- **4.** Successful Proposer shall provide thirty (30) days written notice to the Risk Manager of any cancellation, non-renewal, termination, material change, or reduction in coverage of any insurance policies to procurement representative including solicitation number and title with all notices.
- **5.** Successful Proposer agrees that should at any time Successful Proposer fail to meet or maintain the required insurance coverage(s) as set forth herein, the COUNTY may terminate this contract.
- **6.** The Successful Proposer waives all subrogation rights against COUNTY, a Political Subdivision of the State of Florida, for all losses or damages which occur during the contract and for any events occurring during the contract period, whether the suit is brought during the contract period or not.
- 7. The Successful Proposer has sole responsibility for all insurance premiums and policy deductibles.
- 8. It is the Successful Proposer'S responsibility to ensure that his agents, representatives and subcontractors comply with the insurance requirements set forth herein. Successful Proposer shall include his agents, representatives, and subcontractors working on the project or at the worksite as insured under its policies, or Successful Proposer shall furnish separate certificates and endorsements for each agent, representative, and subcontractor working on the project or at the worksite. All coverages for agents, representatives, and subcontractors shall be subject to all of the requirements set forth to the procurement representative.
- **9.** All required insurance policies must be written with a carrier having a minimum A.M. Best rating of A- FSC VII or better. In addition, the COUNTY has the right to review the Successful Proposer's deductible or self-insured retention and to require that it be reduced or eliminated.
- 10. Successful Proposer understands and agrees that the stipulated limits of coverage listed herein in this insurance section shall not be construed as a limitation of any potential liability to the COUNTY, or to others, and the COUNTY'S failure to request evidence of this insurance coverage shall not be construed as a waiver of Successful Proposer'S obligation to provide and maintain the insurance coverage specified.
- 11. Successful Proposer understands and agrees that the COUNTY does not waive its immunity and nothing herein shall be interpreted as a waiver of the COUNTY'S rights, including the limitation of waiver of immunity, as set forth in Florida Statutes 768.28, or any other statutes, and the COUNTY expressly reserves these rights to the full extent allowed by law.
- **12.** No award shall be made until the Procurement Division has received the Certificate of Insurance in accordance with this section.

#### **BONDING REQUIREMENTS**

Bid Bond/Certified Check. By submitting a proposal, the Successful Proposer agrees should its proposal be accepted, to execute the form of Agreement and present the same to COUNTY for approval within ten (10) calendar days after notice of intent to award. The Successful Proposer further agrees that failure to execute and deliver said form of Agreement within ten (10) calendar days will result in damages to COUNTY and as guarantee of payment of same a bid bond/certified check shall be enclosed within the submitted sealed proposal in the amount of five (5%) percent of the total amount of the proposal. The Successful Proposer further agrees that in case the Successful Proposer fails to enter into an Agreement, as prescribed by COUNTY, the bid bond/certified check accompanying the proposal shall be forfeited to COUNTY as agreed liquidated damages. If COUNTY enters into an agreement with a Successful Proposer, or if COUNTY rejects any and/or all proposals, accompanying bond will be promptly returned.

Payment and Performance Bonds. Prior to commencing work, the Successful Proposer shall obtain, for the benefit of and directed to COUNTY, a Payment and Performance Bond satisfying the requirements of Florida Statutes § 255.05, covering the faithful performance by the Successful Proposer of its obligation under the Contract Documents, including but not limited to the construction of the project on the project site and the payment and obligations arising thereunder, including all payments to Subcontractors, laborers, and materialmen. The surety selected by the Successful Proposer to provide the Payment and Performance Bond shall be approved by COUNTY prior to issuance of such Bond, which approval shall not be unreasonably withheld or delayed provided that surety is rated A- or better by Best's Key Guide, latest edition.

Failure to provide the required bonds on the prescribed form may result in Successful Proposer being deemed nonresponsive. Bonds must be in the form prescribed in Florida Statutes § 255.05, and must not contain notice, demand or other terms and conditions, including informal pre-claim meetings, not provided for in Florida Statutes § 255.05.

Bonds shall be in an amount equal to 100% of the contract price issued by a duly authorized and nationally recognized surety company, authorized to do business in the State of Florida, satisfactory to COUNTY. Surety shall be rated as "A-" or better by Best's Key Guide, latest edition. The attorney-in-fact who signs the bonds must file with the bonds, a certificate and effective dated copy of power-of-attorney. Payment and Performance Bonds shall be issued to "Manatee County, a political subdivision of the State of Florida", within ten (10) calendar days after issuance of notice of intent to award.

In addition, pursuant to Florida Statutes § 255.05(1)(b), Florida Statutes, prior to commencing work, the Successful Proposer shall be responsible and bear all costs associated to record the Payment and Performance Bond with the Manatee County Clerk of the Circuit Court. A certified copy of said recording shall be furnished to the Procurement Division upon filing. Pursuant to Florida Statutes § 255.05(1)(b), Florida Statutes, COUNTY will make no payment to the Successful Proposer until the Successful Proposer has complied with this paragraph.

Furnishing Payment and Performance Bonds shall be requisite to execution of an Agreement with COUNTY. Said Payment and Performance Bonds will remain in force for the duration of this Agreement with the premiums paid by the Successful Proposer. Failure of the Successful Proposer to execute such Agreement and to supply the required bonds shall be just cause for cancellation of the award. COUNTY may then contract with the next lowest, responsive and responsible Successful Proposer or re-advertise this RFP.

Failure of COUNTY at any time to require performance by the Successful Proposer of any provisions set out in the resulting Agreement will in no way affect the right of COUNTY, thereafter, to enforce those provisions.

### **EXHIBIT 1, SCOPE OF SERVICES**

#### 1.01 BACKGROUND INFORMATION

The purpose of this Request for Qualifications (RFQ) is to solicit responses from qualified firms or individuals to provide CMAR Services for the 63rd Ave E - US 301 to Tuttle Avenue Project (Project No.6107860), Tuttle Ave at 63rd Ave E (Honore Ave) - Traffic Signal and Intersection Improvement Project (Project No.6065961), and Pearce Drain Watershed Flood Mitigation Project (Project No.6115800).

The intent of this solicitation is to select a firm to provide professional CMAR services (hereinafter referred to in this Scope as CMAR) as part of a team that includes County representatives and the County's selected design team.

## 1.02 PROJECT DESCRIPTION

The 63avE from US301 to Tuttle Avenue project includes construction of approximately 1.12 miles of roadway improvements from US 301 to 39th Street East (Tuttle Avenue). The proposed widening will include a four-lane divided roadway with sidewalks, bike lanes, and street lighting. This section will include four, 12-foot lanes, a 22-foot median, curb and gutter, four-foot bike lanes, and five-foot sidewalks in each direction.

Tuttle Ave at 63rd Ave E (Honore Ave) - Traffic Signal and Intersection Improvement Project includes installation of traffic signal with mast arm supports and provide fiber optic communication related infrastructure and other Advance Traffic Management System (ATMS) devices.

Pearce Drain Watershed Flood Mitigation (6525 33rd St East) project consists of the design of a stormwater reservoir providing flood plain compensation within the Pearce Drain/Gap Creek Watershed for 63rd Avenue Improvements and the surrounding areas. The reservoir will have a direct connection to Pearce Drain.

## 1.03 CMAR SCOPE OF SERVICES

CMAR services to be provided by the CMAR shall include, but are not limited to, preconstruction, bidding, and construction phase services. Compensation to the CMAR for these services shall be a negotiated fee, based on a percentage of the cost of the work. A portion of the fixed fee for services shall be incrementally paid to the CMAR for preconstruction phase services.

## 1.04 TECHNICAL REQUIREMENTS

#### A. PRE-CONSTRUCTION SERVICES

The services to be provided by the CMAR during the design and pre-construction phase may include (but not be limited to):

- 1. Consulting with, advising, assisting, and making recommendations to the County and the Design Team.
- 2. Preliminary site investigations.
- 3. Quality assurance and control during the design phase.
- 4. Develop and maintain baseline schedule. Ongoing monitoring and controlling of the schedule and advising the County of ways to gain efficiencies in project delivery and reduce overall project delivery time.
- 5. Analyze the scope for any potential long lead items, including possible work packaging, that could impact the schedule and advise the County and Design Team of schedule impacts.
- 6. Identify items that have the potential to be procured directly by the County.
- 7. Recommendations for material and systems alternatives.
- 8. Value Engineering recommendations.
- 9. Review all plans and specifications as they are being developed by the Design Team and make recommendations with respect to construction feasibility, availability of material and labor, and time requirements for procurement and construction. During the pre-construction services phase, reviews will be conducted at the 90% and 100% design phases for the CIP# 6107860, CIP #6065961 & CIP #6115800 Project.
- 10. Provide a detailed estimate of construction costs at the 90% design completion level for the CIP# 6107860, CIP #6065961 & CIP #6115800 Project. The cost estimate summary will be organized in the same manner as the proposed construction and equipment packages.
- 11. Support in assistance and development of sequence of construction.
- 12. Code compliance review to ensure permits are attainable.
- 13. Attend in-person progress design meetings or conference calls, if, and when, required by the County and/or the Design Team.
- 14. Make recommendations to the County and the Design Team regarding the division of work in the plans and specifications to facilitate the bidding process and awarding of work packages.
- 15. Advertise/solicit qualified "open book" bids for the various bid packages and obtain a minimum of three quantified bids for each bid package. The County shall have the ability to review and dis-approve any proposed subcontractor or equipment supplier. The County shall have the opportunity to be present during all bid openings.
- 16. Submit a GMP to the County based on the 90% plans and specifications for the Project. Due to potential permitting, land acquisition, and currently

unforeseen issues that may delay the start of construction of the Project until the completion of the 100% plans and specifications, the County may require the GMP to be revised based on the 100% plans and specifications for the Project.

17. Pre-construction services may also include the oversight of any early preconstruction work deemed beneficial to the Project by the County.

#### B. CONSTRUCTION PHASE SERVICES

The construction phase shall commence upon the County's acceptance of the GMP. The CMAR shall become the single point of responsibility for the performance of the construction contract for the Project.

The GMP shall be inclusive of all elements of construction from the submission of all required upfront documents to final inspection and acceptance by the County as a completed Project, including all required final close out documents. The CMAR shall be responsible for all elements of work that require subcontractors and shall be held responsible for replacement of subcontractors that fail to perform.

The services required for the construction phase shall include, but not be limited to, the following:

- 1. The CMAR shall be required to use the Internet web-based project management tool, e-Builder Enterprise<sup>TM</sup> (e-Builder), and protocols included in that software during this project; and shall take any training courses required by the County, at no additional cost to the County. The use of this project management system does not replace or change any contractual responsibilities of the participants. User licenses for e-Builder will be provided and paid for by the County based on assigned roles for the project including Project Manager, Project Fiscal, Project Superintendent, and others as may be required.
- 2. User registration, electronic and computer equipment, and Internet connections required for e-Builder are the responsibility of the successful Bidder and its subcontractors. The sharing of user accounts is prohibited. Individuals who are granted log-in access to the County e-Builder platform shall be responsible for the proper use of their passwords and access to data as agents of the successful Bidder. For documents requiring original signature such as Contracts, paper documents may be required, as directed by the County, in addition to submittal via e-Builder.
- 3. Project management to ensure performance of the work in accordance with the resulting Agreement.
- 4. Construction supervision to ensure compliance with design documents and permit conditions.
- 5. Contracting with all sub-contractors, materials suppliers, surveying firms, equipment suppliers, and other entities as necessary for the construction of

- the project. The County shall employ the services of a Materials Testing firm and will utilize County Infrastructure Inspectors.
- 6. Coordination and cooperation with any third-party contracts or contractors that the County may provide for this project.
- 7. Supervision of third-party testing to assure independence and proper conduct.
- 8. Development and administration of quality control systems to ensure the work is performed in strict accordance with design requirements, applicable building codes and the County's objectives.
- 9. Process payment requests for approval by the Design Team and appropriate County representatives.
- 10. Preparation of County Owner Direct Purchase documents.
- 11. Provide construction phase accounting and reporting to the County.
- 12. Administration of jobsite security and safety programs.
- 13. Providing temporary facilities for use by others.
- 14. Maintenance of on-site and off-site traffic.
- 15. Maintenance of all project records.
- 16. Scheduling of inspections by authorities having jurisdiction over the project.
- 17. Oversight of field surveying services.
- 18. Maintain an updated progress schedule identifying the critical path for the Project.
- 19. Establish and implement procedures for the coordination among the CMAR, the County, Design Team, Materials Testing firm and subcontractors with respect to all aspects of the Project.
- 20. Submit shop drawings for Design Team review and approval prior to purchases.
- 21. Receive and manage equipment and materials.
- 22. Make recommendations, process, and maintain records of requests for changes in the work through change orders.
- 23. Maintain records of Construction remarks and provide As-built notes.
- 24. Manage stormwater runoff, dust, erosion control and dewatering activities.
- 25. Provide high quality Pre, progress and Post Construction photos and video.
- 26. Schedule and conduct regularly scheduled and non-scheduled job-related meetings to ensure orderly progress of the work. Provide meeting minutes for each meeting.

The estimated Project completion time frame for the pre-construction and construction phase is 36 months from the award of this solicitation.

#### 1.08 ESTIMATED PROJECT COST

The County has budgeted the project construction cost at approximately \$24,900,000.00.

WHEREAS, the Owner intends to construct [PROJECT DESCRIPTION], the improvements being hereinafter referred to and defined as the "Project"; and

WHEREAS, Owner desires Construction Manage to provide the professional construction management services requisite to the implementation of the Poject, and

WHEREAS, in response to Owner's Request for qualifications No. (the "RFQ"), Construction Manager has submitted its Proposal and "Trope 1" to provide the services.

**NOW THEREFORE**, the Owner are the Construction Manager, in consideration of the mutual covenants hereinafter set forth, the Cocienty of which is hereby acknowledged, agree as follows:

# ARTICLE 1 ENERLY PROVISIONS

- 1.1 RELATION AP OF ARTIES. The Construction Manager accepts the relationship of trust and confidence established with the Owner by this Agreement, and covenants with the Owner to furnish the Construction Manager's reasonable skill and judgment and to cooperate with the Architect/Engineer in furth ang the interests of the Owner. The Construction Manager shall furnish construction administration and management services and use the Construction Manager's best efforts to perform the Project in an expeditious and economical manner consistent with the interests of the Owner. The Owner shall endeavor to promote harmony and cooperation among the Owner, Architect/Engineer, Construction Manager and other persons or entities employed by the Owner for the Project.
- **1.2 GENERAL CONDITIONS.** The general conditions of the contract shall be the attached General Conditions of the Construction Agreement, which is incorporated herein by reference. The term "Contractor" as used in the General Conditions shall mean the Construction Manager. The term "Contract Sum" as used in the General Conditions shall mean Guaranteed Maximum Price (GMP).

# ARTICLE 2 CONSTRUCTION MANAGER'S RESPONSIBILITIES

The Construction Manager shall perform the services described in this Article. The services to be provided under Sections 2.1 and 2.2 constitute the Preconstruction services. If the Owner and Construction Manager agree, after consultation with the Architect/Engineer, the Construction Phase may commence before the Preconstruction Phase is completed, in which case both phases will proceed concurrently.

## 2.1 PRECONSTRUCTION PHASE.

- A. <u>PRELIMINARY EVALUATION</u>. The Construction Manager shall provide a preliminary evaluation of the Owner's program and Project budget requirements, each in terms of the other.
- CONSULTATION. В. The Construc anager, the Architect/Engineer, shall jointly schedule and attend egular meets as with the Owner. The Construction Manager shall consult with the Owner hitect/Fagineer regarding site use and ing s stem improvements and the selection of materials, built a equipment. The Construction Manager shall provide recommendations on contractive feasibility; actions designed to minimize quirements for procurement, installation and adverse effects of labor or material shortage time construction completion; and factors related to astruction cost, including estimates of alternative designs or materials, preliminary bud ats and loss le économies.
- C. PRELIMINARY I <u>**ROJECT SCHEDULE.**</u> When Project requirements described in Section 3.1.A has sufficiently identified, the Construction Manager shall prepare, and periodically update a premainary Project schedule for the Architect/Engineer's review and the The Construction Manager shall obtain mer's ap oval. Architect/Engineer's If the portion of the preliminary Project schedule relating to the pprov performance of the Architect/Engineer's services. The Construction Manager shall coordinate and integrate the preliminary Prefect schedule with the services and activities of the Owner, Architect/Engineer and Construction Manager. As design proceeds, the preliminary Project schedule shall be updated to indicate proposed activity sequences and durations, milestone dates for receipt and approval of pertinent information, submittal of a Guaranteed Maximum Price (GMP) proposal, preparation and processing of shop drawings and samples, delivery of materials or equipment requiring long-lead-time procurement, Owner's occupancy requirements showing portions of the Project having occupancy priority, and proposed date of Substantial Completion. If preliminary Project schedule updates indicate that previously approved schedules may not be met, the Construction Manager shall make appropriate recommendations to the Owner and Architect/Engineer.
- D. <u>PHASED CONSTRUCTION</u>. The Construction Manager shall make recommendations to the Owner and Architect/Engineer regarding the phased issuance of Project Plans and Specifications to facilitate phased construction of the Work, if such phased construction

is appropriate for the Project, taking into consideration such factors as economies, time of performance, availability of labor and materials, and provisions for temporary facilities.

## E. <u>PRELIMINARY COST ESTIMATES</u>.

- 1. When the Owner has sufficiently identified the Project requirements and the Architect/Engineer has prepared other basic design criteria, the Construction Manager shall prepare, for the review of the Architect/Engineer and approval of the Owner, a preliminary cost estimate utilizing area, volume or similar conceptual estimating techniques.
- 2. When schematic design documents have been prepared by the Architect/Engineer and approved by the Owner are Construction Manager shall prepare, for the review of the Architect/Engineer and approval of the Owner, a more detailed estimate with supporting data. Paring the preparation of the design development documents, the Construction Manager shall update and refine this estimate at appropriate intervals a feed to by the Owner, Architect/Engineer and Construction Manager.
- 3. When design development doc ments have been prepared by the Architect/Engineer and approved by the Owner, the Construction Manager shall prepare a detailed estimate was supporting data for review by the Architect/Engineer and approva by the Owner. During the preparation of the construction documents, the Construction Manager shall update and refine this estimate at appropriate intervals agreed to by the Owner, Architect/Engineer and Construction Constru
- 4. If ar estimate abmitted to the Owner exceeds previously approved estimates or the Owner's judget, the Construction Manager shall make appropriate recommendations to the Owner and Architect/Engineer.
- F. <u>SUBCONTRACTORS AND SUPPLIERS</u>. The Construction Manager shall seek to develop Subcontractor interest in the Project and shall furnish to the Owner and Architect/Engineer for their information a list of possible Subcontractors, including suppliers who are to furnish materials or equipment fabricated to a special design, from whom proposals will be requested for each principal portion of the Work. The Architect/Engineer will promptly reply in writing to the Construction Manager if the Architect/Engineer or Owner know of any objection to such Subcontractor or supplier. The receipt of such list shall not require the Owner or Architect/Engineer to investigate the qualifications of proposed Subcontractors or suppliers, nor shall it waive the right of the Owner or Architect/Engineer later to object to or reject any proposed Subcontractors or suppliers.
- G. <u>LONG-LEAD-TIME ITEMS</u>. The Construction Manager shall recommend to the Owner and Architect/Engineer a schedule for procurement of long-lead-time items which

will constitute part of the Work as required to meet the Project schedule. If such long-lead-time items are procured by the Owner, they shall be procured on terms and conditions acceptable to the Construction Manager. Upon the Owner's acceptance of the Construction Manager's GMP proposal, all contracts for such items shall be assigned by the Owner to the Construction Manager, who shall accept responsibility for such items as if procured by the Construction Manager. The Construction Manager shall expedite the delivery of long-lead-time items.

- H. <u>EXTENT OF RESPONSIBILITY</u>. The Construction Manager does not warrant or guarantee estimates and schedules except as may be included as part of the GMP. The recommendation and advice of the Construction Manager concerning design alternatives shall be subject to the review and approval of the Owner and the Owner's professional consultants. It is not the Construction Manager's responsibility to ascertain that the Project Plans and Specifications are in accordance with applicable laws, statutes, ordinances, building codes, rules and regulations. However, if the Construction Manager recognizes that portions of the Project Plans and Specifications are at variance therewith, the Construction Manager chall promptly notify the Architect/Engineer and Owner in writing.
- I. <u>EQUAL EMPLOYMENT OF ORTUNIT</u> AND AFFIRMATIVE <u>ACTION</u>. The Construction Manager shall comply with a plicable laws, regulations and special requirements of the Contract Documents regarding equal employment opportunity and affirmative action programs.

# 2.2 GUARANTEED MAXIMUM F & SE F OPOSAL AND CONTRACT TIME.

- A. <u>TIMING</u>. When Poject Plans and Specifications are sufficiently complete, the Construction Marager shall ropose a GMP, which shall be the sum of the estimated Cost of the Work and the Contractor. Fee.
- B. SPECIFICATIONS. As the Tried Plans and Specifications may not be finished at the time the GMP proposal is prepared, the Construction Manager shall provide in the GMP for further development of the Project Plans and Specifications by the Architect/Engineer that is consistent with the Contract Documents and reasonably inferable therefrom. Such further development does not include such things as changes in scope, systems, kinds and quality of materials, finishes or equipment, all of which, as required, shall be incorporated by Change Order.
- C. <u>CONTINGENCY</u>. The estimated Cost of the Work shall include the Construction Manager's contingency, a sum established by the Construction Manager for the Construction Manager's exclusive use to cover costs arising under Section 2.2.B and other costs which are properly reimbursable as Cost of the Work but not the basis for a Change Order.
- D. <u>BASIS OF GUARANTEED MAXIMUM PRICE</u>. The Construction Manager shall include with the GMP proposal a written statement of its basis, which shall include:

- 1. A list of the Project Plans and Specifications, including all addenda thereto and the Conditions of the Contract, which were used in preparation of the GMP proposal.
- 2. A list of allowances and a statement of their basis.
- 3. A list of the clarifications and assumptions made by the Construction Manager in the preparation of the GMP proposal to supplement the information contained in the Project Plans and Specifications.
- 4. The proposed GMP, including a statement of the estimated costs organized by trade categories, allowances, contingency, and other items and the Fee that comprise the GMP.
- 5. The Date of Substantial Completion upon which the proposed GMP is based, and a schedule of the construction document is dance dates upon which the date of Substantial Completion is based.
- E. <u>MEETING OF CONSTRUCTION TEAM</u> The Construction Manager shall meet with the Owner and Architect/Engine r to a view by GMP proposal and the written statement of its basis. In the event that the Owner or Architect/Engineer discover any inconsistencies or inaccuracies in the influential presented, they shall promptly notify the Construction Manager, who shall make appropriate agreements to the GMP proposal, its basis, or both.
- F. <u>ACCEPTANCE</u>. Taless the Owner accepts the GMP proposal in writing on or before the date specified in the paposal for such acceptance and so notifies the Construction Manager, the GMP proposal shall not be exective without written acceptance by the Construction Manager.
- G. COSTS IN ADVANCE. Prior to the Owner's acceptance of the Construction Manager's CMP proposal and issuance of a Notice to Proceed, the Construction Manager shall not incur any cost to be reimbursed as part of the Cost of the Work, except as the Owner may specifically authorize in writing.
- H. <u>GMP ADDENDUM</u>. Upon acceptance by the Owner of the GMP proposal, the GMP and its basis shall be set forth in the GMP Addendum. The GMP shall be subject to additions and deductions by a change in the Work as provided in the Contract Documents, and the Substantial Completion Date shall be subject to adjustment as provided in the Contract Documents.
- I. <u>REVISIONS TO PROJECT PLANS AND SPECIFICATIONS</u>. The Owner shall authorize and cause the Architect/Engineer to revise the Project Plans and Specifications to the extent necessary to reflect the agreed-upon assumptions and clarifications contained in the GMP Addendum. Such revised Project Plans and Specifications shall be furnished to the Construction Manager in accordance with schedules agreed to by the Owner,

Architect/Engineer and Construction Manager. The Construction Manager shall promptly notify the Architect/Engineer and Owner if such revised Project Plans and Specifications are inconsistent with the agreed-upon assumptions and clarifications.

J. <u>TAXES</u>. The GMP shall include in the Cost of the Work only those taxes which are enacted at the time the GMP is established.

#### 2.3 CONSTRUCTION PHASE.

#### A. GENERAL.

- 1. The Construction Phase shall commence on the earlier of:
  - i. the owner's acceptance of the Construction Manager's GMP proposal and issuance of a Notice to Proceed, or
  - ii. the Owner's first authorization to be Construct of Manager to:
    - (a) award a Subcontract.
    - (b) undertake construction work with the Construction Manager's own forces, or
    - (c) issue a purch set de for materials or equipment required for the Work

# B. APMINIS ATION.

1. The action of the Work that the Construction Manager does not customarily perform with the Construction Manager's own personnel shall be performed under Succontracts or by other appropriate agreements with the Construction Manager. The Construction Manager shall obtain bids from Subcontractors and from suppliers of materials or equipment fabricated to a special design for the Work from the list previously reviewed and, after analyzing such bids, shall deliver such bids to the Owner and Architect/Engineer. The Owner will then determine, with the advice of the Construction Manager and subject to the reasonable objection of the Architect/Engineer, which bids will be accepted. The Owner may designate specific persons or entities from whom the Construction Manager shall obtain bids; however, if the GMP has been established, the Owner may not prohibit the Construction Manager from obtaining bids from other qualified bidders. The Construction Manager shall not be required to contract with anyone to whom the Construction Manager has reasonable objection.

- 2. If the GMP has been established, and a specific bidder among those whose bids are delivered by the Construction Manager to the Owner and Architect/Engineer (1) is recommended to the Owner by the Construction Manager; (2) is qualified to perform that portion of the Work; and (3) has submitted a bid which conforms to the requirements of the Contract Documents without reservations or exceptions, but the Owner requires that another bid be accepted, then a Change Order shall be issued to adjust the Contract Time and the GMP by the difference between the bid of the person or entity recommended to the Owner by the Construction Manager and the amount of the Subcontract or other agreement actually signed with the person or entity designated by the Owner.
- 3. Subcontracts and agreements with suppliers furnishing materials or equipment fabricated to a special design shall conform to the payment provisions of Sections 7.1.H and 7.1.I and shall not be awarded or the basis of cost plus a fee without the prior consent of the Owner.
- 4. The Construction Manager shall scholule and consect a meeting at which the Owner, Architect/Engineer, Construction Manager and appropriate Subcontractors can discuss the status of the Wark. The Construction Manager shall prepare and promptly distribute meeting minutes.
- 5. Promptly after the Owner a cepta ce of the GMP proposal, the Construction Manager shall prepare a schodul in accordance with Section 2.3 of the General Conditions, including the Owner's occupancy requirements.
- 6. The Construction Genage shall provide monthly written reports to the Owner and Architecta inches on the progress of the entire Work. The Construction Marker shall maintain a daily log containing a record of weather, Su contracts to orking on the Project Site, number of workers, Work accomplished problems encountered and other similar relevant data as the Owner may leasonably require. The log shall be available to the Owner and Architect/Engineer.
- 7. The Construction Manager shall develop a system of cost control for the Work, including regular monitoring of actual costs for activities in progress and estimates for uncompleted tasks and proposed changes. The Construction Manager shall identify variances between actual and estimated costs and report the variances to the Owner and Architect/Engineer at regular intervals.
- **2.4 PROFESSIONAL SERVICES.** Sections 2.1 and 2.2 of the General Conditions shall apply to both the Preconstruction and Construction Phases.
- **2.5 HAZARDOUS MATERIALS.** Sections 2.4.U and 5.5 of the General Conditions shall apply to both the Preconstruction and Construction Phases.

# ARTICLE 3 OWNER'S RESPONSIBILITIES

#### 3.1 INFORMATION AND SERVICES.

- A. <u>GENERAL INFORMATION</u>. The Owner shall provide full information in a timely manner regarding the requirements of the Project, including a program which sets forth the Owner's objectives, constraints and criteria, including space requirements and relationships, flexibility and expandability requirements, special equipment and systems, and site requirements.
- B. <u>BUDGET</u>. The Owner shall establish and update an overall budget for the Project, based on consultation with the Construction Manager and Architect/Engineer, which shall include contingencies for changes in the Work and other costs which are the responsibility of the Owner.
- C. <u>STRUCTURAL AND ENVIRONMENTA</u> <u>TEGAS</u>, <u>SURVEYS AND REPORTS</u>. In the Preconstruction Phase, the Owner shall furnish the following with reasonable promptness and at the Owner's expense. Except to the extend that the Construction Manager knows of any inaccuracy, the Construction Manager shall be intitle to rely upon the accuracy of any such information, reports, surveys, drawings and estate escribed in subsections 1 through 5, below, but shall exercise customary precautions relating to be performance of the Work.
  - 1. Reports, surveys, the ings and lests concerning the conditions of the Project Site which are require by .
  - 2. Surveys describing posicial characteristics, legal limitations and utility location for the project Site, and a written legal description of the Project Site. The survey and egal information shall include, as applicable, grades and lines of states, alloys, pavements and adjoining property and structures; adjacent drainage: rights-of-way, restrictions, easements, encroachments, zoning, deed restrictions, boundaries and contours of the Project Site; locations, dimensions and necessary data pertaining to existing buildings, other improvements and trees; and information concerning available utility services and lines, both public and private, above and below grade, including inverts and depths. All information on the survey shall be referenced to a Project benchmark.
  - 3. The services of a geotechnical engineer when such services are requested by the Construction Manager. Such services may include but are not limited to test borings, test pits, determinations of soil bearing values, percolations tests, evaluations of hazardous materials, ground corrosion and resistivity tests, including necessary operations for anticipating subsoil conditions, with reports and appropriate professional recommendations.

- 4. Structural, mechanical, chemical, air and water pollution tests, tests for hazardous materials, and other laboratory and environmental tests, inspections and reports which are required by law.
- 5. The services of other consultants when such services are reasonably required by the scope of the Project and are requested by the Construction Manager.
- **3.2 OWNER'S DESIGNATED REPRESENTATIVE.** The Owner shall designate in writing its Owner's Project Representative who shall have authority to perform those duties set forth in Section 7.8 of the General Conditions. The Owner's Project Representative shall render decisions promptly and furnish information expeditiously, to avoid unreasonable delay in the services or Work of the Construction Manager.
- 3.3 ARCHITECT/ENGINEER. The Owner shall retain an Architect/Engineer to provide basic services, including normal structural, mechanical and rectrical engineering services, other than cost estimating services, described in Article VI of the General conditions. The Owner shall authorize and cause the Architect/Engineer to provide those additional services requested by the Construction Manager which must necessarily harrowiled by the Architect/Engineer for the Preconstruction and Construction Phases of the Word. Such services shall be provided in accordance with time schedules agreed to by a Owner, Architect/Engineer and Construction Manager. Upon request of the Construction change the Owner shall furnish to the Construction Manager a copy of the Owner's Agreement with the Architect/Engineer.
- 3.4 LEGAL REQUIREM. The Owner shall determine and advise the Architect/Engineer and Construction M pager of any special legal requirements relating specifically to the Project while different those generally applicable to construction in the jurisdiction of the Project. The Owner shall furnish such legal services as are necessary to provide the information and seconds required under Section 3.1.

# ARTICLE 4 MPENSATION AND PAYMENTS FOR PRECONSTRUCTION SERVICES

The Owner shall compensate and make payments to the Construction Manager for Preconstruction Services as follows:

#### 4.1 COMPENSATION.

A. <u>PRECONSTRUCTION SERVICES</u>. For the Preconstruction Services described in Section 2.1, the Construction Manager's compensation shall be calculated as follows:

(State basis of compensation, whether a stipulated sum, multiple of Direct Personnel Expense, actual cost, etc. Include a statement of reimbursable cost items as applicable.)

- B. <u>ADJUSTMENT</u>. Compensation for Preconstruction Services shall be equitably adjusted if such services extend beyond \_\_\_\_\_\_ days from the date of this Agreement or if the originally contemplated scope of services is significantly modified.
- C. <u>PERSONNEL EXPENSE</u>. If compensation is based on a multiple of Direct Personnel Expense, "Direct Personnel Expense" shall mean the direct salaries of the Construction Manager's personnel engaged in the Project and the portion of the cost of their mandatory and customary contributions and benefits related thereto, such as employment taxes and other statutory employee benefits, insurance, sick leave, holidays, vacations, pensions and similar contributions and benefits.

#### 4.2 PAYMENTS.

- A. <u>TIMING</u>. Subject to the requirements Article III of the General Conditions, payments for Preconstruction Services shall be made monthly following presentation of the Construction Manager's invoice and, where applicable, a be in proportion to services performed.
- B. <u>DUE DATES</u>. Payments share in the by wher in accordance with the requirements of Section 218.735, Florida Statutor.

# ART CE 5 COMPENSATION FOR COAS RUCTION PHASE SERVICES

The Owner shall compensate the Construction Manager for Construction Phase services as follows:

**5.1 COMPE** Short for the Construction Manager's performance of the Work as described in Section 2.3, the Owner shall pay the Construction Manager in current funds the Contract Sum consisting the Cost of the Work as defined in Article 6 and the Construction Manager's Fee determined as follows:

**5.2 GUARANTEED MAXIMUM PRICE.** The sum of the Cost of the Work and the Construction Manager's Fee are guaranteed by the Construction Manager not to exceed the amount provided as the GMP in the GMP Addendum, subject to additions and deductions by changes in the Work as provided in the Contract Documents. Such maximum sum as adjusted by approved changes in the Work is referred to in the Contract Documents as the GMP. Costs which would

cause the GMP to be exceeded shall be paid by the Construction Manager without reimbursement by the Owner.

#### **5.3 CHANGES IN THE WORK**

- A. <u>ADJUSTMENTS TO GMP</u>. Adjustments to the GMP on account of changes in the Work subsequent to the execution of the GMP Addendum may be determined by any of the methods listed in Article V of the General Conditions.
- B. "COST". In calculating adjustments to Subcontracts (except those awarded with the Owner's prior consent on the basis of cost plus a fee), the Owner and Construction Manager shall proceed in accordance with Section 5.6 of the General Conditions. Adjustments to subcontracts awarded with the Owner's prior consent on the basis of cost plus a fee shall be calculated in accordance with the terms of those subcontracts. In calculating adjustments to the Agreement, the terms "cost" and "costs" as used in the above-referenced Ceneral Conditions shall mean the Cost of the Work as defined in Article 6 of the Agreement.
- C. <u>CONSTRUCTION MAN JER</u> FEE Vano specific provision is made in Section 5.1 for adjustment of the Construction hanger's Fee in the case of changes in the Work, or if the extent of such changes is such that in the aggregate, the application of the adjustment provisions of Section 5.1 will cause substant at inequally to the Owner or Construction Manager, the Construction Manager's Fee shall be equitably djusted on the basis of the Fee established for the original Work.

# A. TICLE 6 COST OF THAY OR FOR CONSTRUCTION PHASE

# 6.1 COSTS TO BE M. URSED

A. <u>COST F WORK</u>. The term "Cost of the Work" shall mean costs necessarily incurred by the Construction Manager in the proper performance of the Work. Such costs shall be at rates not higher than those customarily paid at the place of the Project except with prior consent of the Owner. The Cost of the Work shall include only the items set forth in this Article 6.

## B. <u>LABOR COSTS</u>.

1. Wages or salaries of construction workers directly employed by the Construction Manager to perform the construction of the Work at the Project Site or, with the Owner's written approval, at off-site workshops.

2. Wages or salaries of the Construction Manager's supervisory and administrative personnel when stationed at the Project Site and performing Work, with the Owner's prior written approval.

<u>Classification</u> <u>Hourly Rate</u> \$0.00

(If it is intended that the wages or salaries of certain personnel stationed at the Construction Manager's principal office or offices other than the site office shall be included in the Cost of the Work, such personnel shall be identified below.)

- 3. Wages or salaries of the Construction Manager's supervisory or administrative personnel engaged, at factories, workshops or wine traveling, in expediting the production or transportation of materials or quipment required for the Work, but only for that portion of their time required for the Work.
- 4. Costs paid or incurred by the Construction Manager for taxes, insurance, contributions, assessments and berefits a quired by law or collective bargaining agreements, and, for personne not lovel by such agreements, customary benefits such as sick leave, in dical and health benefits, holidays, vacations and pensions, provided that such cost are based on wages and salaries included in the Cost of the Work under a stiolar 6.1.B.1 through 6.1.B.3.
- C. <u>SUBCONTRACTOR</u> STATE Payments made by the Construction Manager to Subcontractors in accordance with the Equirements of the Subcontracts.
- D. <u>COSTS O ABRIALS AND EQUIPMENT INCORPORATED IN</u> THE COMPLETED CONSTRUCTION.
  - 1. Costs, including transportation, of materials and equipment incorporated or to be incorporated in the completed construction.
  - 2. Costs of materials described in the preceding Section 6.1.D.1 in excess of those actually installed but required to provide reasonable allowance for waste and for spoilage. Unused excess materials, if any, shall be handed over to the Owner at the completion of the Work or, at the Owner's option, shall be sold by the Construction Manager; amounts realized, if any, from such sales shall be credited to the Owner as a deduction from the Cost of the Work.
- E. <u>COSTS OF OTHER MATERIALS AND EQUIPMENT, TEMPORARY</u> FACILITIES AND RELATED ITEMS.

1. Costs, including transportation, installation, maintenance, dismantling and removal of materials, supplies, temporary facilities, machinery, equipment, and

hand tools not customarily owned by the construction workers, which are provided by the Construction Manager at the Project Site and fully consumed in the performance of the Work; and cost less salvage value on such items if not fully consumed, whether sold to others or retained by the Construction Manager. Cost for items previously used by the Construction Manager shall mean fair market value.

- 2. Rental charges for temporary facilities, machinery, equipment and hand tools not customarily owned by the construction workers, which are provided by the Construction Manager at the Project Site, whether rented from the Construction Manager or others, and costs of transportation, installation, minor repairs and replacements, dismantling and removal thereof. Rates and quantities of equipment rented shall be subject to the Owner's prior approval. The total rental cost of any item may not exceed the pur hase price of any comparable item.
- 3. Costs of removal of debris from the Project Stating and legal disposal of same.
- 4. Reproduction costs, costs of delegioms, in amile transmissions and longdistance telephone calls, postere and express delivery charges, telephone at the Project Site and reasonable petty ash expenses of the Project Site office.
- 5. That portion of the reas name travel and subsistence expenses of the Construction Manager's per onnel incurred while traveling in discharge of duties connected with the Work.

## F. MISCELL N'2005 COSTS.

1. The portional irectly attributable to this Agreement of premiums for insurance and sonds.

(If charges for self-insurance are to be included, specify the basis of reimbursement.)

- 2. Sales, use or similar taxes imposed by a governmental authority which are related to the Work and for which the Construction Manager is liable.
- 3. Fees and assessments for the building permit and for other permits, licenses and inspections for which the Construction Manager is required by the Contract Documents to pay.
- 4. Fees of testing laboratories for tests required by the Contract Documents, except those related to nonconforming Work other than that for which payment is permitted by Section 6.1.G.2, reproduction costs, costs of telegrams, facsimile

transmissions and long-distance telephone calls, postage and express delivery charges, telephone at the Project Site and reasonable petty cash expenses of the Project Site office.

- 5. Royalties and license fees paid for the use of a particular design, process or product required by the Contract Documents; the cost of defending suits or claims for infringement of patent or other intellectual property rights arising from such requirement by the Contract Documents; payments made in accordance with legal judgments against the Construction Manager resulting from such suits or claims and payments of settlements made with the Owner's consent; provided, however, that such costs of legal defenses; judgment and settlements shall not be included in the calculation of the Construction Manager's Fee or the GMP and provided that such royalties, fees and costs are not excluded by the Contract Documents.
- 6. Costs for communications services, electronic are pment and software, directly related to the Work and located at the Project Site. Ath the Owner's prior written approval.
- 7. Deposits lost for causes other can be Co. struction Manager's negligence or failure to fulfill a specific esponsibility to the Owner set forth in this Agreement.
- 8. Legal, mediation and arbitration costs, other than those arising from disputes between the Owner and Construction Manager, reasonably incurred by the Construction Manager of the performance of the Work and with the Owner's written permission, which permission shall not be unreasonably withheld.
- 9. Explaises incured in accordance with Construction Manager's standard per onnel to cy for relocation and temporary living allowances of personnel required for the Work, in case it is necessary to relocate such personnel from distant began ons, with the Owner's prior written approval.
- 10. Other costs incurred in the performance of the Work if and to the extent approved in advance in writing by the Owner.
- G. <u>EMERGENCIES AND REPAIRS TO DAMAGED OR NONCONFORMING WORK</u>. The Cost of the Work shall also include costs described in Section 6.1.A which are incurred by the Construction Manager:
  - 1. In acting to prevent threatened damage, injury or loss in case of emergency affecting the safety of persons and property, as provided in Section 2.4.P of the General Conditions.

- 2. In repairing or correcting damaged or nonconforming Work executed by the Construction Manager or the Construction Manager's Subcontractors or suppliers, provided that such damage or nonconforming Work was not caused by the negligence or failure to fulfill a specific responsibility to the Owner set forth in this Agreement or by the Construction Manager's foremen, engineers or superintendents, or other supervisory, administrative or managerial personnel of the Construction Manager, or by the failure of the Construction Manager's personnel to supervise adequately the Work of the Subcontractors or suppliers, and only to the extent that the cost of repair or correction is not recoverable by the Construction Manager from insurance, sureties, Subcontractors, suppliers or others.
- H. <u>COSTS TO BE INCLUDED</u>. The costs described in Sections 6.1.A through 6.1.G shall be included in the Cost of the Work notwith landing any provisions of the General Conditions which may require the Construction Manager to pay such costs, unless such costs are excluded by the provisions of Section 6.2.

## **6.2 COSTS NOT TO BE REIMBURSED.** The Cost of the Fork shall not include:

- 1. Salaries and other compensation of the Construction Manager's personnel stationed at the Construction Manager's principal office or offices other than the Project Site office, except as specifically provided in Section 6.1.B.2 and 6.1.B.3.
- 2. Bonuses, profit sharing, in entive composation, and any other discretionary payments, paid to anyone hired by the Construction Manager or paid to any Subcontractor or vendor, unless the Owner has provided prior written approval.
- 3. Expenses of the Concretation Manager's principal office and offices other than the Project Site annee, except as specifically provided in Section 6.1.
- 4. Overhead and general expenses, except as may be expressly included in Section 6.1.
- 5. The Construction Manager's capital expenses, including interest on the Construction Manager's capital employed for the Work.
- 6. Rental costs of machinery and equipment, except as specifically provided in Section 6.1.E.2.
- 7. Costs due to the negligence of the Construction Manager or to the failure of the Construction Manager to fulfill a specific responsibility to the Owner set forth in this Agreement.
- 8. Costs incurred in the performance of Preconstruction Services.

- 9. Except as provided in Section 6.1.F.10, any cost not specifically and expressly described in Section 6.1.
- 10. Costs which would cause the GMP to be exceeded.

#### 6.3 DISCOUNTS, REBATES AND REFUNDS

- A. <u>ACCRUAL TO OWNER</u>. Cash discounts obtained on payments made by the Construction Manager shall accrue to the Owner if (1) before making the payment, the Construction Manager included them in an Application for Payment and received payment therefor from the Owner, or (2) the Owner has deposited funds with the Construction Manager with which to make payments; otherwise, cash discounts shall accrue to the Construction Manager. Trade discounts, rebates, refunds and amounts received from sales of surplus materials and equipment shall accrue to the Owner, and the Construction Manager shall more provisions so that they can be secured.
- B. <u>DEDUCTION FROM COST OF WORK</u>. moveds which accrue to the Owner in accordance with the provisions of Section 6.3 A shall be redited to the Owner as a deduction from the Cost of the Work.
- **6.4 ACCOUNTING RECORDS.** The construction Manager shall keep full and detailed accounts and exercise such controls as may be sees, try for proper financial management, in order to substantiate all costs incurred under this A trainer. The accounting and control systems shall be satisfactory to the Owner. The Owner and the Country's accountants or other Owner-authorized personnel shall be afforded access to the Country to Manager's records, books, correspondence, instructions, drawings, receipts, subcontracts, purchase orders, vouchers, memoranda and all other data relating to this Project, and the Country on Manager shall preserve these for a period of three years after final payment, or for such longer period as may be required by law.

# ARTICLE 7 CONSTRUCTION PHASE

## 7.1 PROGRESS PAYMENTS.

- A. <u>PROGRESS PAYMENTS</u>. Subject to the requirements of Article III of the General Conditions, based upon Applications for Payment submitted to the Architect/Engineer by the Construction Manager and Certificates for Payment issued by the Architect/Engineer, the Owner shall make progress payments on account of the GMP to the Construction Manager as provided below and elsewhere in the Contract Documents.
- B. <u>PERIOD COVERED</u>. The period covered by each Application for Payment shall be one calendar month ending on the last day of the month, or as follows:

(State period to be covered by Applications for Payment.) Remove if not applicable.

- C. <u>DATE OF PAYMENT</u>. Payments shall be made by Owner in accordance with the requirements of Section 218.735, Florida Statutes.
- D. <u>SUPPORTING DOCUMENTATION</u>. With each Application for Payment, the Construction Manager shall submit payrolls, petty cash accounts, receipted invoices or invoices with check vouchers attached and any other evidence required by the Owner or Architect/Engineer to demonstrate that cash disbursements already made by the Construction Manager on account of the Cost of the Work equal or exceed (1) progress payments already received by the Construction Manager; less (2) that portion of those payments attributable to the Construction Manager's Fee; plus (3) payrolls for the period covered by the present Application for Payment.
- E. <u>SCHEDULE OF VALUES</u>. Each Application for Payment shall be based upon the most recent schedule of values submitted by the Construction Manager in accordance with the Contract Documents. The schedule of values shall allocate the entire GMP among the various portions of the Work, except that the Construction Manager's Fee shall be shown as a single separate item. The schedule of values shall be prepared in such forwand supported by such data to substantiate its accuracy as the Architect/Engineer may require. This schedule, unless objected to by the Architect/Engineer, shall be used as a basis for reviewing the Construction Manager's Application for Payment.
- F. Applications for Pay and so I show the percentage completion of each portion of the Work as of the end of the pe to covered by the Application for Payment. The percentage completion shall be the letter of (It the percentage of that portion of the Work which has actually been completed or (2) the precentage obtained by dividing (a) the expense which has actually been incurred by the Construction Manager on account of that portion of the Work for which the Construction Manager has made or intends to make actual payment prior to the next Application for Payment by (b) the stare of the GMP allocated to that portion of the Work in the schedule of values.
- G. <u>CMPUTATION</u>. Subject to other provisions of the Contract Documents, the amount of each progress of ment shall be computed as follows:
  - 1. Take that portion of the GMP properly allocable to completed Work as determined by multiplying the percentage completion of each portion of the Work by the share of the GMP allocated to that portion of the Work in the schedule of values. Pending final determination of cost to the Owner of changes in the Work, amounts not in dispute may be included as provided in Section 5.6 of the General Conditions, even though the GMP has not yet been adjusted by Change Order.
  - 2. Add that portion of the GMP properly allocable to materials and equipment delivered and suitably stored at the Project Site for subsequent incorporation in the Work or, if approved in advance by the Owner, suitably stored off the Project Site at a location agreed upon in writing, supported by paid receipts.

- 3. Add the Construction Manager's Fee, less retainage of five percent (5%). The Construction Manager's Fee shall be computed upon the Cost of the Work described in the two preceding Sections at the rate stated in Section 5.1. or, if the Construction Manager's Fee is stated as a fixed sum in that Section, shall be an amount which bears the same ratio to that fixed-sum Construction Manager's Fee as the Cost of the Work in the two preceding Sections bears to a reasonable estimate of the probable Cost of the Work upon its completion.
- 4. Subtract the aggregate of previous payments made by the Owner.
- 5. Subtract the shortfall, if any, indicated by the Construction Manager in the documentation required by Section 7.1.D to substantiate prior Applications for Payment, or resulting from errors subsequent discovered by the Owner in such documentation.
- 6. Subtract amounts, if any, for which the Archa ct/Engineer has withheld or nullified a Certificate for Payment as provided in Section 3.3.C of the General Conditions.
- H. <u>SUBCONTRACTOR R. TAIN AGE</u>. Except with the Owner's prior approval, payments to Subcontractors shall be succeed to retention of not less than five percent (5%). The Owner and the Construction Mana to shall gree upon a mutually acceptable procedure for review and approval of payments and retention for Subcontracts.
- I. <u>REDUCTION IN ETAMAGE</u>. Notwithstanding the foregoing, upon completion of at least fifty percent (2%) of the Work, as determined by the Architect/Engineer and Owner, the Owner may, with the concurrence of the Architect/Engineer, reduce to two and one-half percent (2.5%) are amount of retainage withheld from the Construction Manager's Fee in each subsequent progress parametris.
- J. <u>NOAP ANCE PAYMENTS</u>. Except with the Owner's prior approval, the Construction Manager shall not make advance payments to suppliers for materials or equipment which have not been delivered and stored at the Project Site.
- K. <u>RELIANCE ON INFORMATION</u>. In taking action on the Construction Manager's Applications for Payment, the Architect/Engineer shall be entitled to rely on the accuracy and completeness of the information furnished by the Construction Manager and shall not be deemed to represent that the Architect/Engineer has made a detailed examination, audit or arithmetic verification of the documentation submitted in accordance with Section 7.1.D or other supporting data, that the Architect/Engineer has made exhaustive or continuous on-site inspections or that the Architect/Engineer has made examinations to ascertain how or for what purposes the Construction Manager has used amounts previously paid on account of the Contract. Such examinations, audits and verifications, if required by the Owner, will be performed by the Owner acting in the sole interest of the Owner.

### 7.2 FINAL PAYMENT.

- A. <u>CONDITIONS OF FINAL PAYMENT</u>. Final payment shall be made by the Owner to the Construction Manager when (1) the Agreement has been fully performed by the Construction Manager except for the Construction Manager's responsibility to correct nonconforming Work, as provided in Section 2.4.C of the General Conditions, and to satisfy other requirements, if any, which necessarily survive final payment; (2) a final Application for Payment and a final accounting for the Cost of the Work have been submitted by the Construction Manager and reviewed by the Owner; and (3) a final Certificate for Payment has then been issued by the Architect/Engineer; such final payment shall be made by the Owner not more than thirty (30) days after the issuance of the Architect/Engineer's final Certificate for Payment, or as follows:
- B. <u>CALCULATION</u>. The amount of the final payment shall be calculated as follows:
  - 1. Take the sum of the Cost of the Work stated by the Construction Manager's final accounting and the Construction Manager's Fee, but not more than the GMP.
  - 2. Subtract amounts, if any, for which the Architect/Engineer withholds, in whole or in part, a final Certificate for Parament as provided in Section 2.4.C of the General Conditions or other providing of the Contract Documents.
  - 3. Subtract the aggregate of privile's payments made by the Owner.

If the aggregate of previous payments made by the Owner exceeds the amount due the Construction Manager, the Construction Manager shall reimburse the difference to the Owner. Failing reimbursement by the Construction Manager and notwithstanding any other provisions of the Contract Document to the constary, Owner shall have the right to bring a direct action in the Circuit Court to recover such Corporate.

- C. REVIEY. The Owner's fiscal staff will review and report in writing on the Construction Manager's final accounting within thirty (30) days after delivery of the final accounting to the Architect/Engineer by the Construction Manager. Based upon such Cost of the Work as the Owner's fiscal staff report to be substantiated by the Construction Manager's final accounting, and provided the other conditions of Section 7.2.A have been met, the Architect/Engineer will, within seven days after receipt of the written report of the Owner's fiscal staff, either issue to the Owner a final Certificate for Payment with a copy to the Construction Manager or notify the Construction Manager and Owner in writing of the Architect/Engineer's reasons for withholding a certificate as provided in Section 3.5.C of the General Conditions.
- D. <u>ISSUANCE</u>. If the Owner's fiscal staff report the Cost of the Work as substantiated by the Construction Manager's final accounting to be less than claimed by the Construction Manager, the Construction Manager shall be entitled to proceed in accordance with Article VIII of the General Conditions without a further decision of the Architect/Engineer. A

demand shall be made by the Construction Manager within fifteen (15) days after the Construction Manager's receipt of a copy of the Architect/Engineer's final Certificate for Payment. Failure to make such demand within this 15-day period shall result in the substantiated amount reported by the Owner's fiscal staff becoming final and binding on the Construction Manager. Pending a final resolution of the disputed amount, the Owner shall pay the Construction Manager the amount certified in the Architect/Engineer's final Certificate for Payment.

E. <u>ADDITIONAL REIMBURSEMENTS</u>. If, after final payment and at the Owner's request, the Construction Manager incurs costs described in Section 6.1 and not excluded by Section 6.2, (1) to correct nonconforming Work or (2) arising from the resolution of disputes, the Owner shall reimburse the Construction Manager such costs and the Construction Manager's Fee, if any, related thereto on the same basis as if such costs had been incurred prior to final payment, but not in excess of the GMP. If the Construction Manager has participated in savings, the amount of such savings shall be recalculated and appropriate credit given to the Owner in determining the net amount to be paid by the Owner to the Construction Manager.

# ARTICLE 8 INSURANCE AND AQNDS

**8.1 INSURANCE.** If and to the extent required by the P. P documents, the Construction Manager shall furnish insurance coverage at (by not necessarily limited to) workers' compensation, commercial general liability, to he dity, excess liability, and builder's risk. The Construction Manager shall furnish to the two er an appropriate policies and Certificate(s) of Insurance.

### 8.2 PAYMENT AND PERFOR ANGE BOND.

- A. BOND RA WELL. The Construction Manager shall post a Payment and Performance Bond in the amount of the GMP, in a form approved by the Owner. In addition, pursuant to Florida Statutes (55. 5(1)(b), Florida Statutes, the Construction Manager shall be responsible and bear an eosts as ociated to record the Payment and Performance Bond with the Manatee County Clerk of the Carcuit Court.
- B. <u>DELIVERY</u>. The Construction Manager shall deliver the required bond to the Owner with the GMP Addendum along with a certified copy of recording.

# ARTICLE 9 MISCELLANEOUS PROVISIONS

- **9.1 DISPUTE RESOLUTION.** During both the Preconstruction and Construction Phases, claims, disputes or other matters in question between the parties to this Agreement shall be resolved as provided in Article VIII of the General Conditions.
- **9.2 OTHER PROVISIONS.** Unless otherwise noted, the terms used in this Agreement shall have the same meaning as those in the General Conditions.

- 9.3 EXTENT OF CONTRACT. This Agreement and the other documents incorporated herein by reference, represents the entire and integrated agreement between the Owner and the Construction Manager and supersedes all prior negotiations, representations or agreements, either written or oral. This Agreement may be amended only by written instrument signed by both the Owner and Construction Manager. Except as provided in Section 9.13 below, if anything in any document incorporated into this Agreement is inconsistent with this Agreement, this Agreement shall govern.
- **9.4 OWNERSHIP AND USE OF DOCUMENTS**. Section 10.4 of the General Conditions shall apply to both the Preconstruction and Construction Phases.
- 9.5 GOVERNING LAW; VENUE. This Agreement shall be governed by the laws of the State of Florida. Venue for any petition for writ of certiorari of other court action allowed by this Agreement shall be in the Circuit Court of the Twelfth Jynicial Circuit in and for Manatee County, Florida.
- 9.6 ASSIGNMENT. The Owner and Construction Manager is Dectively bind themselves, their partners, successors, assigns and legal representatives of the other party hereto and to partners, successors, assigns and legal representatives of successors are under the Constact Documents. Neither party to the Agreement shall assign the Agreement as a whole without write consent of the other. If either party attempts to make such an assignment without such a ment, that party shall nevertheless remain legally responsible for all obligations under the Agreement
- **9.7 SUBSTANTIAL COMPLE NON-DEFINED**. Substantial Completion shall be defined as provided in Article I it in General Conditions. In the event a temporary certificate of occupancy or completion is issue establishing Substantial Completion, the Construction Manager shall diligently pursue the Issuance of a permanent certificate of occupancy or completion.
- 9.8 PROJECT LIEET IGS. During the Construction Phase, there shall be project meetings, at the jobsite or the location acceptable to the parties, on a regularly scheduled basis. The meetings will be attended by a representative of the Construction Manager, Architect/Engineer and Owner. These representatives shall be authorized to make decisions that are not otherwise contrary to the requirements of this Agreement.
- **9.9 WEATHER**. During the Construction Phase, any rainfall, temperatures below 32 degrees Fahrenheit or winds greater than 25 m.p.h. which actually prevents Work on a given day, shall be considered lost time and an additional day added to the Contract Time, provided no work could be done on site, and provided written notice has been submitted to the Owner by the Construction Manager documenting same.
- **9.10 SHOP DRAWINGS; CRITICAL SUBMITTALS**. In consideration of the impact of timely review of submittals and shop drawings on the overall progress of the Work, it is hereby agreed that the Owner shall cause his agents and design professionals to accomplish the review of

any particular "critical" submittals and/or shop drawings and return same to the Construction Manager within fourteen (14) days.

- **9.11 PUNCH LIST**. Within 30 days after obtainment of Substantial Completion, the Owner shall generate a "punch list" of all work items requiring remedial attention by the Construction Manager. Within 5 days thereafter the Architect/Engineer shall assign a fair value to the punch list items, which sum shall be deducted from the next scheduled progress payment to the Construction Manager. Upon satisfactory completion of the punch list items, as certified by the Architect/Engineer, the previously deducted sum shall be paid to the Construction Manager.
- **9.12 CLOSEOUT DOCUMENTATION**. Within 30 days after obtainment of Substantial Completion and before final payment, Construction Manager shall gather and deliver to Owner all warranty documentation, all manufacturer's product and warranty literature, all manuals (including parts and technical manuals), all schematics and handbacks, and all as-built drawings.
- 9.13 GOVERNING PROVISIONS; CONFLICTS. It the event of a conflict between this Agreement and the Specifications or as between the specifications, the Specifications shall govern.
- 9.14 E-VERIFY. The Construction Manager's employment of unauthorized aliens is a violation of Section 274(e) of the Federal Immigration and Employment Act. The Construction Manager shall utilize the U.S. Department of Holo and Security E-Verify system to verify the employment eligibility of all new employees hard during the term of this Agreement, and shall require the same verification procedure of all subcentractors.
- **9.15 INDEPENDENT CONTRACTOR.** The Construction Manager acknowledges that it is functioning as an independ in a tractor in performing under the terms of this Agreement, and it is not acting as an employer of the owner.
- 9.16 WAIVE S. Note that Agreement nor any portion of it may be modified or waived orally. However, each party (through its governing body or properly authorized officer) shall have the right, but not the obligation, to waive, on a case-by-case basis, any right or condition herein reserved or intended for the benefit or protection of such party without being deemed or considered to have waived such right or condition for any other case, situation, or circumstance and without being deemed or considered to have waived any other right or condition. No such waiver shall be effective unless made in writing with an express and specific statement of the intent of such governing body or officer to provide such waiver.
- **9.17 VALIDITY**. Each of the Owner and Construction Manager represents and warrants to the other its respective authority to enter into this Agreement.
- **9.18 COVENANT TO DEFEND**. Neither the validity of this Agreement nor the validity of any portion hereof may be challenged by any party hereto, and each party hereto hereby waives any right to initiate any such challenge. Furthermore, if this Agreement or any portion hereof is challenged by a third party in any judicial, administrative, or appellate proceeding (each party

hereby covenanting with the other party not to initiate, encourage, foster, promote, cooperate with, or acquiesce to such challenge), the parties hereto collectively and individually agree, at their individual sole cost and expense, to defend in good faith its validity through a final judicial determination or other resolution, unless all parties mutually agree in writing not to defend such challenge or not to appeal any decision invalidating this Agreement or any portion thereof.

- **9.19 DISCLAIMER OF THIRD PARTY BENEFICIARIES; SUCCESSORS AND ASSIGNS.** This Agreement is solely for the benefit of the parties hereto, and no right, privilege, or cause of action shall by reason hereof accrue upon, to, or for the benefit of any third party. Nothing in this Agreement is intended or shall be construed to confer upon or give any person, corporation, partnership, trust, private entity, agency, or other governmental entity any right, privilege, remedy, or claim under or by reason of this Agreement or any provisions or conditions hereof. This Agreement shall be binding upon, and its benefits and advantages shall inure to, the successors and assigns of the parties hereto.
- 9.20 HEADINGS AND CAPTIONS. The headings and arrions of articles, sections, and paragraphs used this Agreement are for convenience of reference only and are not intended to define or limit their contents, nor are they to affect the construction of or be taken into consideration in interpreting this Agreement.
- 9.21 LEGAL REFERENCES. All reference to statutory sections or chapters shall be construed to include subsequent amendment to an provisions, and to refer to the successor provision of any such provision. References a "applicable law" and "general law" shall be construed to include provisions of local state and orderal law, whether established by legislative action, administrative rule or regulation of the lad decision.
- 9.22 SEVERABILITY In providing of this Agreement are declared by the parties hereto to be severable. In the event by team or provision of this Agreement shall be held invalid by a court of competer jurisdiction, such invalid term or provision should not affect the validity of any other term or provision area, and all such terms and provisions hereof shall be enforceable to the fullest extent permitted by law as if such invalid term or provision had never been part of this Agreement; provided, however, if any term or provision of this Agreement is held to be invalid due to the scope or extent thereof, then, to the extent permitted by law, such term or provision shall be automatically deemed modified in order that it may be enforced to the maximum scope and extent permitted by law.
- **9.23 ATTORNEY'S FEES AND COSTS**. In any claim dispute procedure or litigation arising from this Agreement, each party hereto shall be solely responsible for paying its attorney's fees and costs regardless of the outcome of any such procedure or litigation.
- **9.24 NOTICES**. All notices, comments, consents, objections, approvals, waivers, and elections under this Agreement shall be in writing and shall be given only by hand delivery for which a receipt is obtained, or certified mail, prepaid with confirmation of delivery requested, or by electronic mail with delivery confirmation. All such communications shall be addressed to the

applicable addressees set forth below or as any party may otherwise designate in the manner prescribed herein.

- 9.25 PUBLIC RECORDS LAW. It's Construction Manager shall comply with the Florida Public Records Act (Chapter 119, Florida Natutes), and shall:
  - A. Keep and maintain public records required by the Owner to perform the services called for in 118 A reement.
  - B. Upo request from the Owner's custodian of public records, provide the Owner will a confer the requested records or allow the records to be inspected or copies within reasonable time at a cost that does not exceed the cost provided in Chapter 1.9, Florida Statutes or as otherwise provided by law.
  - C. Ensure that public records that are exempt or confidential and exempt from public records disclosure requirements are not disclosed except as authorized by law for the duration of this Agreement and following completion of this Agreement if the Construction Manager does not transfer the records to the Owner.
  - D. Upon completion of this Agreement, transfer, at no cost, to the Owner all public records in possession of the Construction Manager or keep and maintain such public records. If the Construction Manager transfers all public records to the Owner upon completion of the Agreement, the Construction Manager shall destroy any duplicate public records that are exempt or confidential and exempt

from public records disclosure requirements. If the Construction Manager keeps and maintains public records upon completion of the Agreement, the Construction Manager shall meet all applicable requirements for retaining public records. All records stored electronically must be provided to the Owner, upon request from the Owner's custodian of public records, in a format that is compatible with the information technology systems of the Owner.

### ARTICLE 10 TERMINATION OR SUPENSION

# 10.1 TERMINATION PRIOR TO ESTABLE SHIP ST GUARANTEED MAXIMUM PRICE.

- A. <u>RIGHT OF TERMINAL ON</u>. Prior to execution by both parties of the GMP Addendum, the Owner may terminate this Agreement at any time without or without cause pursuant to Sections 14.1 and 14.2 of the General Conditions, and the Construction Manager may terminate this Agreement for any of the reasons described in Section 14.6 of the General Conditions.
- B. OMPENS TION FOR PRECONSTRUCTION SERVICES. If the Owner or Construction Modage te minates this Contract pursuant to this Section 10.1 prior to commencement of the Construction Phase, the Construction Manager shall be equitably compensated for Preconstation on Services performed prior to receipt of notice of termination; provided, however, that the compensation for such services shall not exceed the compensation set forth in Section 4.1.A.
- C. <u>ADDITIONAL COMPENSATION FOR CONSTRUCTION SERVICES</u>. If the Owner or Construction Manager terminates this Agreement pursuant to this Section 10.1 after commencement of the Construction Phase, the Construction Manager shall, in addition to the compensation provided in Section 10.1.B, be paid an amount calculated as follows:
  - 1. Take the Cost of the Work incurred by the Construction Manager.
  - 2. Add the Construction Manager's Fee computed upon the Cost of the Work to the date of termination at the rate stated in Section 5.1 or, of the Construction Manager's Fee is stated as a fixed sum in that Section, an amount which bears

the same ratio to that fixed-sum Fee as to Cost of the Work at the time of termination bears to a reasonable estimate of the probable Cost of the Work upon its completion.

3. Subtract the aggregate of previous payments made by the Owner on account of the Construction Phase.

The Owner shall also pay the Construction Manager fair compensation, either by purchase or rental at the election of the Owner, for any equipment owned by the Construction Manager which the Owner elects to retain and which is not otherwise included in the Cost of the Work under Section 10.1.C.1. To the extent that the Owner elects to take legal assignment of Subcontracts and purchase orders (including rental agreements), the Construction Manager shall as a condition of receiving the payments referred to in this Article 10, execute and deliver all such papers and take all such steps, including the legal assignment of such Subcontracts and other contractual rights of the Construction Manager, as the Owner may require for the purpose of Sully vesting in the Owner the rights and benefits of the Construction Manager under such whe intracts or purchase orders.

Subcontracts, purchase orders and rental agreements extered into by the Construction Manager with the Owner's written approval prior to the execution of the CMP Addendum shall contain provisions permitting assignment to the Owner of described by ve. If the Owner accepts such assignment, the Owner shall reimburse or indentify the Construction Manager with respect to all costs arising under the Subcontract, purchase order or rental agreement except those which would not have been reimbursable as Cost of the Work if the contract had not been terminated. If the Owner elects not to accept the assignment of any subcontract, purchase order or rental agreement which would have constituted a Cost of the Work had this Agreement not been terminated, the Construction Manager shall terminate substituted, purchase order or rental agreement and the Owner shall pay the Construction Manager the costs necessarily incurred by the Construction Manager by reason of such termination.

- 10.2 TERM NATION ACTER ESTABLISHING GUARANTEED MAXIMUM PRICE. After execution by 15th parties of the GMP Addendum, the Agreement may be terminated as provided in Article 14 of the General Conditions.
- A. <u>LIMITATION ON PAYMENT; TERMINATION BY OWNER</u>. In the event of such termination by the Owner, the amount payable to the Construction Manager pursuant to Section 14.2 of the General Conditions shall not exceed the amount the Construction Manager would have been entitled to receive pursuant to Sections 10.1.B and 10.1.C of this Agreement.
- B. <u>LIMITATION ON PAYMENT; TERMINATION BY CONSTRUCTION MANAGER</u>. In the event of such termination by the Construction Manager, the amount to be paid to the Construction Manager under Section 14.6 of the General Conditions shall not exceed the amount the Construction Manager would have been entitled to receive pursuant to Sections 10.1.B and 10.1.C above, except that the Construction Manager's Fee shall be calculated as if the Work had been fully completed by the Construction Manager, including a reasonable estimate of the Cost of the Work for Work not actually completed.

**10.3 SUSPENSION.** The Work may be suspended by the Owner as provided in Section 14.3 of the General Conditions. In such case, the term "Contract Sum" in that Section shall be understood to mean Cost of the Work.

#### **GENERAL CONDITIONS**

#### ARTICLE I

#### **DEFINITIONS**

- **1.1 Definitions.** For purposes of the Contract Documents, the following terms shall have the following meanings.
- A. <u>Acceptance:</u> The acceptance of the Project into the Owner's operating public infrastructure.
- B. <u>Application for Payment:</u> The form approved and accepted by the Owner, which is to be used by Contractor in requesting progress payments or final payment and which is to include such supporting documentation as is required by the Contact Documents.
- C. <u>Architect/Engineer:</u> , a corporation or limited liability company, registered and licenset of do braness in the State of Florida, OR \_\_\_\_\_\_, an employee of Owner.
- D. <u>Change Order</u>: A writer ofter signed by the Owner, the Architect/Engineer and the Contractor authorizing change in the Project Plans and/or Specifications and, if necessary, a corresponding discument in the Contract Sum and/or Contract Time, pursuant to Article V.
- E. <u>Construction Societies</u>: The Construction Services to be provided by Contractor pursuant to Section 2.4, in a sorous with the terms and provisions of the Contract Documents.
- F. <u>Contruction</u> Team: The working team established pursuant to Section 2.1.B.
- G. <u>Contract Jum</u>: The total compensation to be paid to the Contractor for Construction Services rendered pursuant to the Contract Documents, as set forth in Contractor's Bid (or Guaranteed Maximum Price Addendum), unless adjusted in accordance with the terms of the Contract Documents
- H. <u>Contract Time</u>: The time period during which all Construction Services are to be completed pursuant to the Contract Documents, to be set forth in the Project Schedule.
- I. <u>Contractor's Personnel</u>: The Contractor's key personnel designated by Contractor.
- J. <u>Days</u>: Calendar days except when specified differently. When time is referred to in the Contract Documents by days, it will be computed to exclude the first and include the last day of such period. If the last day of any such period falls on a Saturday or Sunday or legal holiday, such day will be omitted from the computation.
- K. <u>Defective</u>: When modifying the term "Work", referring to Work that is unsatisfactory, faulty or deficient, or does not conform to the Contract Documents, or that does

not meet the requirements of any inspection, reference standard, test or approval referred to in the Contract Documents, or that has been damaged prior to Owner's approval of final payment (unless responsibility for the protection thereof has been assumed by Owner).

- L. <u>Field Directive</u>: A written order issued by Owner which orders minor changes in the Work not involving a change in Contract Time, to be paid from the Owner's contingency funds.
- M. <u>Final Completion Date</u>: The date upon which the Project is fully constructed and all Work required on the Project and Project Site is fully performed as verified in writing by the Owner.
- N. <u>Float Time</u>: The time available in the Project Schedule during which an unexpected activity can be completed without delaying Substantial Completion of the Work.
- O. <u>Force Majeure</u>: Those conditions constituting excuse from performance as described in and subject to the conditions described in Article 41.
- P. <u>Notice to Proceed</u>: Written notice by Owner (after execution of Contract) to Contractor fixing the date on which the Contractor shall start to perform the Work.
  - Q. Owner: Manatee Cot x a pairtical subdivision of the State of Florida.
- R. Owner's Project Sepres ntake: The individual designated by Owner to perform those functions set forth in Section X2
- S. <u>Payment and A Symance Bond</u>: The Payment and Performance Bond security posted pursuant to Section 2.4.Y to guarantee payment and performance by the Contractor of its obligations here ader.
- T. <u>Permittin Authority</u>: Any applicable governmental authority acting in its governmental and regulate apacity which is required to issue or grant any permit, certificate, license or other approval which is required as a condition precedent to the commencement or approved of the Work, or any part thereof, including the building permit.
- U. <u>Procurement Ordinance</u>: The Manatee County Procurement Code, Chapter 2-26 of the Manatee County Code of Laws, as amended from time to time.
- V. <u>Progress Report</u>: A report to Owner that includes all information required pursuant to the Contract Documents and submitted in accordance with Section 2.4.EE, hereof.
- W. <u>Project</u>: The total construction of which the Work performed under the Contract Documents may be the whole or a part and which may include construction by Owner and by separate contractors. For the purposes of the Contract Documents, the term Project shall include all areas of proposed improvements and all areas which may reasonably be judged to have an impact on the Project.

- X. <u>Project Costs</u>: The costs incurred by the Contractor to plan, construct and equip the Project and included within, and paid as a component of, the Contract Sum.
- Y. <u>Project Manager</u>: Subject to the prior written consent of Owner, the individual designated to receive notices on behalf of the Contractor, or such other individual designated by the Contractor, from time to time, pursuant to written notice in accordance with the Contract Documents.
- Z. <u>Project Plans and Specifications</u>: The one hundred percent (100%) construction drawings and specifications prepared by the Architect/Engineer, and any changes, supplements, amendments or additions thereto approved by the Owner, which shall also include any construction drawings and final specifications required for the repair or construction of the Project, as provided herein.
- AA. <u>Project Schedule</u>: The schedule and sequence of events for the commencement, progression and completion of the Project, developed pursuant to Section 2.3., as such schedule may be amended as provided herein.
- BB. <u>Project Site</u>: The site depicted in the Project Plans and Specifications, inclusive of all rights of way, temporary construction extenents or hiersed or leased sovereign lands.
- CC. <u>Subcontractor</u>: Any individual (other than a direct employee of the Contractor) or organization retained by Contactor to blan, construct or equip the Project pursuant to Article IV.
- DD. <u>Substantial Completes and Substantially Complete</u>: The stage in the progress of the Work when the Work or resignated portion thereof is sufficiently complete in accordance with the Contract Decumes so that the Owner can occupy or utilize the Work for its intended use; provided, however that as a condition precedent to Substantial Completion, the Owner has received at certificate of occupancy or completion and other permits, approvals, licenses, and other decuments fold any governmental authority which are necessary for the beneficial occupancy of the Project or any designated portion thereof.
- EE. <u>Substantial Completion Date</u>: The date on which the Project or designated portion thereof is deemed to be Substantially Complete, as evidenced by receipt of (i) the Architect/Engineer's certificate of Substantial Completion, (ii) written Acceptance of the Project by the Owner, and (iii) approvals of any other authority as may be necessary or otherwise required.
- FF. <u>Substitute</u>: Materials or equipment offered by the Contractor as an alternative to that set forth in the Project Plans and Specifications, where (i) the Project Plans and Specifications do not authorize an "approved equal", or (ii) the Owner, in its reasonable discretion, determines that a pre-authorized "approved equal" will result in a substantial change to the Work because of cost, quality or other difference in comparison to the materials or equipment specified.
  - GG. <u>Unit Price Work</u>: Work to be paid for on the basis of unit prices.
- HH. Work: The term "Work" means the construction and services required by the Contract Documents, whether completed or partially completed, and includes all labor,

materials, equipment and services provided or to be provided by the Contractor to fulfill the Contractor's obligations. The Work may constitute the whole or a part of the Project.

II. <u>Work Directive Change</u>: A written directive to Contractor, issued on or after the effective date of the Agreement pursuant to Section 5.8 and signed by Owner's Project Representative, ordering an addition, deletion or revision in the Work, or responding to differing or unforeseen physical conditions under which the Work is to be performed or responding to emergencies.

#### **ARTICLE II**

#### RELATIONSHIP AND RESPONSIBILITIES

- 2.1 Relationship between Contractor and Owne. The Contractor accepts the relationship of trust and confidence established with Owner persuary to the Contract Documents. The Contractor shall furnish its best skill and judgment and contract with Owner and Owner's Project Representative in furthering the interests of the Owner. The Contractor agrees to provide the professional services required to complete the Project confistent with the Owner's direction and the terms of the Contract Documents. All services produce the under by Contractor, either directly or through Subcontractors, shall be provided in a cordar ce with sound construction practices and applicable professional construction standards.
- A. <u>Purpose</u>. The purpose of the Contract Documents is to provide for the provision of construction services it the Project on the Project Site by the Contractor, and construction of the Project by the Contract in accordance with the Project Plans and Specifications. The further place of the Contract Documents is to define and delineate the responsibilities and obligations of the Contract Documents and to express the desire of all such parties to conserate accomplish the purposes and expectations of the Contract Documents.
- B. Construct on Team. The Contractor, Owner and Architect/Engineer shall be called the "Construction Team" and shall work together as a team commencing upon full execution of the Contract Documents through Substantial Completion. As provided in Section 2.2, the Contractor and Architect/Engineer shall work jointly through completion and shall be available thereafter should additional services be required. The Contractor shall provide leadership to the Construction Team on all matters relating to construction. The Contractor understands, acknowledges and agrees that the Architect/Engineer shall provide leadership to the Construction Team on all matters relating to design.
- C. <u>Owner's Reliance on Bid (or Guaranteed Maximum Price Addendum)</u>. The Contractor acknowledges that the representations, statements, information and pricing contained in its Bid (or Guaranteed Maximum Price Addendum) have been relied upon by the Owner and have resulted in the award of this Project to the Contractor.
- **2.2 General Contractor Responsibilities.** In addition to the other responsibilities set forth herein, the Contractor shall have the following responsibilities pursuant to the Contract Documents:

- A. <u>Personnel</u>. The Contractor represents that it has secured, or shall secure, all personnel necessary to perform the Work, none of whom shall be employees of the Owner. Primary liaison between the Contractor and the Owner shall be through the Owner's Project Representative and Contractor's Project Manager. All of the services required herein shall be performed by the Contractor or under the Contractor's supervision, and all personnel engaged in the Work shall be fully qualified and shall be authorized or permitted under law to perform such services.
- B. <u>Cooperation with Architect/Engineer</u>. The Contractor's services shall be provided in conjunction with the services of the Architect/Engineer. In the performance of professional services, the Contractor acknowledges that time is critical for Project delivery. The Contractor acknowledges that timely construction utilizing the services of an Architect/Engineer and a Contractor requires maximum cooperation between all parties.
- C. <u>Timely Performance</u>. The Contractor hall perform all services as expeditiously as is consistent with professional skill and care are the orderly progress of the Work, in accordance with the Project Schedule. Verification of estimate Thoject Schedule goals will be made as requested by the Owner.
- D. <u>Duty to Defend Work</u>. In the cent Cany dispute between the Owner and any Permitting Authority that relates to the quality, completen corprofessional workmanship of the Contractor's services or Work, the Contractor hall at its sole cost and expense, cooperate with the Owner to defend the quality and workman hip to the Contractor's services and Work.
- E. Trade and Induces Term inology. It is the intent of the Contract Documents to describe a functionally complete Project (a tart thereof) to be constructed in accordance with the Contract Documents. Any Work, materials of equipment that may reasonably be inferred from the Contract Documents as being required to produce the intended result will be supplied whether or not specifically called for. When words which have a well-known technical or trade meaning are used to describe Work, materials, or equipment, such words shall be interpreted in accordance with that meaning. Reference to tandard specifications, manuals or codes of any technical society, organization or association, or to the laws or regulations of any governmental authority, whether such reference be specificated, implication, shall mean the latest standard specification, manual, code or laws or regulations in effect at the time of opening of Bids (or at the time of execution of the Guaranteed Maximum Price Addendum), except as may be otherwise specifically stated. However, no provision of any referenced standard specification, manual or code (whether or not specifically incorporated by reference in the Contract Documents) shall be effective to change the duties and responsibilities of Owner or Contractor, or any of their agents or employees from those set forth in the Contract Documents. Computed dimensions shall govern over scaled dimensions.
- 2.3 Project Schedule. The Contractor, within ten (10) days after being awarded the Agreement, shall prepare and submit for the Owner's and Architect/Engineer's information a Contractor's construction schedule for the Work. The schedule shall not exceed time limits current under the Contract Documents, shall be revised at appropriate intervals as required by the conditions of the Work and Project, shall be related to the entire Project to the extent required by the Contract Documents, and shall provide for expeditious and practicable execution of Work.

- A. The Project Schedule shall show a breakdown of all tasks to be performed, and their relationship in achieving the completion of each phase of Work, subject to review of Owner and Architect/Engineer and approval or rejection by Owner. The Project Schedule shall show, at a minimum, the approximate dates on which each segment of the Work is expected to be started and finished, the proposed traffic flows during each month, the anticipated earnings by the Contractor for each month and the approximate number of crews and equipment to be used. The Project Schedule shall include all phases of procurement, approval of shop drawings, proposed Change Orders in progress, schedules for Change Orders, and performance testing requirements. The Project Schedule shall include a construction commencement date and Project Substantial Completion Date, which dates shall accommodate known or reasonably anticipated geographic, atmospheric and weather conditions.
- B. The Project Schedule shall serve as the framework for the subsequent development of all detailed schedules. The Project Schedule shall be used to verify Contractor performance and to allow a Own is Project Representative to monitor the Contractor's efforts.
- C. The Project Schedule may be adjusted by the Contractor pursuant to Article V. The Owner shall have the right to the ble Work provided such rescheduling is in accord with the remainder of terms of a Contract Documents.
- re a submittal schedule, promptly after being D. The Contractor shall p awarded the Agreement there fter as necessary to maintain a current and si ll submittal sched submit the schedule(s) Architect/Engineer's The Architect/Engineer's approval shall not be lelayed withheld. The submittal schedule shall (1) be unreasonabl Contractor's construction schedule, and (2) allow the coordinated reasonable time to review submittals. If the Contractor fails Architect/Engi nittal schedule, the Contractor shall not be entitled to any ntact Sum or extension of Contract Time based on the time required for r view of submittals.
- E. The Contractor shall perform the Work in general accordance with the most recent schedules submitted to the Owner and Architect/Engineer.

# **2.4 Construction Services.** The Contractor shall provide the following Construction Services:

A. <u>Construction of Project</u>. The Contractor shall work from the receipt of a Notice to Proceed through the Substantial Completion of the Project in accordance with the terms of the Contract Documents to manage the construction of the Project. The Construction Services provided by the Contractor to construct the Project shall include without limitation (1) all services necessary and commensurate with established construction standards, and (2) all services described in the Invitation for Bid (or Request for Proposal) and the Bid (or Guaranteed Maximum Price Addendum).

- B. <u>Notice to Proceed</u>. A Notice to Proceed may be given at any time within thirty (30) days after the effective date of the Agreement. Contractor shall start to perform the Work on the date specified in the Notice to Proceed, but no Work shall be done at the site prior to the issuance of the Notice to Proceed.
- C. Quality of Work. If at any time the labor used or to be used appears to the Owner as insufficient or improper for securing the quality of Work required or the required rate of progress, the Owner may order the Contractor to increase its efficiency or to improve the character of its Work, and the Contractor shall conform to such an order. Any such order shall not entitle Contractor to any additional compensation or any increase in Contract Time. The failure of the Owner to demand any increase of such efficiency or any improvement shall not release the Contractor from its obligation to secure the quality of Work or the rate of progress necessary to complete the Work within the limits imposed by the Contract Documents. The Owner may require the Contractor to remove such personnel as the Owner deems incompetent, careless, insubordinate or otherwise objectionable, or whose continued employment on the Project is deemed to be contrary to the Owner's interest. The Contractor shall provide good quality workmanship and shall promptly correct construction defects without additional tomper sation. Acceptance of the Work by the Owner shall not relieve the Contractor of the responsible any construction defects.
- D. <u>Materials</u>. All materials and equipment shall be of good quality and new, except as otherwise provided in the Contract Jocuments. Exequired by Architect/Engineer, Contractor shall furnish satisfactory evidence (in luck g reports of required tests) as to the kind and quality of materials and equipment. Also atends and equipment shall be applied, installed, connected, erected, used, cleaned and conditioned in accordance with the instruction of the applicable supplier except as otherwise royidal in the Contract Documents.
- E. Account city for work. The Contractor shall be solely accountable for its Work, including plans review an contract submittals. The Contractor shall be solely responsible for means, methods, techniques, explences and procedures of construction. If a specific means, method, technique, secure or procedure of construction is required by the Contract Documents, the Contractor may tilize an alternative means, method, technique, sequence or procedure acceptable to the Architect/Engineer if the Contractor submits sufficient information to allow the Architect/Engineer to detect that the alternative is equivalent to that required by the Contract Documents.
- F. <u>Contract Sum.</u> The Contractor shall construct the Project so that the Project can be built for a cost not to exceed the Contract Sum.
- G. <u>Governing Specifications</u>. In the absence of specified Owner design standards or guidelines, the Architect/Engineer shall use, and the Contractor shall comply with, the most recent version of the applicable FDOT or AASHTO design standards. In general, the Project shall be constructed by the Contractor in accordance with applicable industry standards. The Contractor shall be responsible for utilizing and maintaining current knowledge of any laws, ordinances, codes, rules, regulations, standards, guidelines, special conditions, specifications or other mandates relevant to the Project or the services to be performed.

- H. <u>Adherence to Project Schedule</u>. The development and equipping of the Project shall be undertaken and completed in accordance with the Project Schedule, and within the Contract Time described therein.
- I. <u>Superintendent</u>. The Contractor shall employ a competent superintendent and necessary assistants who shall be in attendance at the Project Site during performance of the Work. The superintendent shall represent the Contractor, and communications given to the superintendent shall be as binding as if given to the Contractor.
- (1) The Contractor, as soon as practicable after award of the Agreement, shall furnish in writing to the Owner through the Architect/Engineer the name and qualifications of the proposed superintendent. The Architect/Engineer may reply within 14 days to the Contractor in writing stating (1) whether the Owner or the Architect/Engineer has reasonable objection to the proposed superintendent or (2) that the Architect/Engineer requires additional time to review. Failure of the Architect/Engineer to reply within 14 days shall constitute notice of no reasonable objection.
- (2) The Contractor shall not employ a propose superictendent to whom the Owner or Architect/Engineer has made reasonable and timely object on the Contractor shall not change the superintendent without the Owner's consent, which shall not be unreasonably withheld or delayed.
- J. Work Hours. Contractor shall provide competent, suitable qualified personnel to survey and lay out the Work are personnel to construction as required by the Contract Documents. Contractor shall at all times maintan good discipline and order at the site. Except in connection with the safety or protection of persons of the Work or property at the site or adjacent thereto and except as otherwise indicated in a Contract Documents, all Work at the site shall be performed during regular work as hours, and Contractor shall not permit overtime work or the performance of Work on a Saturday anday or legal holiday without Owner's written consent given after prior notice to Archite transpineer (at least seventy-two (72) hours in advance).
- K. Over the Redted Costs. Contractor shall pay for all additional Architect/Engineer charges, insection costs and Owner staff time for any overtime work which may be authorized. Such cational charges shall be an obligation of Contractor and no extra payment shall be made by Owner because such overtime work. At Owner's option, such overtime costs may be deducted from Contractor's monthly payment request or Contractor's retainage prior to release of final payment. Contractor's obligation to pay all overtime-related costs shall not apply if Contractor is directed by Owner to work overtime solely for Owner's convenience.
- L. <u>Insurance, Overhead and Utilities</u>. Unless otherwise specified, Contractor shall furnish and assume full responsibility for all bonds, insurance, materials, equipment, labor, transportation, construction equipment and machinery, tools, appliances, fuel, power, light, heat, telephone, water, sanitary facilities, temporary facilities and all other facilities and incidentals necessary for the furnishing, performance, testing, start-up and completion of the Work.
- M. <u>Cleanliness</u>. The Contractor shall keep the premises and surrounding area free from accumulation of waste materials or rubbish caused by operations under the Contract. At completion of the Work, the Contractor shall remove waste materials, rubbish, the Contractor's tools, construction equipment, machinery and surplus materials from and about the Project Site.

Contractor shall restore to original conditions all property not designated for alteration by the Contract Documents If the Contractor fails to clean up as provided in the Contract Documents, the Owner may do so and Owner shall be entitled to reimbursement from Contractor.

- N. <u>Loading</u>. Contractor shall not load nor permit any part of any structure to be loaded in any manner that will endanger the structure, nor shall Contractor subject any part of the Work or adjacent property to stresses or pressures that will endanger it.
- O. <u>Safety and Protection</u>. Contractor shall comply with all applicable federal, state and local safety regulations. Contractor shall be responsible for initiating, maintaining and supervising all safety precautions and programs in connection with the Work. Contractor shall take all necessary precautions for the safety of and shall provide the necessary protection to prevent damage, injury or loss to:
  - (1) All employees on the Work and other persons and organizations who may be affected thereby;
  - (2) All the Work and materials and equipment to be incorporated therein, whether in storage on or off the Project Site; and
  - (3) Other property at the Project lite is adjustent thereto, including trees, shrubs, lawns, walks, ravements, recoways, structures, utilities and underground facilities but resignated for removal, relocation or replacement during construct a.

Contractor shall comply with all approache two ond regulations of any public body having jurisdiction for the safety of persons of rop, it or to protect them from damage, injury or loss, and shall erect and maintain all passage ways, guard fences, lights and other facilities for the protection required by public automaty or local conditions. Contractor shall provide reasonable maintenance of traffiction the public and preservation of the Owner's business, taking into full consideration all local conditions. Contractor's duties and responsibilities for safety and protection with regard to the Work shall continue until such time as all the Work is completed.

- P. <u>Emergencies</u>. In emergencies affecting the safety or protection of persons or the Work or property at the Project Site or adjacent thereto, Contractor, without special instruction or authorization from Architect/Engineer or Owner, shall act to prevent threatened damage, injury or loss. Contractor shall give Owner prompt written notice if Contractor believes that any significant changes in the Work or variations from the Contract Documents have been caused thereby. If Owner determines that a change in the Project is required because of the action taken in response to an emergency, a Work Directive Change or Change Order will be issued to document the consequences of the changes or variation.
- Q. <u>Substitutes</u>. For Substitutes not included with the Bid (or Guaranteed Maximum Price Addendum), but submitted after the effective date of the Agreement (or Guaranteed Maximum Price Addendum), Contractor shall make written application to Architect/Engineer for acceptance thereof, certifying that the proposed Substitute will perform adequately the functions and achieve the results called for by the general design, be similar and of equal substance to that specified and be suited to the same use as that specified. The application

will also contain an itemized estimate of all costs and delays or schedule impacts that will result directly or indirectly from review, acceptance and provision of such Substitute, including costs of redesign and claims of other contractors affected by the resulting change, all of which will be considered by the Architect/Engineer in evaluating the proposed Substitute. Architect/Engineer may require Contractor to furnish at Contractor's expense, additional data about the proposed Substitute. In rendering a decision, Owner, Architect/Engineer and Contractor shall have access to any available Float Time in the Project Schedule. If Substitute materials or equipment not included as part of the Bid (or Guaranteed Maximum Price Addendum), but proposed after the effective date of the Agreement, are accepted and are less costly than the originally specified materials or equipment, then the net difference in cost shall be credited to the Owner and an appropriate Change Order executed to adjust the Contract Sum.

- (1) Architect/Engineer will be allowed a reasonable time within which to evaluate each proposed Substitute. Architect/Engineer will be the sole judge of acceptability and no Substitute will be ordered, installed or utilized without Architect/Engineer's prior writt a acceptance which will be evidenced by either a Change Order or a approved shop drawing. Owner may require Contractor to furnish at paractors expense a special performance guarantee or other surety with respect to any Substitute.
- (2) Contractor shall reimburse O. I. for he charges of Architect/Engineer and Architect/Engineer's Consultants for exclusing each proposed Substitute submitted after the effective date of the Agreement and all costs resulting from any delays in the York shile the Substitute was undergoing review.
- R. Surveys and States. The Contractor shall furnish, as part of the Contract Sum, all labor, stakes, surveys, batter coards to structures, grade lines and other materials and supplies and shall set constructors stakes and batter boards for establishing lines, position of structures, slopes and other concolling using necessary for the proper prosecution of the Work. Where rights-of-way, easements, or perty lines or any other conditions which make the lay-out of the Project or parts of the Project witical are involved, the Contractor shall employ a competent surveyor who is registered to the State of Florida for lay-out and staking. These stakes and marks shall constitute the field control by and in accord with which the Contractor shall govern and execute the Work. The Contactor shall be held responsible for the preservation of all stakes and marks and if for any reason any of the stakes or marks or batter boards become destroyed or disturbed, they shall be immediately and accurately replaced by the Contractor.
- S. <u>Suitability of Project Site</u>. The Contractor has, by careful examination, satisfied itself as to the nature and location of the Work and all other matters which can in any way affect the Work, including, but not limited to details pertaining to borings, as shown on the drawings. Such boring information is not guaranteed to be more than a general indication of the materials likely to be found adjacent to holes bored at the Project Site, approximately at the locations indicated. The Contractor has examined boring data, where available, made its own interpretation of the subsurface conditions and other preliminary data, and has based its Bid (or Guaranteed Maximum Price Addendum) on its own opinion of the conditions likely to be encountered. Except as specifically provided in Sections 2.4.U., 5.4 and 5.5, no extra compensation or extension of time will be considered for any Project Site conditions that existed at the time of bidding (or at the time of execution of the Guaranteed Maximum Price Addendum). No verbal agreement or conversation with any officer, agent or employee of the Owner, before or

after the execution of the Agreement, shall affect or modify any of the terms or obligations herein contained.

- T. <u>Project Specification Errors</u>. If the Contractor, during the Work, finds that the drawings, specifications or other Contract Documents cannot be followed, the Contractor shall immediately inform the Owner in writing, and the Owner shall promptly check the accuracy of the information. Any Work done after such discovery, until any necessary changes are authorized, will be done at the Contractor's sole risk of non-payment and delay.
- U. Remediation of Contamination. Owner and Contractor recognize that remediation of subsurface conditions may be necessary due to potential hazardous materials contamination. Because the presence or extent of any contamination is not known, Contractor shall include no cost in the Contract Sum, and no time in the Project Schedule, for cost or delays that might result from any necessary remediation. The Project Schedule will provide a period of time between demolition activities and the start of the next activity to commence any remediation if needed. Contractor shall use all reasonable efforts in schedul ag the Project to minimize the likelihood that remediation delays construction. Any hazar ous practicals remediation Work which Contractor agrees to perform shall be done pursuant to change Order or amendment consistent with the following:
  - (1) The dates of Substantial Coap, tion hall 12 equitably adjusted based on delays, if any, incurred inconnection will remediation efforts.
  - cons ctors which have mobilized on the Project (2) Contractor, and any de onstated costs of overhead operations at the Site, shall be paid for any period of delay of more than seven (7) days, except Project Site du to the extent the proceeds concurrently with remediation. The fcosts to be reimbursed are limited to those reasonably incurred the delay period (such as trailers or offices, telephones, at the job. like); equipment dedicated to the Project and located at the salaries and associated costs of personnel dedicated to the to he extent that they do not perform work on other projects; and te costs that are reasonable and which are incurred during the dela find. Subcontractors and suppliers which have not mobilized are limited to the costs set forth in Section 2.4.U(3).
  - (3) Contractor and any Subcontractor or supplier on the Project who is eligible for compensation shall be paid any demonstrated costs of escalation in materials or labor, and reasonable costs of off-site storage of materials identified to the Project, arising because of any delay of more than seven (7) days. Such Contractor, Subcontractors and suppliers are obligated to take all reasonable steps to mitigate escalation costs, such as through early purchase of materials.
  - (4) Contractor, for itself and all Subcontractors and suppliers on the Project, hereby agrees that the extension of time for delays under Section 2.4.U(1), and payment of the costs identified in Sections 2.4.U(2) and/or Section 2.4.U(3), are the sole remedies for costs and delays described in this Section, and waives all claims and demands for extended home office

overhead (including, but not limited to, "Eichleay" claims), lost profit or lost opportunities, and any special, indirect, or consequential damages arising as a result of delays described in this Section. The Contract Sum shall be adjusted to reflect payment of allowable costs.

- (5) If any delay described in this section causes the time or cost for the Project to exceed the Contract Time or the Contact Sum, then the Owner may terminate the Agreement pursuant to Section 14.2.
- (6) Contractor and any Subcontractor or supplier seeking additional costs under this Section 2.4.U. shall promptly submit estimates or any costs as requested by Owner, and detailed back-up for all costs when payment is sought or whenever reasonably requested by Owner. All costs are auditable, at Owner's discretion. Bid, estimate and pricing information reasonably related to any request for additional compensation will be provided promptly upon request.
- (7) Contractor shall include provisions in its schontract and purchase orders consistent with this Section.

### V. <u>Interfacing</u>.

- The Contractor shall take leasures as are necessary to ensure proper (1) ty of the Project, including but not limited to construction and de providing that all procu ent of long-lead items, the separate construction the gent al conditions items are performed without Subcontractor duplication or o maintain completion of all Work on schedule. tention ball be given to provide that each Subcontractor bid Particula Centries the Work included in that particular separate package scheduling for start and completion, and its relationship to subcontrac ther separa contractors.
- Without a suming any design responsibilities of the Architect/Engineer, the Contact or shall include in the Progress Reports required under this Section 2.4 comments on overlap with any other separate subcontracts, omissions, lack of correlation between drawings, and any other deficiencies noted, in order that the Architect/Engineer may arrange for necessary corrections.
- W. <u>Job Site Facilities</u>. The Contractor shall arrange for all job site facilities required and necessary to enable the Contractor and Architect/Engineer to perform their respective duties and to accommodate any representatives of the Owner which the Owner may choose to have present on the Project Site.
- X. <u>Weather Protection</u>. The Contractor shall provide temporary enclosures of building areas to assure orderly progress of the Work during periods when extreme weather conditions are likely to be experienced. The Contractor shall also be responsible for providing weather protection for Work in progress and for materials stored on the Project Site. A contingency plan shall be prepared upon request of the Owner for weather conditions that may affect the construction.

- Y. Payment and Performance Bond. Prior to the construction commencement date, the Contractor shall obtain, for the benefit of and directed to the Owner, a Payment and Performance Bond satisfying the requirements of Section 255.05, Florida Statutes, covering the faithful performance by the Contractor of its obligations under the Contract Documents, including but not limited to the construction of the Project on the Project Site and the payment of all obligations arising thereunder, including all payments to Subcontractors, laborers, and materialmen. The surety selected by the Contractor to provide the Payment and Performance Bond shall be approved by the Owner prior to the issuance of such Bond, which approval shall not be unreasonably withheld or delayed provided that the surety is rated A or better by Best's Key Guide, latest edition. For Changes in the Work that result in an increase in the Contract Sum, Owner reserves the right to require the Contractor to secure and deliver additive riders to the Payment and Performance Bond.
- Z. <u>Construction Phase; Building Permit; Code Jaspections</u>. Unless otherwise provided, Contractor shall obtain and pay for all construction permits and licenses. Owner shall assist Contractor, when necessary, in obtaining such permits are licenses. Contractor shall pay all governmental charges and inspection fees necessary for the prosecution of the Work.
  - (1) <u>Building Permit</u>. The Owner and Architect/Engineer shall provide such information to any Permitting Authority as a necessary to obtain approval from the Permitting Authority to omme the construction prior to beginning construction. The Contractor shall pull any required building permit, and shall be responsible to delivering and posting the building permit at the Project Site prior to the comme gement of construction. The cost of the building permits included in the Contract Sum. The Owner and Architect/Engine as a "Fully cooperate with the Contractor when and where no every.
  - ons. The Project requires detailed code compliance inspection (2) during construction in disciplines determined by any Permitting Authority. dis ip hes normally include, but are not necessarily limited to, mechanical, electrical, plumbing, general building and fire. The structural shall notify the appropriate inspector(s) Architect/Engineer, no less than 24 hours in advance, when the Work is ready for inspection and before the Work is covered up. All inspections shall be made for conformance with the applicable ordinances and building codes. Costs for all re-inspections of Work found defective and subsequently repaired shall not be included as Project Costs and shall be borne by the Contractor or as provided in the contract between Contractor and Subcontractor.
  - (3) <u>Contractor's Personnel</u>. The Contractor shall maintain sufficient off-site support staff and competent full-time staff at the Project Site authorized to act on behalf of the Contractor to coordinate, inspect, and provide general direction of the Work and progress of the Subcontractors. At all times during the performance of the Work, the Owner shall have the right to demand replacement of Contractor Personnel to whom the Owner has reasonable objection, without liability to the Contractor.

(4) <u>Lines of Authority</u>. To provide general direction of the Work, the Contractor shall establish and maintain lines of authority for its personnel and shall provide this information to the Owner and all other affected parties, such as the code inspectors of any Permitting Authority, the Subcontractors, and the Architect/Engineer. The Owner and Architect/Engineer may attend meetings between the Contractor and his Subcontractors; however, such attendance is optional and shall not diminish either the authority or responsibility of the Contractor to administer the subcontracts.

Quality Control. The Contractor shall develop and maintain a program, AA. acceptable to the Owner and Architect/Engineer, to assure quality control of the construction. The Contractor shall be responsible for and supervise the Work of all Subcontractors, providing instructions to each when their Work does not conform to the requirements of the Project Plans and Specifications, and the Contractor shall continue to coordinate the Work of each Subcontractor to ensure that corrections are made in a timely manner so as to ot affect the efficient progress of the Ahitect/Engineer over the Work. Should a disagreement occur between the Contractor the acceptability of the Work, the Owner, at its sole discretion and in dir on to any other remedies provided herein, shall have the right to determine be acceptability, provided that such determination is consistent with standards for co etion projets of this type and generally accepted industry standards for workmanship in ne Sta of P

racto All Subcontractors shall be compensated BB. Management of Subd in accordance with Article IV. The Contra shar solely control the Subcontractors. The ers an Field Orders with all affected Subcontractors and Contractor shall negotiate all Change shall review the costs and advise the Own and Architect/Engineer of their validity and er's best interest. When there is an imminent threat to health reasonableness, acting in the G and safety, and Owner's Project ptance concurrence is impractical, the Contractor shall act immediately to remove the the ais to health and safety and shall subsequently fully inform Owner of all such action taken. The Contractor shall also carefully review all shop drawings and then forward the same to 11. At hitect/Engineer for review and actions. The Architect/Engineer will transmit them back to the Intractor, who will then issue the shop drawings to the affected Subcontractor for fabrication revision. The Contractor shall maintain a suspense control system to promote expeditious handling. The Contractor shall request the Architect/Engineer to make interpretations of the drawings or specifications requested of him by the Subcontractors and shall maintain a business system to promote timely response. The Contractor shall inform the Architect/Engineer which shop drawings or requests for clarification have the greatest urgency, to enable the Architect/Engineer to prioritize requests coming from the Contractor. The Contractor shall advise the Owner and Architect/Engineer when timely response is not occurring on any of the above.

### CC. Job Requirements.

- (1) The Contractor shall provide each of the following as a part of its services hereunder:
  - (a) Maintain a log of daily activities, including manpower records, equipment on site, weather, delays, major decisions, etc;

- (b) Maintain a roster of companies on the Project with names and telephone numbers of key personnel;
- (c) Establish and enforce job rules governing parking, clean-up, use of facilities, and worker discipline;
- (d) Provide labor relations management and equal opportunity employment for a harmonious, productive Project;
- (e) Provide and administer a safety program for the Project and monitor for subcontractor compliance without relieving them of responsibilities to perform Work in accordance with best acceptable practice;
- (f) Provide a quality control program provided under Section 2.4.C above:
- (g) Provide miscellaneous office supplies hat support the construction efforts which are consumed by its own forces;
- (h) Provide for travel and from its tome office to the Project Site and to those other places within Manatee County as required by the Project;
- (i) Verify at tests, equipment, and system start-ups and operating and maintenance in tractions are conducted as required and in the parence of the required personnel and provide adequate records of sale to Architect/Engineer;
- Main ain at the job site orderly files for correspondence, reports of John Conferences, shop drawings and sample submissions, reproductions of original Contract Documents including all addenda, change orders, field orders, additional drawings issued after execution of the Agreement, Owner/Architect/Engineer's clarifications and interpretations of the Contract Documents, Progress Reports, as-built drawings, and other project related documents;
- (k) Keep a diary or log book, recording hours on the job site, weather conditions, data relative to questions of extras or deductions; list of visiting officials and representatives or manufacturers, fabricators, suppliers and distributors; daily activities, decisions, observations in general and specific observations in more detail as in the case of observing test procedures, and provide copies of same to Owner/Architect/Engineer;
- (l) Record names, addresses and telephone numbers of all Contractors, Subcontractors and major suppliers of materials and equipment;

- (m) Furnish Owner/Architect/Engineer periodic reports, as required, of progress of the Work and Contractor's compliance with the approved progress schedule and schedule of shop drawing submissions;
- (n) Consult with Owner/Architect/Engineer in advance of scheduling major tests, inspections or start of important phases of the Work;
- (o) Verify, during the course of the Work, that certificates, maintenance and operations manuals and other data required to be assembled and furnished are applicable to the items actually installed, and deliver same to Owner/Architect/Engineer for review prior to final Acceptance of the Work; and
- (p) Cooperate with Owner in the admir stration of grants.
- (2) The Contractor shall provide personnel an equipment, or shall arrange for separate Subcontractors to provide each of the following as a Project Cost:
  - (a) Services of independent tening Looratories, and provide the necessary testing of materials transure conformance to contract requirements; and
  - (b) Printing and discription fall required bidding documents and shop drawing including he sets required by Permitting Authority inspectors.
- DD. As-Built Pray of the Contractor shall continuously review as-built drawings and mark up procress place to provide as much accuracy as possible. Prior to, and as a requirement for authorizing final plyment to the Contractor due hereunder, the Contractor shall provide to the Owner of gina sec of marked-up, as-built Project Plans and Specifications and an electronic format of those a cords showing the location and dimensions of the Project as constructed, which documes shall be certified as being correct by the Contractor and the Architect/Engineer. Final as-built drawings shall be signed and sealed by a registered Florida surveyor.
- EE. <u>Progress Reports</u>. The Contractor shall forward to the Owner, as soon as practicable after the first day of each month, a summary report of the progress of the various parts of the Work, to include those parts of the Work in fabrication and in the field, stating the existing status, estimated time of completion and cause of delay, if any. Together with the summary report, the Contractor shall submit any necessary revisions to the original schedule for the Owner's review and approval. In addition, more detailed schedules may be required by the Owner for daily traffic control.
- FF. <u>Contractor's Warranty</u>. The Contractor warrants to the Owner and Architect/Engineer that materials and equipment furnished under the Contract will be of good quality and new unless the Contract Documents require or permit otherwise. The Contractor further warrants that the Work will conform to the requirements of the Contract Documents and

will be free from defects, except for those inherent in the quality of the Work the Contract Documents require or permit. Work, materials, or equipment not conforming to these requirements will be considered defective. The Contractor's warranty excludes remedy for damage or defect caused by abuse, alterations to the Work not executed by the Contractor, improper or insufficient maintenance, improper operation, or normal wear and tear and normal usage. If required by the Architect/Engineer, the Contractor shall furnish satisfactory evidence as to the kind and quality of materials and equipment.

- (1) Contractor shall use its best efforts and due diligence to ensure that during the warranty period, those entities or individuals who have provided direct warranties to the Owner as required by the Contract Documents perform all required warranty Work in a timely manner and at the sole cost and expense of such warranty providers. Any such cost or expense not paid by the warranty providers shall be paid by the Contractor, to include any costs and attorney's fees incurred in warranty-related litigation between Contractor and any Subcontractors.
- (2) The Contractor shall secure guarantees as levarrant as of Subcontractors, equipment suppliers and materialmen, and assemble and deliver same to the Owner in a manner that will facilitate their maximum enforcement and assure their meaningful implication. The Contractor shall collect and deliver to the Owner any specific writter guaranties or warranties given by others as required by subcontracts.
- (3) At the Owner's request, the Consector shall conduct, jointly with the Owner and the Archie Engineer, to more than two (2) warranty inspections within three (3) years a state Substantial Completion Date.
- GG. <u>Apprentices</u>. It entractor employs apprentices, their performance of Work shall be governed by and shall covery with the provisions of Chapter 446, Florida Statutes.
- HH. Schoole f Values. Unit prices shall be established for this Agreement by the submission of a schedule f values within ten (10) days of receipt of the Notice to Proceed. The schedule shall include partities and prices of items equaling the Contract Sum and will subdivide the Work into components in sufficient detail to serve as the basis for progress payments during construction. Such prices shall include an appropriate amount of overhead and profit applicable to each item of Work. Upon request of the County, the Contractor shall support the values with data which will substantiate their correctness.
- II. Other Contracts. The Owner reserves the right to let other contracts in connection with this Work. The Contractor shall afford other contractors reasonable opportunity for the introduction and storage of their materials and execution of their work, and promptly connect and coordinate the Work with theirs.

#### ARTICLE III

#### **COMPENSATION**

- **3.1** Compensation. The Contract Sum constitutes the total compensation (subject to authorized adjustments) payable to Contractor for performing the Work. All duties, responsibilities and obligations assigned to or undertaken by Contractor shall be at Contractor's expense without change in the Contract Sum.
- A. <u>Adjustments</u>. The Contract Sum may only be changed by Change Order or by a written amendment. Any claim for an increase or decrease in the Contract Sum shall be based on written notice delivered by the party making the claim to the other party. Notice of the amount of the claim with supporting data shall be delivered within fifteen (15) days from the beginning of such occurrence and shall be accompanied by claimant's written statement that the amount claimed covers all amounts to which the claimant is entitled as a result of the occurrence of said event. Failure to deliver a claim within the requisite 15-day period shall constitute a waiver of the right to pursue said claim.
- B. <u>Valuation</u>. The value of any Work covered to Change Order or of any claim for an increase or decrease in the Contract Sum shar be determined in one of the following ways (at Owner's discretion):
  - (1) In the case of Unit Price W. In accordance with Section 3.1.C, below; or
  - (2) By mutual acceptance of a sump sum; or
  - (3) On the basis of the cost of the Work, plus a negotiated Contractor's fee for overhead and profit. Contractor shall submit an itemized cost breakdown together with stop, using data.
- C. <u>Unit Price V ork</u>. The unit price of an item of Unit Price Work shall be subject to re-evaluation and adjustment pursuant to a requested Change Order under the following conditions:
  - (1) If the total cost of a particular item of Unit Price Work amounts to 5% or more of the Contract Sum and the variation in the quantity of the particular item of Unit Price Work performed by Contractor differs by more than 15% from the estimated quantity of such item indicated in the Agreement; and
  - (2) If there is no corresponding adjustment with respect to any other item of Work; and
    - (i) If Contractor believes that it has incurred additional expense as a result thereof; or
    - (ii) If Owner believes that the quantity variation entitles it to an adjustment in the unit price; or
    - (iii) If the parties are unable to agree as to the effect of any such

- **3.2 Schedule of Compensation.** All payments for services and material under the Contract Documents shall be made in accordance with the following provisions.
- A. <u>Periodic Payments for Services</u>. The Contractor shall be entitled to receive payment for Construction Services rendered pursuant to Section 2.4 in periodic payments which shall reflect a fair apportionment of cost and schedule of values of services furnished prior to payment, subject to the provisions of this Section.
- B. <u>Payment for Materials and Equipment</u>. In addition to the periodic payments authorized hereunder, payments may be made for material and equipment not incorporated in the Work but delivered and suitably stored at the Project Site, or another location, subject to prior approval and acceptance by the Owner on each occasion.
- C. <u>Credit toward Contract Sum.</u> All payments for Construction Services made hereunder shall be credited toward the payment of the Construction Sum as Contractor's sole compensation for the construction of the Project.
- 3.3 Invoice and Payment. All payment A services and materials under the Contract Documents shall be invoiced and paid in accordance will the Lowing provisions.
- A. <u>Invoices</u>. The Contractor's had submit to the Owner periodic invoices for payment, in a form acceptable to the Owner, who shad include a sworn statement certifying that, to the best of the Contractor's knowled, information and belief, the construction has progressed to the point indicated, the quality and the Work as wered by the invoice is in accord with the Project Plans and Specifications, and the Contractor is entitled to payment in the amount requested, along with the cost reports required pursuant. Article II, showing in detail all monies paid out, Project Costs accumulated, or Project Costs accumulated. This data shall be attached to the invoice.
- B. Addition Information; Processing of Invoices. Should an invoiced amount appear to exceed Work effort believed to be completed, the Owner may, prior to processing of the invoice for payment, require the Contractor to submit satisfactory evidence to support the invoice. All Progress Reports and invoices shall be delivered to the attention of the Owner's Project Representative. Invoices not properly prepared (mathematical errors, billing not reflecting actual Work done, no signature, etc.) shall be returned to the Contractor for correction.
- C. <u>Architect/Engineer's Approval</u>. Payment for Work completed shall be subject to the Architect/Engineer approving the payment requested by the Contractor and certifying the amount thereof that has been properly incurred and is then due and payable to the Contractor, and identifying with specificity any amount that has not been properly incurred and that should not be paid.
- D. <u>Warrants of Contractor with Respect to Payments</u>. The Contractor warrants that (1) upon payment of any retainage, materials and equipment covered by a partial payment request will pass to Owner either by incorporation in construction or upon receipt of payment by the Contractor, whichever occurs first; (2) Work, materials and equipment covered by previous

partial payment requests shall be free and clear of liens, claims, security interests, or encumbrances; and (3) no Work, materials or equipment covered by a partial payment request which has been acquired by the Contractor or any other person performing Work at the Project Site, or furnishing materials or equipment for the Project, shall be subject to an agreement under which an interest therein or an encumbrance thereon is retained by the seller or otherwise imposed by the Contractor or any other person.

E. <u>All Compensation Included</u>. Contractor's compensation includes full payment for services set forth in the Contract Documents, including but not limited to overhead, profit, salaries or other compensation of Contractor's officers, partners and/or employees, general operating expenses incurred by Contractor and relating to this Project, including the cost of management, supervision and data processing staff, job office equipment and supplies, and other similar items.

#### **ARTICLE IV**

## **SUBCONTRACTORS**

- 4.1 Subcontracts. At the Owner's rate the Corractor shall provide Owner's Project Representative with copies of all propried and final subcontracts, including the general and supplementary conditions thereof.
- A. <u>Subcontracts Generally</u>. All subcontracts shall: (1) require each Subcontractor to be bound to Contract of the same extent Contractor is bound to Owner by the terms of the Contract Documents, as to se to as may apply to the portion of the Work to be performed by the Subcontract (2) provide for the assignment of the subcontracts from Contractor to Owner at the election (3) provide that Owner will be an additional insured of all insurance policies required to be provided by the Subcontractor, except workers' compensation (6) assign all warranties directly to Owner, and (6) identify Owner as an intended third-party beneficiary of the subcontract.
- (1) A Subcontractor is a person or entity who has a direct contract with Contractor to perform a portion of the Work at the site. The term "Subcontractor" is referred to throughout the Contract Documents as if singular in number and means a Subcontractor or an authorized representative of the Subcontractor. The term "Subcontractor" does not include a separate contractor or subcontractors of a separate contractor.
- (2) A Sub-subcontractor is a person or entity who has a direct or indirect contract with a Subcontractor to perform a portion of the Work at the site. The term "Sub-subcontractor" is referred to throughout the Contract Documents as if singular in number and means a Sub-subcontractor or an authorized representative of the Sub-subcontractor.
- B. <u>No Damages for Delay</u>. Except when otherwise expressly agreed to by Owner in writing, all subcontracts shall provide:

"LIMITATION OF REMEDIES – NO DAMAGES FOR DELAY. The Subcontractor's exclusive remedy for delays in the performance of the contract caused by events beyond its control, including delays claimed to be caused by the Owner or Architect/Engineer or attributable to the Owner or Architect/Engineer and including claims based on breach of contract or negligence, shall be an extension of its contract time and shall in no way involve any monetary claim."

Each subcontract shall require that any claims by the Subcontractor for delay must be submitted to the Contractor within the time and in the manner in which the Contractor must submit such claims to the Owner, and that failure to comply with the conditions for giving notice and submitting claims shall result in the waiver of such claims.

- C. <u>Subcontractual Relations</u>. The Contractor shall require each Subcontractor to assume all the obligations and responsibilities which the Contractor owes the Owner pursuant to the Contract Documents, by the parties to the extent of the Work to be performed by the Subcontractor. Said obligations shall be made in writing and shall preserve and protect the rights of the Owner and Architect/Engineer, with respect to the Work to be performed by the Subcontractor, so that the subcontracting thereof will not prejudic such rights. Where appropriate, the Contractor shall require each Subcontractor to enter the similar agreements with its sub-subcontractors.
- D. <u>Insurance</u>; Acts and <u>Omissons</u> insurance requirements for Subcontractors shall be no more stringent than those requirements a posed on the Contractor by the Owner. The Contractor shall be responsible to the Owner on the as and omissions of its employees, agents, Subcontractors, their agents and employees, and all ther persons performing any of the Work or supplying materials under a contract to be Contractor.
- 4.2 Relationship an Resemblities. Except as specifically set forth herein with respect to direct materials ecquisives by Owner, nothing contained in the Contract Documents or in any Contract Document does a shall create any contractual relation between the Owner or Architect/Engineer and are sub-paractor. Specifically, the Contractor is not acting as an agent of the Owner with respect to are Subcontractor. The utilization of any Subcontractor shall not relieve Contractor from any Chaolity or responsibility to Owner, or obligate Owner to the payment of any compensation to the Subcontractor or additional compensation to the Contractor.
- **4.3 Payments to Subcontractors; Monthly Statements.** The Contractor shall be responsible for paying all Subcontractors from the payments made by the Owner to Contractor pursuant to Article III, subject to the following provisions:
- A. Payment. The Contractor shall, no later than ten (10) days after receipt of payment from the Owner, out of the amount paid to the Contractor on account of such Subcontractor's Work, pay to each Subcontractor the amount to which the Subcontractor is entitled in accordance with the terms of the Contractor's contract with such Subcontractor. The Contractor shall, by appropriate agreement with each Subcontractor, require each Subcontractor to make payments to sub-Subcontractors in a similar manner. After receipt of payment from Owner, if the need should arise to withhold payments to Subcontractors for any reason, as solely determined by Contractor, the Contractor shall promptly restore such monies to the Owner, adjusting subsequent pay requests and Project bookkeeping as required.

- B. Final Payment of Subcontractors. The final payment of retainage to Subcontractors shall not be made until the Project has been inspected by the Architect/Engineer or other person designated by the Owner for that purpose, and until both the Architect/Engineer and the Contractor have issued a written certificate that the Project has been constructed in accordance with the Project Plans and Specifications and approved Change Orders. Before issuance of final payment to any Subcontractor without any retainage, the Subcontractor shall submit satisfactory evidence that all payrolls, material bills, and other indebtedness connected with the Project have been paid or otherwise satisfied, warranty information is complete, as-built markups have been submitted, and instruction for the Owner's operating and maintenance personnel is complete. Final payment may be made to certain select Subcontractors whose Work is satisfactorily completed prior to the completion of the Project, but only upon approval of the Owner's Project Representative.
- **4.4 Responsibility for Subcontractors.** As provided in Section 2.4.BB, Contractor shall be fully responsible to Owner for all acts and omissions of the Subcontractors, suppliers and other persons and organizations performing or furnishing any of the Work under a direct or indirect Contract with Contractor just as Contractor is responsible for Contractor's or nacts and omissions.
- **4.5 Contingent Assignment of Subcontract.** Each subcontract agreement for a portion of the Work is assigned by the Contractor to a Owner, provided that:
  - (1) assignment is effective a ly after termination of the Contract by the Owner for cause pure at to article XIV and only for those subcontract agreements that the Cyric accepts by notifying the Subcontractor and Contractor in a sing; and
  - assignment is subject to the prior rights of the surety, if any, obligated under bon relative to the Agreement.

When the Owner accepts the assignment of a subcontract agreement, the Owner assumes the Contractor's rights an obligations under the subcontract. Upon such assignment, if the Work has been suspended for more than thirty (30) days, the Subcontractor's compensation shall be equitably adjusted for inches in cost resulting from the suspension. Upon such assignment to the Owner, the Owner may further assign the subcontract to a successor contractor or other entity. If the Owner assigns the subcontract to a successor contractor or other entity, the Owner shall nevertheless remain legally responsible for all of the successor contractor's obligations under the subcontract.

#### **ARTICLE V**

## **CHANGES IN WORK**

**5.1 General.** Changes in the Work may be accomplished after execution of the Agreement, and without invalidating the Agreement, by Change Order, Work Directive Change or order for a minor change in the Work, subject to the limitations stated in this Article V and elsewhere in the Contract Documents. A Change Order shall be based upon agreement among the

Owner, Contractor and Architect/Engineer; a Work Directive Change requires agreement by the Owner and Architect/Engineer and may or may not be agreed to by the Contractor; an order for a minor change in the Work may be issued by the Architect/Engineer alone. Changes in the Work shall be performed under applicable provisions of the Contract Documents, and the Contractor shall proceed promptly, unless otherwise provided in the Change Order, Work Directive Change or order for a minor change in the Work.

- 5.2 Minor Changes in the Work. The Owner or Architect/Engineer shall have authority to order minor changes in the Work not involving adjustment in the Contract Sum or extension of the Contract Time and not inconsistent with the intent of the Contract Documents. Such change will be effected by written order signed by the Architect/Engineer and shall be binding on the Owner and Contractor. The Contractor shall abide by and perform such minor changes. Such changes shall be effected by a Field Directive or a Work Directive Change. Documentation of changes shall be determined by the Construction Team, and displayed monthly in the Progress Reports. Because such changes shall not affect the Contract Sum to be paid to the Contractor, they shall not require a Change Order pursuant to Section 5.6.
- **5.3** Emergencies. In any emergency affecting the safety of persons or property, the Contractor shall act at its discretion to prevent threatened damage, in arry or loss. Any increase in the Contract Sum or extension of time claimed by the Contractor because of emergency Work shall be determined as provided in Section 5.6. However, then were practicable, the Contractor shall obtain verbal concurrence of the Owner's Project Representative and Architect/Engineer where the act will or may affect the Contract Sum or Contract Time.
- Concealed Conditions. If the Contract rencounters conditions at the site that are 5.4 (1) subsurface or otherwise conceans physical anditions that differ materially from those indicated in the Contract Documents or a unusual nature, that differ materially from those of arily to ad to exist and generally recognized as inherent in construction activities of the character roylded for in the Contract Documents, the Contractor shall promptly provide petice to the Owner and the Architect/Engineer before conditions are disturbed and in no event later that ten (10) days after first observance of the conditions. The Unampy investigate such conditions and, if the Architect/Engineer Architect/Engineer v determines that they differ materially and cause an increase or decrease in the Contractor's cost of, or time required for, framework of any part of the Work, will recommend an equitable adjustment in the Contract Sum or Contract Time, or both. If the Architect/Engineer determines that the conditions at the site are not materially different from those indicated in the Contract Documents and that no change in the terms of the Contract is justified, the Architect/Engineer shall promptly notify the Owner and Contractor in writing, stating the reasons. If the Contractor disputes the Architect/Engineer's determination or recommendation, the Contractor may proceed as provided in Article VIII. If the Owner disputes the Architect/Engineer's determination or recommendation, the Owner may appeal directly to the Purchasing Official and shall thereafter follow the process set forth in Section 8.5.
- 5.5 Hazardous Materials. In the event the Contractor encounters on the Project Site material reasonably believed to be hazardous, petroleum or petroleum related products, or other hazardous or toxic substances, except as provided in Section 2.4.U, the Contractor shall immediately stop Work in the area affected and report the condition to the Owner and the Architect/Engineer in writing. The Work in the affected area shall not thereafter be resumed except by Change Order or written amendment, if in fact the material or substance has not been rendered

harmless. The Work in the affected area shall be resumed when the Project Site has been rendered harmless, in accordance with the final determination by the Architect/Engineer or other appropriate professional employed by Owner. The Contractor shall not be required to perform without its consent any Work relating to hazardous materials, petroleum or petroleum related products, or other hazardous or toxic substances. In the event the Contractor encounters on the Project Site materials believed in good faith to be hazardous or contaminated material, and the presence of such hazardous or contaminated material was not known and planned for at the time the Contractor submitted its Bid (or Guaranteed Maximum Price proposal), and it is necessary for the Contractor to stop Work in the area affected and delays Work for more than a seven (7) day period, adjustments to the Contract Sum and/or Contract Time shall be made in accordance with this Article V.

## 5.6 Change Orders; Adjustments to Contract Sum.

- A. <u>Change Orders Generally</u>. The increase or decrease in the Contract Sum resulting from a change authorized pursuant to the Contract Docyments shall be determined:
  - (1) By mutual acceptance of a lump sum sount properly itemized and supported by sufficient substantiating data, a permit evaluation by the Architect/Engineer and Owner; or
  - (2) By unit prices stated in the Agree hent absequently agreed upon; or
  - (3) By any other method a tually agreeable to Owner and Contractor.

If Owner and Contractor are unable t see up in horeases or decreases in the Contract Sum and the Architect/Engineer certifies that the ork. Is to be commenced prior to any such agreement, a write. Change Order signed by or on behalf of the Owner, the Contractor, provided it rece shall promptly proceed with the Vork solved. The cost of such Work shall then be determined on the basis of the reasonable exp atures of those performing the Work attributed to the change. der is issued under these conditions, the Owner, through the However, in the event a Change C aolh مرا Architect/Engineer, v and estimated cost of the Work and the Contractor shall not perform any Work whose cost ey eeds that estimated without prior written approval by the Owner. In such case, the Contract shall keep and present in such form as the Owner may prescribe an itemized accounting, together with appropriate supporting data of the increase in overall costs of the Project. The amount of any decrease in the Contract Sum to be allowed by the Contractor to the Owner for any deletion or change which results in a net decrease in costs will be the amount of the actual net decrease.

5.7 Owner-Initiated Changes. Without invalidating the Agreement and without notice to any Surety, Owner may, at any time, order additions, deletions or revisions in the Work. These will be authorized by a written amendment, a Field Directive, a Change Order, or a Work Directive Change, as the case may be. Upon receipt of any such document, Contractor shall promptly proceed with the Work involved which will be performed under the applicable conditions of the Contract Documents (except as otherwise specifically provided). A Work Directive Change may not change the Contract Sum or the Contract Time; but is evidence that the parties expect that the change directed or documented by a Work Directive Change will be incorporated in a subsequently issued Change Order following negotiations by the parties as to its effect, if any, on the Contract Sum or Contract Time.

- **5.8** Unauthorized Work. Contractor shall not be entitled to an increase in the Contract Sum or an extension of the Contract Time with respect to any Work performed that is not required by the Contract Documents.
- **5.9 Defective Work.** Owner and Contractor shall execute appropriate Change Orders (or written amendments) covering changes in the Work which are ordered by Owner, or which may be required because of acceptance of defective Work, without adjustment to the Contract Sum.
- 5.10 Estimates for Changes. At any time Architect/Engineer may request a quotation from Contractor for a proposed change in the Work. Within twenty-one (21) calendar days after receipt, Contractor shall submit a written and detailed proposal for an increase or decrease in the Contract Sum or Contract Time for the proposed change. Architect/Engineer shall have twenty-one (21) calendar days after receipt of the detailed proposal to respond in writing. The proposal shall include an itemized estimate of all costs and time for performance that will result directly or indirectly from the proposed change. Unless otherwise directed, itemized estimates shall be in sufficient detail to reasonably permit an analysis by Architector gineer of all material, labor, equipment, subcontracts, overhead costs and fees, and shall cover all Voranvolved in the change, whether such Work was deleted, added, changed or impacted. Notwithstanding the request for quotation, Contractor shall carry on the Work and the tank the progress schedule. Delays in the submittal of the written and detailed proposal with be considered from-prejudicial.
- **5.11** Form of Proposed Changes the farm of all submittals, notices, Change Orders and other documents permitted or required to be a sed or ransmitted under the Contract Documents shall be determined by the Owner. Second Cornel forms shall be utilized.
- 5.12 Changes to Contract Time. The Contract Time may only be changed pursuant to a Change Order or a written am admit to the Contract Documents. Any claim for an extension or shortening of the Contract Time hall be based on written notice delivered by the party making the claim to the other party. No ce of the extent of the claim with supporting data shall be delivered within fiften (1) days from detection or beginning of such occurrence and shall be accompanied by the claimant's written statement that the adjustment claimed is the entire adjustment to which the chirant has reason to believe it is entitled to because of the occurrence of said event. The Contract time will be extended in an amount equal to time lost due to delays beyond the control of Contractor. Such delays shall include, but not be limited to, acts or neglect by Owner or others performing additional Work; or to fires, floods, epidemics, abnormal weather conditions or acts of God. Failure to deliver a written notice of claim within the requisite 15-day period shall constitute a waiver of the right to pursue said claim.

## **ARTICLE VI**

## ROLE OF ARCHITECT/ENGINEER

#### 6.1 General.

- A. <u>Retaining</u>. The Owner shall retain an Architect/Engineer (whether an individual or an entity) lawfully licensed to practice in Florida. That person or entity is identified as the Architect/Engineer in the Agreement and is referred to throughout the Contract Documents as if singular in number.
- B. <u>Duties</u>. Duties, responsibilities and limitations of authority of the Architect/Engineer as set forth in the Contract Documents shall not be restricted, modified or extended without written consent of the Owner and Architect/Engineer. Consent shall not be unreasonably withheld.
- C. <u>Termination</u>. If the employment of the Architect/Engineer is terminated, the Owner shall employ a successor Architect/Engineer as to whom the Contractor has no reasonable objection and whose status under the Contract Documents shall be that of the Architect/Engineer.
- **6.2** Administration. The Architect/Engineer will provide administration of the Agreement as described in the Contract Documents and will be an Oyder's representative during construction until the date the Architect/Engineer approves the fine application for Payment. The Architect/Engineer will have authority to act on behalf of the Own or y to the extent provided in the Contract Documents.
- A. <u>Site Visits</u>. The Architect Engine r will the site at intervals appropriate to the stage of construction, or as otherwise agreed with the Owner, to become generally familiar with the progress and quality of the portion when we complete, and to determine in general if the Work observed is being performed in a manne indicating that the Work, when fully completed, ocuments. Unless specifically instructed by Owner, the will be in accordance with the Contra Architect/Engineer will not be required on the exhaustive or continuous on-site inspections to e Work The Architect/Engineer will not have control over, check the quality or quantity charge of, or responsibility fo estruction means, methods, techniques, sequences or procedures, or for the safety pred ons and programs in connection with the Work, since these responsibilities under the Contract Documents. are solely the Contract r's rights a
- B. Reporting Based on the site visits, the Architect/Engineer will keep the Owner reasonably information out the progress and quality of the portion of the Work completed, and report to the Owner (1) known deviations from the Contract Documents and from the most recent construction schedule submitted by the Contractor, and (2) defects and deficiencies observed in the Work. The Architect/Engineer will not be responsible for the Contractor's failure to perform the Work in accordance with the requirements of the Contract Documents. The Architect/Engineer will not have control over or charge of and will not be responsible for acts or omissions of the Contractor, Subcontractors, or their agents or employees, or any other persons or entities performing portions of the Work.
- **6.3** Interpretation of Project Plans and Specifications. The Architect/Engineer will be the interpreter of the requirements of the Project Plans and Specifications. Upon receipt of comments or objections by Contractor or Owner, the Architect/Engineer will make decisions on all claims, disputes, or other matters pertaining to the interpretation of the Project Plans and Specifications.

- **6.4** Rejection of Non-Conforming Work. Upon consultation with Owner, the Architect/Engineer shall have the authority to reject Work which does not conform to the Project Plans and Specifications.
- 6.5 Correction of Work. The Contractor shall promptly correct all Work rejected by the Architect/Engineer for being defective or as failing to conform to the Project Plans and Specifications, whether observed before or after the Substantial Completion Date and whether or not fabricated, installed, or completed. The Contractor shall bear all costs of correcting such rejected Work, including compensation for Architect/Engineer's additional services made necessary thereby.
- 6.6 Timely Performance of Architect/Engineer. The Contractor shall identify which requests for information or response from the Architect/Engineer have the greatest urgency and those items which require prioritizing in response by the Architect/Engineer. The Contractor shall also identify the preferred time period for response and shall request a response time which is reasonably and demonstrably related to the needs of the Project and Contractor. If Architect/Engineer claims that Contractor's expectations for a esponse are unreasonable, Owner shall require Architect/Engineer to communicate such claim to Contractor is writing together with the specific time necessary to respond and the date upon which such response will be made. If Contractor believes that Architect/Engineer is not providing timely services or responses, Contractor shall notify Owner of same in writing the service is required without risk of delaying the Project.

# AL W LE VI

# OWNER'S RESTAND RESPONSIBILITIES

- 7.1 Projec Site; Title. The Owner shall provide the lands upon which the Work under the Contract Docume to to done, except that the Contractor shall provide all necessary additional land required for the erection of temporary construction facilities and storage of his materials, together with right of access to same. The Owner hereby represents to the Contractor that it currently has and will maintain up through and including the Substantial Completion Date, good title to all of the real property constituting the Project Site. Owner agrees to resolve, at its expense, any disputes relating to the ownership and use of the Project Site which might arise during construction.
- 7.2 Project Plans and Specifications; Architect/Engineer. The parties hereto acknowledge and agree that Owner has previously entered into an agreement with Architect/Engineer. Pursuant to the terms of such agreement, the Architect/Engineer, as an agent and representative of Owner, is responsible for the preparation of Project Plans and Specifications which consist of drawings, specifications, and other documents setting forth in detail the requirements for the construction of the Project. All such Project Plans and Specifications shall be provided either by Owner or the Architect/Engineer, and Contractor shall be under no obligation to provide same and shall be entitled to rely upon the accuracy and completeness of the Project Plans and Specifications provided by the Architect/Engineer and all preliminary drawings prepared in connection therewith. The Contractor will be furnished a reproducible set of all drawings and

specifications reasonably necessary for the performance of Contractor's services hereunder and otherwise ready for printing. The Contractor shall be notified of any written modification in the agreement between Owner and Architect/Engineer.

- Surveys; Soil Tests and Other Project Site Information. Owner shall be 7.3 responsible for providing a legal description and certified land survey of the Project Site in a form and content and with such specificity as may be required by the Architect/Engineer and Contractor to perform their services. To the extent deemed necessary by Owner and Architect/Engineer, and solely at Owner's expense, Owner may engage the services of a geotechnical consultant to perform test borings and other underground soils testing as may be deemed necessary by the Architect/Engineer or the Contractor. Contractor shall not be obligated to provide such surveys or soil tests and shall be entitled to rely upon the accuracy and completeness of the information provided; subject, however, to the provisions of Section 2.4.S hereof. Owner shall provide Contractor, as soon as reasonably possible following the execution of the Contract Documents, all surveys or other survey information in its possession describing the hysical characteristics of the Project Site, together with soils reports, subsurface investigations, utility locations, deed restrictions, easements, and legal descriptions then in its posses on or ontrol. Upon receipt of all all property advise Owner of surveys, soils tests, and other Project Site information, Contractor any inadequacies in such information and of the need for any addit, nat surveys, soils or subsoil tests. In performing this Work, Contractor shall use the standard of care of experienced contractors and will use its best efforts timely to identify all and lens or or assions. Owner shall not be responsible for any delay or damages to the Corractor or any sible or disclosed site conditions or disclosed deficiencies in the Project Site which should have been identified by Contractor and corrected by Owner prior to the execution of a e Co. tract Documents.
- ication; **Coordination.** 7.4 **Information:** Com The Owner's Project Representative shall examine any documes or requests for information submitted by the Contractor and shall advise Core stor of Coner's decisions pertaining thereto within a reasonable period of time to avoid unreason ble of the progress of the Contractor's services. Contractor shall indicate if any such documents or requests warrant priority consideration. However, decisions pertaining to approval of the Projet Schedule as it relates to the date of Substantial Completion, the Project Cost, Contact is compensation, approving or changing the Contract Sum shall only be effective when approved by wher in the form of a written Change Order or amendment to the reserves the right to designate a different Owner's Project Contract Documents. Representative provided Contractor is notified in writing of any such change. Owner and Architect/Engineer may communicate with Subcontractors, materialmen, laborers, or suppliers engaged to perform services on the Project, but only for informational purposes. Neither the Owner nor the Architect/Engineer shall attempt to direct the Work of or otherwise interfere with any Subcontractor, materialman, laborer, or supplier, or otherwise interfere with the Work of the Contractor. Owner shall furnish the data required of Owner under the Contract Documents promptly.
- **7.5 Governmental Body.** The Contractor recognizes that the Owner is a governmental body with certain procedural requirements to be satisfied. The Contractor has and will make reasonable allowance in its performance of services for such additional time as may be required for approvals and decisions by the Owner and any other necessary government agency.
- 7.6 Pre-Completion Acceptance. The Owner shall have the right to take possession of and use any completed portions of the Work, although the time for completing the entire Work

or such portions may not have expired, but such taking possession and use shall not be deemed an acceptance of any Work not completed in accordance with the Contract Documents.

# 7.7 Ownership and Use of Drawings, Specifications and Other Instruments of Service.

- (1) The Architect/Engineer and the Architect/Engineer's consultants shall be deemed the authors and owners of their respective instruments of service, including the Project Plans and Specifications, and will retain all common law, statutory and other reserved rights, including copyrights. The Contractor, Subcontractors, Sub-subcontractors, and material or equipment suppliers shall not own or claim a copyright in the instruments of service. Submittal or distribution to meet official regulatory requirements or for other purposes in connection with this Project is not to be constructed as publication in derogation of the Architect/Engineer's or Architect/Engineer's consultants' reserved right.
- (2) The Contractor, Subcontractors, Sub-sub ctors and material or equipment suppliers are authorized to use and reproduce the drawings and plen and clusively for execution of the specifications provided to the s aut. Azation shall bear the copyright Work. All copies made ader t notice, if any, shown on he roject Plans and Specifications or other The Contractor, Subcontractors, instruments of ંગી હ subcontractors, and n equipment suppliers may not use the sations of other projects or for additions to this Project drawings or sp outside the scope of the York without the specific written consent of the sitect/Engineer and the Architect/Engineer's consultants. Owner,
- 7.8 Owner's Project Peresentative. Owner's Project Representative is Owner's Agent, who will act a directed by and under the supervision of the Owner, and who will confer with Owner/Architec Englished regarding his actions. The Owner's Project Representative's dealings in matters pertaining to the on-site Work shall, in general, be only with the Owner/Architect/Engineer Contractor and dealings with Subcontractors shall only be through or with the full knowledge of Contractor.
- A. <u>Responsibilities</u>. Except as otherwise instructed in writing by Owner, the Owner's Project Representative will:
  - (1) Attend preconstruction conferences; arrange a schedule of progress meetings and other job conferences as required in consultation with Owner/Architect/Engineer and notify those expected to attend in advance; and attend meetings and maintain and circulate copies of minutes thereof;
  - (2) Serve as Owner/Architect/Engineer's liaison with Contractor, working principally through Contractor's superintendent, to assist in understanding the intent of the Contract Documents. As requested by Owner/Architect/Engineer, assist in obtaining additional details or information when required at the job site for proper execution of the Work;

- (3) Report to Owner/Architect/Engineer whenever he believes that any Work is unsatisfactory, faulty or defective or does not conform to the Contract Documents;
- (4) Accompany visiting inspectors representing public or other agencies having jurisdiction over the project; record the outcome of these inspections and report to Owner/Architect/Engineer;
- (5) Review applications for payment with Contractor for compliance with the established procedure for their submission and forward them with recommendations to Owner/Architect/Engineer; and
- (6) Perform those duties as set forth elsewhere within the Contract Documents.
- B. <u>Limitations</u>. Except upon written instructions of Owner, Owner's Project Representative shall not:
  - (1) Authorize any deviation from the Contract Comments or approve any substitute materials or equipment,
  - (2) Exceed limitations on Oyder/Architect Agineer's authority as set forth in the Contract Documents;
  - (3) Undertake any of the remonstrilities of Contractor, Subcontractors or Contractor's standard network;
  - (4) Advise of r issue directions relative to any aspect of the means, methods, technique services or procedures of construction unless such is specifically called for in the Contract Documents;
  - (5) Advice of or issue directions as to safety precautions and programs in connectic with the Work;
  - (6) Authorize Owner to occupy the project in whole or in part; or
  - (7) Participate in specialized field or laboratory tests.

## **ARTICLE VIII**

## RESOLUTION OF DISAGREEMENTS;

#### CLAIMS FOR COMPENSATION

**8.1 Owner to Decide Disputes.** The Owner shall reasonably decide all questions and disputes (with the exception of matters pertaining to the interpretation of the Project Plans and Specifications which shall be resolved by the Architect/Engineer pursuant to Section 6.3) that may

arise in the execution and fulfillment of the services provided for under the Contract Documents, in accordance with the Procurement Ordinance.

- **8.2 Finality.** The decision of the Owner upon all claims, questions, disputes and conflicts shall be final and conclusive, and shall be binding upon all parties to the Contract Documents, subject to judicial review as provided in Section 8.5 below.
- 8.3 No Damages for Delay. If at any time Contractor is delayed in the performance of Contractor's responsibilities under the Contract Documents as the result of a default or failure to perform in a timely manner by Owner or Owner's agents or employees, Contractor shall not be entitled to any damages except for compensation specifically authorized in Article III. Contractor's sole remedy will be a right to extend the time for performance. Nothing herein shall preclude Contractor from any available remedy against any responsible party other than Owner. Contractor shall be responsible for liquidated damages for delay if otherwise provided for in the Contract Documents.
- 8.4 Permitted Claims Procedure. Where authorized or positive under the Contract Documents, all claims for additional compensation by Contractor, exension of time affecting the Substantial Completion Date, for payment by the Owner of cost depages or losses due to casualty, Force Majeure, Project Site conditions or otherwise, shall be governed by the following:
  - (1) All claims must be submitted as requestor Change Order in the manner as provided in Article V.
  - (2) The Contractor must stamit notice of claim to Owner's Project Representative a to the Architect/Engineer within fifteen (15) days of the beginning of such access ce. Failure to submit a claim within the requisite 15-day paired shall anstitute a waiver of the right to pursue said claim.
  - Within two (20) days of submitting its notice of claim, the Contractor hall submit to the Owner's Project Representative its request for Change Ord, which shall include a written statement of all details of the claim, including description of the Work affected.
  - (4) After receipt of a request for Change Order, the Owner's Project Representative, in consultation with the Architect/Engineer, shall deliver to the Contractor, within twenty (20) days after receipt of request, its written response to the claim.
  - (5) In the event the Owner and Contractor are unable to agree on the terms of a Change Order, the Owner shall have the option to instruct the Contractor to proceed with the Work. In that event, the Owner shall pay for those parts of the Work, the scope and price of which are not in dispute. The balance of the disputed items in the order to proceed will be resolved after completion of the Work, based upon completed actual cost.
  - (6) The rendering of a decision by Owner with respect to any such claim, dispute or other matter (except any which have been waived by the making or acceptance of final payment) will be a condition precedent to any

exercise by Owner or Contractor of such right or remedies as either may otherwise have under the Contract Documents or by laws or regulations in respect of any such claim, dispute or other matter.

- 8.5 Contract Claims and Disputes. After completion of the process set forth in Section 8.4 above, any unresolved dispute under this Agreement shall be decided by the Purchasing Official in accordance with Section 2-26-63 of the Manatee County Code of Laws, subject to an administrative hearing process as provided in Section 2-26-64. The decision of the hearing officer in accordance with Section 2-26-64 of the Manatee County Code of Laws shall be the final and conclusive decision subject to exclusive judicial review in circuit court by a petition for certiorari.
- **8.6** Claims for Consequential Damages. The Contractor and Owner waive claims against each other for consequential damages arising out of or relating to this Agreement. This mutual waiver includes:
  - damages incurred by the Owner for rotal expenses, for losses of use, income, profit, financing, business and eputation, and for loss of management or employee productivity or of the ervices of such persons, unless any of such damages or longes are covered by insurance placed by the Contractor; and
  - damages incurred by the Contractor for principal office expenses including the compensation of corsonal stationed there, for losses of financing, business and reputation, and its loss of profit except anticipated profit arising directly can the Wor

This mutual waiver is applicable, withour imitation, to all consequential damages due to either party's termination in accordance when article XIV. Nothing contained in this Section 8.6 shall be deemed to preclude assessment a liquidated direct damages, when applicable, in accordance with the requirements at the Contract Documents.

#### ARTICLE IX

## **INDEMNITY**

## 9.1 Indemnity.

Indemnification Generally. To the fullest extent permitted by law, the A. Contractor shall indemnify and hold harmless the Owner, Architect/Engineer, Architect/Engineer's consultants, and agents and employees of any of them from and against claims, damages, losses and expenses, including but not limited to attorney's fees, arising out of or resulting from performance of the Work, provided that such claim, damage, loss or expense is attributable to bodily injury, sickness, disease or death, or to injury to or destruction of tangible property, but only to the extent caused by the negligent acts or omissions of the Contractor, a Subcontractor or anyone directly or indirectly employed by them or anyone for whose acts they may be liable, regardless of whether such claim, damage, loss or expense is caused in part by a

party indemnified hereunder. Such obligation shall not be construed to negate, abridge, or reduce other rights or obligations of indemnity which would otherwise exist as to a party or person described in this Section 9.1.

- B. <u>Indemnification; Enforcement Actions</u>. The Contractor's duty to indemnify and hold harmless the Owner in Section 9.1 above shall extend to fines, penalties and costs incurred by the Owner as related to any enforcement action taken by local, state, regional or federal regulatory entities. The Owner may deduct any of such fines, penalties and costs as described in this Section from any unpaid amounts then or thereafter due the Contractor under the Contract Documents. Any of such fines, penalties and costs not so deducted from any unpaid amounts due the Contractor shall be payable to the Owner at the demand of the Owner, together with interest from the date of the demand at the maximum allowable rate.
- C. <u>Claims by Employees</u>. In claims against any person or entity indemnified under this Section 9.1 by an employee of the Contractor, a Subcontractor, anyone directly or indirectly employed by them or anyone for whose acts they may be liable, the indemnification obligation under Section 9.1.A. shall not be limited by a limitation on anount or type of damages, compensation or benefits payable by or for the Contractor or Cabcontractor under workers' compensation acts, disability benefit acts or other employee benefit acts
- 9.2 Duty to Defend. The Contractor shall befend the Owner in any action, lawsuit, mediation or arbitration arising from the alleged in alignace, recklessness or intentionally wrongful conduct of the Contractor and other person employed or utilized by the Contractor in the performance of the Work. Notwithstanding any ther provisions within this Article IX, so long as Contractor, through its own counsel, a forms to obligation to defend the Owner pursuant to this Section, Contractor shall not be required to protect the Owner's costs associated with the Owner's participation in the defense.

## **ARTICLE X**

## ACCOUNTING RECORDS; OWNERSHIP OF DOCUMENTS

- 10.1 Accounting Records. Records of expenses pertaining to all services performed shall be kept in accordance with generally accepted accounting principles and procedures.
- 10.2 Inspection and Audit. The Contractor's records shall be open to inspection and subject to examination, audit, and/or reproduction during normal working hours by the Owner's agent or authorized representative to the extent necessary to adequately permit evaluation and verification of any invoices, payments or claims submitted by the Contractor or any of its payees during the performance of the Work. These records shall include, but not be limited to, accounting records, written policies and procedures, Subcontractor files (including proposals of successful and unsuccessful bidders), original estimates, estimating worksheets, correspondence, Change Order files (including documentation covering negotiated settlements), and any other supporting evidence necessary to substantiate charges related to the Contract Documents. They shall also

include, but not be limited to, those records necessary to evaluate and verify direct and indirect costs (including overhead allocations) as they may apply to costs associated with the Contract Documents. For such audits, inspections, examinations and evaluations, the Owner's agent or authorized representative shall have access to said records from the effective date of the Contract Documents, for the duration of Work, and until three (3) years after the date of final payment by the Owner to the Contractor pursuant to the Contract Documents.

- 10.3 Access. The Owner's agent or authorized representative shall have access to the Contractor's facilities and all necessary records to conduct audits in compliance with this Article. The Owner's agent or authorized representative shall give the Contractor reasonable advance notice of intended inspections, examinations, and/or audits.
- 10.4 Ownership of Documents. Upon obtainment of Substantial Completion or termination of the Agreement, all records, documents, tracings, plans, specifications, maps, evaluations, reports, transcripts and other technical data, other than working papers, prepared or developed by the Contractor shall be delivered to and become the property of the Owner. The Contractor at its own expense may retain copies for its files an enterprepare.

## ARTIC LE X

# PUBLIC COUTR CT LAWS

# 11.1 Equal Opportunity Em. Cym.

- A. <u>Employment</u>. A Contractor shall not discriminate against any employee or applicant for employment because of race, creed, sex, color, national origin, disability or age, and will take affirmative action to ensure that all employees and applicants are afforded equal employment opportunities with ut discrimination because of race, creed, sex, color, national origin, disability or age. Such ation will be taken with reference to, but shall not be limited to, recruitment, employment, see assignment, promotion, upgrading, demotion, transfer, layoff or termination, rates of training or retraining, including apprenticeship and on-the-job training.
- B. <u>Participation</u>. No person shall, on the grounds of race, creed, sex, color, national origin, disability or age, be excluded from participation in, be denied the proceeds of, or be subject to discrimination in the performance of the Agreement.
- 11.2 Immigration Reform and Control Act of 1986. Contractor acknowledges that it is responsible for complying with the provisions of the Immigration Reform and Control Act of 1986, located at 8 U.S.C. Section 1324, et seq., and regulations relating thereto. Failure to comply with the above statutory provisions shall be considered a material breach and shall be grounds for immediate termination of this Agreement.
- 11.3 No Conflict of Interest. The Contractor warrants that it has not employed or retained any company or person, other than a bona fide employee working solely for the Contractor to solicit or secure this Agreement, and that it has not paid or agreed to pay any person, company,

corporation, individual, or firm other than a bona fide employee working solely for the Contractor, any fee, commission, percentage, gift or any other consideration, contingent upon or resulting from the award or making of this Agreement.

- A. <u>No Interest in Business Activity</u>. By accepting award of this Agreement, the Contractor, which shall include its directors, officers and employees, represents that it presently has no interest in and shall acquire no interest in any business or activity which would conflict in any manner with the performance of services required hereunder, including without limitation as described in the Contractor's own professional ethical requirements. An interest in a business or activity which shall be deemed a conflict includes but is not limited to direct financial interest in any of the material and equipment manufacturers, suppliers, distributors, or contractors who will be eligible to supply material and equipment for the Project for which the Contractor is furnishing its services required hereunder.
- B. <u>No Appearance of Conflict</u>. The Contractor shall not knowingly engage in any contractual or professional obligations that create an appearance of a conflict of interest with respect to the services provided pursuant to the Agreement, the Contractor has provided the Affidavit of No Conflict, incorporated into the Contract Document as Exhibit "C", as a material inducement for Owner entering the Agreement. If, in the son differential of the County Administrator or designee, a conflict of interest is deemed to exist or a rise during the term of this Agreement, the County Administrator or designee and cannot this Agreement, effective upon the date so stated in a written notice of cancellation without penalt to the Owner.
- 11.4 Truth in Negotiations. By a cutie of the Contract Documents, the Contractor certifies to truth-in-negotiations and that wave actes and other factual unit costs supporting the compensation are accurate, complete collective at the time of contracting. Further, the original Contract Sum and any additions therete changes adjusted to exclude any significant sums where the Owner determines the Contract Sum was increased due to inaccurate, incomplete or non-current wage rates and other factual actions. Such adjustments must be made within one (1) year after final payment to the Contractor.
- 11.5 Public Eng. C incs. The Contractor is directed to the Florida Public Entity Crimes Act, Section 287.133 Florida Statutes, specifically section 2(a), and the Owner's requirement that the Contractor comply with it in all respects prior to and during the term of the Agreement.

#### **ARTICLE XII**

## FORCE MAJEURE, FIRE OR OTHER CASUALTY

## 12.1 Force Majeure.

A. <u>Unavoidable Delays</u>. Delays in any performance by any party contemplated or required hereunder due to fire, flood, sinkhole, earthquake or hurricane, acts of God, unavailability of materials, equipment or fuel, war, declaration of hostilities, revolt, civil strife, altercation or commotion, strike, labor dispute, or epidemic, archaeological excavation, lack of or failure of transportation facilities, or any law, order, proclamation, regulation, or ordinance of any

government or any subdivision thereof, or for any other similar cause to those enumerated, beyond the reasonable control and which with due diligence could not have been reasonably anticipated, shall be deemed to be events of Force Majeure and any such delays shall be excused. In the event such party is delayed in the performance of any Work or obligation pursuant to the Contract Documents for any of the events of Force Majeure stated in this Section 12.1, the date for performance required or contemplated by the Contract Documents shall be extended by the number of calendar days such party is actually delayed.

- B. <u>Concurrent Contractor Delays</u>. If a delay is caused for any reason provided in Section 12.1.A.and during the same time period a delay is caused by Contractor, the date for performance shall be extended as provided in 12.1.A. but only to the extent the time is or was concurrent.
- C. <u>Notice</u>; <u>Mitigation</u>. The party seeking excuse for nonperformance based on Force Majeure shall give written notice to the Owner, if with respect to the Contractor, or to the Contractor if with respect to the Owner, specifying its actual or succipated duration. Each party seeking excuse from nonperformance based on Force Majeure shall the its best efforts to rectify any condition causing a delay and will cooperate with the other raty, except that neither party shall be obligated to incur any unreasonable additional costs and except as to overcome any loss of time that has resulted.
- 12.2 Casualty; Actions by Owner are Contractor, Juring the construction period, if the Project or any part thereof shall have been are ged or destroyed, in whole or in part, the Contractor shall promptly make proof of loss, and when and Contractor shall proceed promptly to collect, or cause to be collected, all valid claims which may have arisen against insurers or others based upon such damage or destruct. The Connactor shall diligently assess the damages or destruction and shall prepare an estimate of the lest, expenses, and other charges, including normal he Connector, necessary for reconstruction of the Project and ordinary compensation t substantially in accordance with the ect Plans and Specifications. Within fifteen (15) days following satisfaction of the expre conditions described in subsections (1), (2) and (3) below, the liligently to commence reconstruction and to complete the Contractor covenants and agrees loss or damage by fire or other casualty to the Project to reconstruction or repair substantially the same size, floo area, cubic content, and general appearance as prior to such loss or damage:
  - (1) Receipt by the Owner or the trustee of the proceeds derived from collection of all valid claims against insurers or others based upon such damage or destruction, and receipt of other sums from any source such that the funds necessary to pay the Project Cost and any additions to the Project Cost necessitated for repair or reconstruction are available;
  - (2) Written agreement executed by the Contractor and the Owner, by amendment to the Contract Documents or otherwise, authorizing and approving the repair or reconstruction and any additions to the Project Cost necessitated thereby, including any required adjustment to the Contract Sum; and
  - (3) Final approval by the Owner of the Project Plans and Specifications for such repair or reconstruction and issuance of any required building permit.

- 12.3 Approval of Plans and Specifications. The Owner agrees to approve the plans and specifications for such reconstruction or repair if the reconstruction or repair contemplated by such plans and specifications is economically feasible, and will restore the Project, or the damaged portion thereof, to substantially the same condition as prior to such loss or damage, and such plans and specifications conform to the applicable laws, ordinances, codes, and regulations. The Owner agrees that all proceeds of any applicable insurance or other proceeds received by the Owner or the Contractor as a result of such loss or damage shall be used for payment of the costs, expenses, and other charges of the reconstruction or repair of the Project.
- 12.4 Notice of Loss or Damage. The Contractor shall promptly give the Owner written notice of any significant damage or destruction to the Project, defined as loss or damage which it is contemplated by Contractor will increase the Contract Sum or extend the Substantial Completion Date, stating the date on which such damage or destruction occurred, the then expectations of Contractor as to the effect of such damage or destruction on the use of the Project, and the then proposed schedule, if any, for repair or reconstruction of the Roject Loss or damage which the Contractor determines will not affect the Contract Sum or Substantial Completion Date will be reported to Owner and Architect/Engineer immediately, and associated forrective actions will be undertaken without delay.

# AR A LE. VII

## REPRESENTATION , YARRANTIES AND COVENANTS

- 13.1 Representations and Warra ties of Contractor. The Contractor represents and warrants to the Owner each of the following.
- A. The Consector is a construction company, organized under the laws of the State of \_\_\_\_\_\_, authorized to transact business in the State of Florida, with \_\_\_\_\_\_ as the primary qualifying agent. Contractor has all requisite power and authority to carry on its business as now conducted, to own or hold its properties, and to enter into and perform its obligations hereunder and under each instrument to which it is or will be a party, and is in good standing in the State of Florida.
- B. Each Contract Document to which the Contractor is or will be a party constitutes, or when entered into will constitute, a legal, valid, and binding obligation of the Contractor enforceable against the Contractor in accordance with the terms thereof, except as such enforceability may be limited by applicable bankruptcy, insolvency, or similar laws from time to time in effect which affect creditors' rights generally and subject to usual equitable principles in the event that equitable remedies are involved.
- C. There are no pending or, to the knowledge of the Contractor, threatened actions or proceedings before any court or administrative agency, within or without the State of Florida, against the Contractor or any partner, officer, or agent of the Contractor which question the validity of any document contemplated hereunder, or which are likely in any case, or in the

aggregate, to materially adversely affect the consummation of the transactions contemplated hereunder, or materially adversely affect the financial condition of the Contractor.

- D. The Contractor has filed or caused to be filed all federal, state, local, or foreign tax returns, if any, which were required to be filed by the Contractor, and has paid, or caused to be paid, all taxes shown to be due and payable on such returns or on any assessments levied against the Contractor.
- E. Neither Contractor nor any agent or person employed or retained by Contractor has acted fraudulently or in bad faith or in violation of any statute or law in the procurement of this Agreement.
- F. The Contractor shall timely fulfill or cause to be fulfilled all of the terms and conditions expressed herein which are within the control of the Contractor or which are the responsibility of the Contractor to fulfill. The Contractor shall be solely responsible for the means and methods of construction.
- G. It is recognized that neither the Architect Promeer, the Contractor, nor the Owner has control over the cost of labor, materials, or equipment, our an abcontractor's methods of determining bid prices, or over competitive bidding, harket, or negotiating conditions.
- H. During the term of the Couract I become s, and the period of time that the obligations of the Contractor under the Contract I becoments shall be in effect, the Contractor shall cause to occur and to continue to be in effect to se in fruments, documents, certificates, and events contemplated by the Contract Documents that we applicable to, and the responsibility of, the Contractor.
- I. The Concestor shall assist and cooperate with the Owner and shall accomplish the construction of the Project in accordance with the Contract Documents and the Project Plans and Specifications and will not knowingly violate any laws, ordinances, rules, regulations, or orders that are or will be applicable thereto.
- J. Contracto warrants and guarantees to Owner that all Work will be in accordance with the Contractor occuments and will not be defective, and that Owner, representatives of Owner, and governmental agencies with jurisdictional interests will have access to the Work at reasonable times for their observation, inspecting and testing. Contractor shall give Architect/Engineer timely notice of readiness of the Work for all required approvals and shall assume full responsibility, including costs, in obtaining required tests, inspections, and approval certifications and/or acceptance, unless otherwise stated by Owner.
- K. If any Work (including Work of others) that is to be inspected, tested, or approved is covered without written concurrence of Architect/Engineer, it must, if requested by Architect/Engineer, be uncovered for observation. Such uncovering shall be at Contractor's expense unless Contractor has given Architect/Engineer timely notice of Contractor's intention to cover the same and Architect/Engineer has not acted with reasonable promptness in response to such notice. Neither observations by Architect/Engineer nor inspections, tests, or approvals by others shall relieve Contractor from Contractor's obligations to perform the Work in accordance with the Contract Documents.

- L. If the Work is defective, or Contractor fails to supply sufficient skilled workers, or suitable materials or equipment, or fails to furnish or perform the Work in such a way that the completed Work will conform to the Contract Documents, Owner may order Contractor to stop the Work, or any portion thereof and terminate payments to the Contractor until the cause for such order has been eliminated. Contractor shall bear all direct, indirect and consequential costs for satisfactory reconstruction or removal and replacement with non-defective Work, including, but not limited to fees and charges of Architect/Engineers, attorneys and other professionals and any additional expenses experienced by Owner due to delays to other Contractors performing additional Work and an appropriate deductive change order shall be issued. Contractor shall further bear the responsibility for maintaining the schedule and shall not be entitled to an extension of the Contract Time or the recovery of delay damages due to correcting or removing defective Work.
- M. If Contractor fails within seven (7) days after written notice to correct defective Work, or fails to perform the Work in accordance with the Contract Documents, or fails to comply with any other provision of the Contract Documents. Where may correct and remedy any such deficiency to the extent necessary to complete corrective and remedial action. Owner may temporarily exclude Contractor from all or part of the site, to corarily take possession of all or part of the Work, Contractor's tools, construction equipment and magninery at the site or for which Owner has paid Contractor but which are stored elsewhere, all for such duration as is reasonably necessary to correct the deficiency. All the tank indirect costs of Owner in exercising such rights and remedies will be charged against Ontract. In an amount approved as to reasonableness by Architect/Engineer and a Contract of Order will be issued incorporating the necessary revisions.
- N. If within three to year after the Substantial Completion Date or such longer period of time as may be prescribed by the sor regulations or by the terms of any applicable special guarantee required by the Contract Documents, any Work is found to be defective, Contractor shall promptly, without to Owner and in accordance with Owner's written instructions, either correct such defective Work or if it has been rejected by Owner, remove it from the site and replace it with non-defective Work. If Contractor does not promptly comply with the terms of such instruction. Owner may have the defective Work corrected/removed and all direct, indirect and consequential costs of such removal and replacement will be paid by Contractor. Failing payment by the Contractor and notwithstanding any other provisions of the Contract Documents to the contrary, Owner shall have the right to bring a direct action in the Circuit Court to recover such costs.
- 13.2 Representations of the Owner. To the extent permitted by law, the Owner represents to the Contractor that each of the following statements is presently true and accurate:
  - A. The Owner is a validly existing political subdivision of the State of Florida.
- B. The Owner has all requisite corporate or governmental power and authority to carry on its business as now conducted and to perform its obligations under the Contract Documents and each Contract Document contemplated hereunder to which it is or will be a party.
- C. The Contract Documents and each Contract Document contemplated hereby to which the Owner is or will be a party has been duly authorized by all necessary action on the part of, and has been or will be duly executed and delivered by, the Owner, and neither the

execution and delivery thereof nor compliance with the terms and provisions thereof or hereof: (a) requires the approval and consent of any other person or party, except such as have been duly obtained or as are specifically noted herein; (b) contravenes any existing law, judgment, governmental rule, regulation or order applicable to or binding on the Owner; or (c) contravenes or results in any breach of, default under, or result in the creation of any lien or encumbrance upon the Owner under any indenture, mortgage, deed of trust, bank loan, or credit agreement, the charter, ordinances, resolutions, or any other agreement or instrument to which the Owner is a party, specifically including any covenants of any bonds, notes, or other forms of indebtedness of the Owner outstanding on the date of the Contract Documents.

- D. The Contract Documents and each document contemplated hereby to which the Owner is or will be a party constitutes, or when entered into will constitute, a legal, valid, and binding obligation of the Owner enforceable against the Owner in accordance with the terms thereof, except as such enforceability may be limited by applicable bankruptcy, insolvency, or similar laws from time to time in effect which affect creditors' rights generally, and subject to usual equitable principles in the event that equitable remedies ar involved.
- E. There are no pending or, to the knowledge of the Owder, threatened actions or proceedings before any court or administrative agency against the Owner which question the validity of the Contract Documents or any document consemplated hereunder, or which are likely in any case or in the aggregate to materially adversate, affect the consummation of the transactions contemplated hereunder or the financial or correlate condition of the Owner.
- F. The Owner shall use a dily suce to timely fulfill or cause to be fulfilled all of the conditions expressed in the Control of the Owner or which are the responsibility. Sthe Cyne to fulfill.
- G. During the rendence of the Work and while the obligations of the Owner under the Contract Documents half the refect, the Owner shall cause to occur and to continue to be in effect and take such actions may be necessary to enforce those instruments, documents, certificates and even contemplated by the Contract Documents that are applicable to and the responsibility of the Owner.
- H. The fer shall assist and cooperate with the Contractor in accomplishing the construction of the Project in accordance with the Contract Documents and the Project Plans and Specifications, and will not knowingly violate any laws, ordinances, rules, regulations, orders, contracts, or agreements that are or will be applicable thereto or, to the extent permitted by law, enact or adopt any resolution, rule, regulation, or order, or approve or enter into any contract or agreement, including issuing any bonds, notes, or other forms of indebtedness, that will result in the Contract Documents or any part thereof, or any other instrument contemplated by and material to the timely and effective performance of a party's obligations hereunder, to be in violation thereof.

#### **ARTICLE XIV**

## TERMINATION AND SUSPENSION

- 14.1 Termination for Cause by Owner. This Agreement may be terminated by Owner upon written notice to the Contractor should Contractor fail substantially to perform a material obligation in accordance with the terms of the Contract Documents through no fault of the Owner. In the event Owner terminates for cause and it is later determined by a court of competent jurisdiction that such termination for cause was not justified, then in such event such termination for cause shall automatically be converted to a termination without cause pursuant to Section 14.2.
- A. Nonperformance. If the Contractor fails to timely perform any of its obligations under the Contract Documents, including any obligation the Contractor assumes to perform Work with its own forces, or if it persistently or repeatedly refuses or fails, except in case for which extension of time is provided, to supply enough properly skilled workmen or proper materials, or fails, without being excused, to maintain an establisted schedule (failure to maintain schedule shall be defined as any activity that falls thirty (30) day, or rore behind schedule) which has been adopted by the Construction Team, or it fails to make proper to pay tent to Subcontractors for materials or labor, or disregards laws, rules, ordinances, regulators, or orders of any public authority having jurisdiction, or otherwise is guilty of subtantial violations of the Agreement the Owner may, after seven (7) days written notice, during which period the Contractor fails to perform such obligation, make good such deficiencies at a perform such actions. The Contract Sum shall be reduced by the cost to the Owner of making and such deficiencies, and the Contractor's compensation shall be reduced by an amount required to manage the making good of such deficiencies. Provided, however, nothing contained herein shall limit or preclude Owner from pursuing additional damages from Contract or because of its breach.
- B. <u>Insolven</u> v. If the Contractor is adjudged bankrupt, or if it makes a general assignment for the benefit of its cediff its or if a receiver is appointed because its insolvency, then the Owner may, without pjudic to any other right or remedy, and after giving the Contractor and its surety, if any, fourteer (14) days written notice, and during which period the Contractor fails to cure the violation terms at the Agreement. In such case, the Contractor shall not be entitled to receive any further payment. Owner shall be entitled to recover all costs and damages arising because of failure of contractor to perform as provided in the Contract Documents, as well as reasonable termination expenses, and costs and damages incurred by the Owner may be deducted from any payments left owing the Contractor.
- C. <u>Illegality</u>. Owner may terminate the Agreement if Contractor disregards laws or regulations of any public body having jurisdiction.
- D. <u>Rights of Owner</u>. The Owner may, after giving Contractor (and the surety, if there is one) seven (7) days written notice, terminate the services of Contractor for cause; exclude Contractor from the Project Site and take possession of the Work and of all Contractor's tools, construction equipment and machinery at the Project Site and use the same to the full extent they could be used (without liability to Contractor for trespass or conversion); incorporate in the Work all materials and equipment stored at the Project Site or for which Owner has paid Contractor but which are stored elsewhere, and finish the Work as Owner may deem expedient. In such case, Contractor shall not be entitled to receive any further payment beyond an amount equal to the value of material and equipment not incorporated in the Work, but delivered and suitably stored,

less the aggregate of payments previously made. If the direct and indirect costs of completing the Work exceed the unpaid balance of the Contract Sum, Contractor shall pay the difference to Owner. Such costs incurred by Owner shall be verified by Owner in writing; but in finishing the Work, Owner shall not be required to obtain the lowest quote for the Work performed. Contractor's obligations to pay the difference between such costs and such unpaid balance shall survive termination of the Agreement. In such event and notwithstanding any other provisions of the Contract Documents to the contrary, Owner shall be entitled to bring a direct action in the Circuit Court to recover such costs.

- Administrator or designee, shall have the right to terminate the Agreement, in whole or in part, without cause upon sixty (60) calendar days' written notice to the Contractor. In the event of such termination for convenience, the Owner shall compensate Contractor for payments due through the date of termination, and one subsequent payment to cover costs of Work performed through the date of termination, subject to the terms and conditions of Section 3.1. The Contractor shall not be entitled to any other further recovery against the Owner including, but not limited to, anticipated fees or profit on Work not required to be performed or correquential damages or costs resulting from such termination.
- A. Release of Contractor. As a condition of Owner's termination rights provided for in this subsection, Contractor shall be recase and elseharged from all obligations arising by, through, or under the terms of the Contact Louments, and the Payment and Performance Bond shall be released. Owner shall assume and become responsible for the reasonable value of Work performed by Subject tractors prior to termination plus reasonable direct close-out costs, but in no event shall Subject tractors be entitled to unabsorbed overhead, anticipatory profits, or damages for experimentation.
- B. <u>Waiver Corrects</u>: Contractor hereby waives any right to protest the exercise by Owner of its right up this Section that may apply under the Procurement Ordinance.
- 14.3 Suspersion and utCause. Owner may, at any time and without cause, suspend the Work or any portion thereof or a period of not more than ninety (90) days by written notice to Contractor, which will fix that on which Work will be resumed. Contractor shall be allowed an increase in the Contract Sum or an extension of the Contract Time, or both, directly attributable to any suspension if Contractor makes an approved claim therefor.
- 14.4 Termination Based Upon Abandonment, Casualty or Force Majeure. If, after the construction commencement date (i) Contractor abandons the Project (which for purposes of this paragraph shall mean the cessation of all construction and other activities relating to the Project, excluding those which are necessary to wind down or otherwise terminate all outstanding obligations with respect to the Project, and no recommencement of same within one hundred twenty (120) days following the date of cessation), or (ii) the Project is stopped for a period of thirty (30) consecutive days due to an instance of Force Majeure or the result of a casualty resulting in a loss that cannot be corrected or restored within one hundred twenty (120) days (excluding the time required to assess the damage and complete the steps contemplated under Section 12.2), the Owner shall have the right to terminate the Agreement and pay the Contractor its compensation earned or accrued to date.

14.5 Vacation of Project Site; Delivery of Documents. Upon termination by Owner pursuant to Section 14.2 or 14.4, Contractor shall withdraw its employees and its equipment, if any, from the Project Site on the effective date of the termination as specified in the notice of termination (which effective date shall not be less than two (2) working days after the date of delivery of the notice), regardless of any claim the Contractor may or may not have against the Owner. Upon termination, the Contractor shall deliver to the Owner all original papers, records, documents, drawings, models and other material set forth and described in the Contract Documents.

14.6 Termination by the Contractor. If, through no act or fault of Contractor, the Work is suspended for a period of more than ninety (90) consecutive days by Owner or under an order of court or other public authority, or Owner fails to act on any Application for Payment or fails to pay Contractor any sum finally determined to be due; then Contractor may, upon fourteen (14) days written notice to Owner terminate the Agreement and recover from Owner payment for all Work executed, any expense sustained plus reasonable termination expenses. In lieu of terminating the Agreement, if Owner has failed to act on any Application for Payment or Owner has failed to make any payment as aforesaid, Contractor may upon fourteen (14) days written notice to Owner stop the Work until payment of all amounts then the
