Attach a sample schedule with your proposal which best illustrates the firm's overall scheduling capabilities. Include in your sample, scheduled anticipated tasks to be performed in providing these services, include the documentation which the County will have to provide and when they would be required." No 7 states "A conceptual level schedule should be included as a separate page to illustrate sequencing of major elements of construction (11"x17" page size and 40 activities maximum.)" a. Are these the same schedule, or a schedule for 63<sup>rd</sup> of the major elements of construction, and a separate example schedule from another project showing our scheduling capabilities? b. If these are a separate schedule it is assumes that the schedule for 63<sup>rd</sup> is part of the 20-page limit, but the example schedule from another project can be part of an exhibit and is not part of the page limit.
