NOTICE OF INTENT TO AWARD

The Manatee County Procurement Division provides notice of its intent to award a contract with Kimley-Horn and Associates, Inc. for the provision of Buffalo Creek Park Athletic Expansion Design Services.

BACKGROUND/EVALUATION

The purpose of this Request for Qualifications (RFQ) was to solicit responses from qualified firms or individuals to provide design services for Buffalo Creek Park. The project involves enhancing existing facilities with synthetic turf fields and natural turf fields, additional soccer fields, paved parking lot, restroom facilities, pavilions, playgrounds, press boxes, landscaping and all other necessary items and site improvements for a fully functional facility.
