We are pleased to provide Manatee County with the following responses to the pre-bid questions for Addendum 2.

**Questions received from Bidders – September 6, 2011 (via E-mail)**

**Question 1** Note regarding bid item #522-1 states to include saw cutting and removal of existing drives within sidewalk limits. The plans indicate that existing concrete drives are to remain with the new sidewalk being poured up to and matching the existing drives. We are to remove the dirt drives and pour new approaches that are to be paid for in item 522-1 for the 6" concrete. There shows to be one asphalt drive that would need sawing. Please confirm the existing concrete drives are to remain.

**Response 1** *The existing concrete driveways are to remain with the exception of the driveways at STA 75+00 and STA 76+00. These driveways have a cross slope too great for pedestrian traffic and will need to be replaced per plan.*
