BACKGROUND/EVALUATION

Manatee County Government solicited a Request for Proposal (RFP) to engage a highly qualified and professional Proposer to provide a broad range of services to assist with the U.S. Department of Housing and Urban Development (HUD) Community Development Block Grant Disaster Recovery (CDBG-DR) grant. Services may include, but are not limited to grant staff augmentation, preparation of environmental reviews, and general grant administration.
