RFQ No. 26-TA006225RB is amended as set forth herein. Responses to questions posed by prospective bidders are provided below. This Addendum is hereby incorporated in and made a part of RFQ No. 26-TA006225RB.

The deadline to submit all inquiries concerning interpretation, clarification or additional information pertaining to this RFQ is November 17, 2025.

QUESTIONS AND RESPONSES:

Q1. Is this contract for a define term (i.e. number of years) or is it tied to the completion of the included “projects”?

R1. The contract term would be three (3) years, with the option to extend for up to an additional two (2) years, for a potential total contract term of five (5) years.

Q2. If the contract is for a defined term, what is that term and will there be option to extend the term as warranted by the scope of the included “projects”?

R2. See response to question 1.

Q3. Is there a list of “projects” likely be included under this contract that can be shared with the interested firms to magnitude of the work?

R3. The expected types of projects and required services are described in Exhibit 1, Scope of Services. At this stage, we are not issuing a specific project list, as future work will depend on permitting status and funding timelines. Anticipated 2026 projects include living shorelines, oyster reef construction, and dredging/minor excavation work.

Q4. Is there an approximate overall budget for the work anticipated to be included in the contract?

R4. Each project will have its own budget, which will vary based on project-specific needs,

permitting requirements, and available funding sources. Some will be larger projects as listed above, but smaller projects will likely arise over the term of the contract.

Q5. Will the selected firm be expected to provide any design services under this contract or will all design and permitting be handled by others?

R5. **Design and permitting will be handled separately and are not part of this contract. The County may request contractor input or constructability recommendations during final stages of design, but the selected contractor(s) will not be responsible for design or permitting.**

Q6. Section G: Tab 7, #8 requires the Contractor to commit to meet the County's budget. Please project the County's budget for this project.

R6. **As noted above, each project under this contract will have its own budget, dependent on project-specific conditions and funding.**

Q7. How will contract price be determined for the successful proposal? (i.e. Time and Materials, negotiated task order, etc.)

R7. **Negotiated task orders.**
