QUESTIONS AND RESPONSES:

Q1. Bid No. 26-R089101PH - Highway Lighting Maintenance is Electrical Contracting and governed by Florida Statute Chapter 489, will each bidder be required to submit a copy of their Electrical Contractors License with their Bid?

R1. Yes, refer to Exhibits, Exhibit 2, Minimum Qualifications, No. 2.

Q2. Is Manatee County currently utilizing an outside contractor to perform their Highway Lighting Maintenance? If so, could Manatee County please provide a copy of the executed contract with the current Vendor or Vendors as well as provide the unit prices?

R2. We are currently using our Traffic Signal Maintenance contract to perform some lighting maintenance work, however, that contract is completely different and does not contain the same pay items and scope.

Q3. Could Manatee County please provide the approximate units accomplished for Highway Lighting Maintenance for the calendar year of 2025?

R3. There isn't a clean / meaningful "units accomplished" measurement that we could share. I can say we average about 40-60 outages / repairs per month. These consist of individual outages, knockdowns as well as system or circuit wide outages.

Q4. Approximately how much money was spent on Highway Lighting Maintenance for the calendar year of 2025?

R4. We anticipate the annual spend could land anywhere between \$250K to \$500K+ annually.

Q5. Can Manatee County provide a current list / type of lighting poles in need of replacement?

R5. There isn't a list of poles that need to be replaced. Typically poles that need to be replaced are due to vehicle accidents. Those repair requests would be communicated to the contractor immediately as they occur. Repairs would be expected soon thereafter. The contract contains language which addresses this.

Q6. Wire Theft / Replacement - Does Manatee County currently have a significant amount of wire theft that needs to be replaced?

R6. We do have wire theft, But we are actively managing those repairs now. The likelihood those repairs will still be needed by the time this contract is executed is slim. Please know, we expect the contractor will be extremely responsive and expeditious in making repairs. There would need to be a constant work flow.

Q7. Wire Theft / Replacement - Has Manatee County experienced wire theft in 2025, if so, approximately how much?

R7. We have, but I don't have an exact count on that. I am sure you can expect there may be a certain amount of vandalism / theft related repairs as well as countermeasure work.

Q8. Can Manatee County provide a copy of their last lighting outage report?

R8. Yes, the street light repair list is being provided with this addendum.

Q9. Is a Bid Bond required for Bid No. 26-R089101PH - Highway Lighting Maintenance?

R9. No.

Q10. Page 58 of 160 - 1.01 BACKGROUND INFORMATION - The estimate annual total expenditure of this Agreement is approximately **\$700,000** for materials and services. Please clarify - Since this is a 3 Year Contract, is the estimated total expenditure (3) **\$700,000.00 = \$2,100,000.00? Or is the intent \$700,000.00 / 3 Years = \$233,33,33 per year?**

R10. We do not anticipate the spend exceeding \$700K in any given fiscal year. However, its subject to change in the event of storm damage.

Q11. Aside from Standard Highway Lighting Maintenance activities, is Manatee County planning any significant upgrades to their lighting system such as Retrofitting HPS luminaires to LED etc.?

R11. We've already handled the majority of our retrofits.
