- 12/06/11 Selection Committee meeting for discussion and review of proposals resulted in the declaration of one respondent, Best Buy Government, LLC, Richfield, Minnesota, being deemed non-responsive.
- CCAV demonstrated a wide range of experience, knowledge, and quality service and has provided audio visual services in convention, event, theatre, hospitality, and numerous travel settings with ample audio visual equipment inventory. In addition, the firm provides staff training and professional development programs for its employees in the latest advent of evolving technology. The Selection Committee ranked this firm first as a result of their overall capabilities to meet the County's requirements.
