The Bid Item Numbers used by the FDOT have been revised. The new numbers are shown on the attached revised Bid Form. In addition, one quantity changed. Specifically, the changes are as follows:

- 1. FDOT Item Number 650-51-311 (old) is changed to 650-1-311 (new).
- 2. FDOT Item Number 650-51-511 (old) is changed to 650-1-511 (new).
- 3. FDOT Item Number 659-107 (old) is changed to 646-1-11 (new).
- 4. FDOT Item Number 659-106 has been eliminated. The signal head tunnels visors are included as part of pay item 650-1-311 and 650-1-511.
- 5. The quantity for 783-1-121 ITS FIBER OPTIC CABLE has been revised to 225 LF.
- 6. FDOT Item Number 110-1-1 has been added to address testing and possible removal of soil and/or water from the site that may be contaminated. This pay item includes all standards and specifications for Section 110: Clearing and Grubbing from the FDOT Standard Specifications for Road and Bridge Construction 2010. Please see Section 110-9.5 which provides information on the handling, transport and disposal of hazardous materials/waste.

To All Bidders:

The following are written understandings of the questions presented to the County at the April 12 Pre-Bid meeting. Following each question is the answer, in bold, provided to all bidders.

1. Is a ROW Use permit required and who will obtain it?

The contractor is required to obtain all permits for completion of the work. All fees and expenses of such permits shall be included in the bid.

2. What is the purpose of requiring a General Contractor license rather than an Electrical Contractor license for the prime contractor?

The requirement for a General Contractor license is no longer part of the bid requirements. In place of the General Contractor license requirement, all bidders must be prequalified by FDOT for "TRAFFIC SIGNAL" work.

See revised criteria in answer to Question number 3 below.

3. Shouldn't the County change to a prequalification process such as the FDOT prequalified categories?

The FDOT has determined that a bidder must be a FDOT prequalified contractor in the category of "TRAFFIC SIGNAL". The prime contractor's corporate name must appear in the State FDOT database in this category on the bid due date. In addition, the certification must be maintained throughout the duration of the project.

4. What is the technical specification for the video detection system?

Please use the following video detection system that is the compatible video detection system used throughout Manatee County:

Video detection camera shall be ITERIS Vantage RZ4 Advanced Wide Dynamic Range Color camera mounted on Pelco mast arm camera bracket. Install the detection system in strict accordance with the video detection system's installation manuals. The Contractor shall only use manufacturer approved cabling connectors and components for the video detection system. The signal contractor shall consult with the technical representatives prior to installation. The Contractor shall request a system critique from the video detection equipment supply manufacturer when installation is complete. The results of the system critique shall be provided in writing to Manatee County Traffic Engineering Division prior to scheduling the final inspection.

### 5. The ATMS controller cabinet is new. Why not just relocate it?

Contractor is to furnish a new traffic controller assembly as shown in the plans. The Contractor is to deliver the existing cabinet and controller equipment in good condition to the County signal shop per the General Notes (Sheet No. T-3).

### 6. There is no ATMS fiber splice detail in the plan. Please provide.

The ATMS fiber optic splice detail is attached. The Contractor shall run the 12-count drop cable to the existing southwest splice box and splice into the splice box and enclosure. The proposed controller cabinet is approximately 125 feet from the existing splice box and enclosure on the southwest corner. In addition, the Contractor shall provide a minimum of 50 feet of slack inside the splice box in the southwest corner. The quantity for Pay Item 783-1-121: ITS FIBER OPTIC CABLE on Sheet No. T-2 and Sheet No. T-5 will be affected due to the additional fiber optic cable needed. The quantity will increase.

### 7. Is the project using Manatee County or FDOT specification on pull boxes, etc.?

The project is using FDOT specification on pull boxes, with consideration of Manatee County preferences.

Please see Sheet No. T-4, Pay item footnote 5. 635-1-11 for guidance. One revision to 635-1-11 is that the pull box cover for fiber communication and/or interconnect cable should be stamped "MANATEE COUNTY FIBER OPTIC SYSTEM".

In addition, for standard pull boxes (pull boxes not used for fiber optic communication/interconnect cable) use polymer concrete construction pull boxes (standard) to be a minimum of seventeen inches (17")(length) x thirty inches (30")(width) x twelve inches (12")(depth). The pull box cover logos to specify function. The top of the lid shall have the following identification permanently cast into their top surface in stamped raised letters, according to the application for which it is to be used: "TRAFFIC SIGNAL" for signalized intersection application, "ELECTRICAL" for other electrical applications, "LIGHTING" for lighting applications, "TRAFFIC MONITORING" for traffic monitoring applications.

Use polymer concrete pull box with a polymer concrete cover marked "FIBER OPTIC CABLE" for fiber communication and/or interconnect cable. Use 24" x 36" x 36" pull boxes placed a minimum of 800' apart.

### 8. Is a project sign required? If so, where is it covered in the bid form?

No project identification sign will be required for the project.

### 9. Where are the specifications for the UPS foundation?

Sheet No. T-4, Note 15: 685-106 states to attach UPS unit to the outside of the controller cabinet. Install UPS unit in accordance with the Manufacturer's specifications. For additional information, see the Technical Special Provision for 685 Uninterruptible Power Source in the bidders package.

10. Do the construction durations include the acquisition time for equipment?

Yes, the 120 and 180 days indicated on the bid documents include all equipment acquisition time.

11. One of the pedestrian poles in the NW corner appears to be outside the ROW. Please confirm legal access, easement, etc.

The pedestrian poles on the northwest corner lie within the right-of-way. Please see Sheet No. T-11 for a zoomed-in view of the northwest corner. The south pole is located within the sidewalk and the north pole is located east of the right-of-way line.

12. The plans show possible contamination in the SE corner. Does the soil have to be tested? What is the process if the soil is contaminated? How is it paid?

The contractor can either test the soil prior to construction and confirm that it is not contaminated, or he can assume it is contaminated in the noted area and containerize the dirt in drums for subsequent disposal. Testing/disposal documentation results must be provided for activities associated with the mast arm foundation and other subsurface work.

Per General Note 27, all contaminated soils must be removed from the site and transported to a state approved contaminated soil disposal facility.

Payment for all testing and/or removal of contaminated or questionable soil is to be covered in newly added FDOT Item Number 110-1-1, Clearing and Grubbing. See Section 110: Clearing and Grubbing from the FDOT Standard Specifications for Road and Bridge Construction 2010 regarding handling contamination.
