Please confirm whether work for the missing Sections is to be included within the scope of this proposal? If so, please provide a specifications and descriptions for this work.

Answer: Specification Sections 09 20 16 Stucco and 09 67 00 Epoxy Flooring are not part of the work. Please disregard the reference to them in the Specifications Table of Contents.

Question 2: Are any signs needed for this project? If so, please provide a specification. **Answer:** The County will provide the signage.

Question 3: On sheet A101, the Toilet Accessory Schedule lists a mop holder with utility shelf (T-8) but the symbol is not called out on the floor plan. Please confirm that the mop holder is not to be provided.

Answer: Utility Shelf with Mop/Broom Holder (T-8) is not part of the work. Please disregard reference to them in the Toilet Accessory Legend.
