The deadline for clarification of questions has been extended to **July 5, 2012 at 3:00 pm.** This deadline had been established to maintain fair treatment of all potential bidders, while maintaining the expedited nature of the Economic Stimulus that the contracting of this work may achieve. Questions received after this date and time shall not be considered.

Due to a duplication concern, by way of this Addendum #1, all interested Bidders are to submit the following Bid Forms: Bid "A", Subcontractor % Bid "A", Bid "B" and Subcontractor % Bid "B".

The FDOT Construction budgeted amount for FM# 427951-1-58-01, is \$ 263,870.00.

It is important to note that Manatee County Government is currently receiving competitive bids which are up to 50% lower than estimates.

ADDENDUM # 1

Question 1: Is it the requirement that only FDOT Prequalified "Traffic Signal" contractor is allowed to bid this job?

Response: Please change the qualifications of bidders to read as follows:

The bidding Contractor (company supplying the bid) must be an FDOT prequalified contractor. The prime contractor's corporate name must appear in the State FDOT database in this category on the bid due date. In addition, the certification must be maintained throughout the duration of the project.

Question 2: Sheet#15 of 16, can 6" Type B 12.5 be allowed for the base material as optional base group 9?

Response: No. 6" Type B12.5 is not allowed to substitute 10" Optional Base Group 9. The thickness of base shall be 10 inch to match existing condition.

If you have submitted a bid prior to receiving this addendum, you may request in writing that your original, sealed bid be returned to your firm. All sealed bids received will be opened on the date stated.


