Question 2:

In Addendum #1 you answered a question concerning prequalification. Does your answer mean that anyone that is a FDOT prequalified bidder can bid this project or is only a contractor that is FDOT prequalified in Traffic Signals allowed to bid? Please clarify.

Answer 2:

From 6-26-12 Addendum 1 reply of:

No, the requirement of FDOT Prequalified "Traffic Signal" contractor has been removed from the contract document. The qualifications of bidders will now read as follows:

The bidding Contractor (company supplying the bid) must be an FDOT prequalified contractor. The prime (bidding) contractor's corporate name must appear in the State FDOT database in this category on the bid due date. In addition, the certification must be maintained throughout the duration of the project.

Question 3:

Is the bid item for the base work on the job Optional Base Group 9 or is it Optional Base Group 9, 10"? We have attached a table referencing base group options.

This table lists Base Group 9 with differing base materials and their respective depths. Do you know the type of exiting base that is there so we know which type to bid? Would you allow the asphalt base item if you placed it to a depth of 10"?

Answer 3:

Answer is Optional Base Group 9, 10". The type of base is not known, only the thickness of 10" which is to be matched.

If you have submitted a bid prior to receiving this addendum, you may request in writing that your original, sealed bid be returned to your firm. All sealed bids received will be opened on the date stated.
