These items shall have the same force and effect as the original bidding and contract documents, and cost involved shall be included in the bid prices. Bids to be submitted on the specified bid date, shall conform to the additions and revisions listed herein.

The stated deadline of August 9, 2012 to submit all inquiries concerning interpretation, clarification or additional information pertaining to this bid has lapsed. This deadline has been established to maintain fair treatment for all potential bidders, while maintaining the expedited nature of the Economic Stimulus that the contracting of this work may achieve.

Bidders Note:

Question 1: Since road closures will not be allow: temporary travel lanes must be constructed. In the area on plan sheet 20 there are solar powered warning arrow signs and a power pole with multiple guy wires that will be in conflict with both new roadway construction and temporary travel lanes. Have there been arrangements with the respective parties to have these removed/relocated as required?

Response: The contractor shall contact Manatee County Project Manager for coordination of the removal and disposition of the solar powered warning arrow signs. The ownership of the solar powered arrow signs shall remain county's property. The power pole and guy wires will be relocated by Preco. The contractor shall coordinate with Preco for the relocation schedule. Please refer to Sheet # 25.

Question 2: We are in receipt of Addendum Two that has addressed our issues with the Railroad Protective Insurance policy however; we do not have enough Railroad Owner information to complete our application to our insurance carrier, Travelers Indemnity Company, for them to quote us a price for the policy. Please provide us with FPL-Railroad mailing address and telephone number, this information does not appear in Exhibit 'G' of the specifications.

Also, with regard to the Railroad Protective policy, what limits of liability are we to furnish? In order for us to get a cost for this policy we will need this information.

The addendum and note on the revised drawings does not specify what the disposition of the removed materials is to be. Please clarify.

Response: The contractor shall dispose the removed materials.
