Quoters are hereby notified that this Addendum shall be acknowledged on page 16 of the Quote Form and made a part of the above named quoting and contract documents. Quotes submitted without acknowledgement of the Addendum will be considered incomplete.

The following items are issued to add to, modify, and clarify the quote and contract documents. These items shall have the same force and effect as the original quoting and contract documents, and cost involved shall be included in the quote price. Quotes to be submitted on the specified bid date, shall conform to the additions and revisions listed herein.

CLARIFICATION:

1. Biomass to be removed to stockpile area consists primarily of cattail (*Typha* spp.) and sesbania (*Sesbania* spp.) Low growing vegetation such as pennywort (*Hydrocotyle* sp.), torpedo grass (*Panicum repens*) and others will be treated and left in place.
2. Hand pulling of cattail and sesbania without application of herbicide is acceptable. Herbicide treatment is still required for all nuisance and exotic species that are not hand pulled.
3. Removal of native desirable vegetation such as cordgrass (*Spartina* spp.) and broomsedges (*Andropogon* spp.) from banks of ponds will not be required. This **does not** change the number of plants required for planting. Plantings will be done more densely and in other suitable areas as determined by County staff.
4. Minor species substitutions for equivalent plants are acceptable if specific species are not available at wholesale pricing at time of planting.
