The stated deadline of September 21, 2012 at 5:00 pm to submit all inquiries concerning interpretation, clarification or additional information pertaining to this bid has lapsed. This deadline has been established to maintain fair treatment for all potential bidders, while maintaining the expedited nature of the Economic Stimulus that the contracting of this work may achieve. Questions received after this date and time shall not be considered.

Questions:

Question 1: What is the peak flow and what is the TDH?

Response: Including the Inflow and Infiltration we see during inclement weather, contractor should anticipate a peak flow of 4,425 GPM at a TDH of 75'.
